### FIRST REUNION HELD IN PHOENIX

The first reunion and organizational meeting of the Vietnam Helicopter Pilots Association (VHPA) was held in Phoenix, Arizona on June 15 - 17, 1984. One hundred and two people attended! Sixty-seven of these were members with the remaining thirty-five being wives or girlfriends.

Pre-registration was held on Friday evening poolside, however, there were already groups that had reacquainted themselves or had met that afternoon by the pool. For those that had pre-registered, packets had been made up with agendas, directories, T-shirts and name tags. There was a lot of activity at the registration desk for those that decided to come at the last minute but all were accommodated.

Friday evening was spent looking through the directory to find a particular name or names. There was a great mixture of feelings, for some to find an old friend that was on the MIA/KIA list or to find that an old friend was selling insurance, an engineer or a pilot. For some, it was the face that looked familiar across the table. After lengthy discussions, finally place that person as someone you served with in the same unit for a few days as one was returning home and the other was just starting his tour of duty. And the stories started!

Saturday morning business got under way. There was a coffee hour and registration for late arrivals. At 9:00 a.m., the business meeting was called to order by Larry Clark, the VHPA organizer. The first order of business was introductions of the attending members by name, unit in Vietnam and their present occupation. The remainder of the morning was spent in setting guidelines for membership and the adoption of the VHPA constitution.

Members, wives and families ate a buffet lunch. During lunch the members started breaking into areas of special interests in anticipation of the organizing of committees in the afternoon session.

The order of business for the afternoon was the formation of committees for the first reunion, the nomination and election of officers and the selection of committee members and chairmen for the standing committees for the next business year. The final order of business was the acceptance of the Executive Council and the Standing Committees by majority vote of the attending members. Media coverage during the first reunion was extensive and very favorable. The local paper, The Phoenix Gazette, did their interviews during the lunch break on Saturday. The article that appeared in the paper on Sunday generated interest in surrounding areas and quite a few new applications after the reunion. Late Saturday afternoon was dedicated to television interviews. Two of the local television stations gave excellent coverage of our reunion. One gave coverage on the evening news of the reunion, our goals and functions. The other is compiling the extensive interviews of some of the attending members into a documentary to be aired sometime in November.

Saturday evening at 6:00 p.m. was the start of the cocktail hour. At 7:30 p.m. the festivities began. The introductions of the newly elected officers were made before dinner. At this time, Larry Clark was presented with the first life membership and Terrie Clark was bestowed the first honorary membership, for their efforts in getting the VHPA organized. Kathy Uster, representing the women of VHPA, presented Larry and Terrie with special gifts, a corsage for Terrie and a boutonniere for Larry.

After dinner, Jim Thompson, a test pilot for the AH-64 Apache program with Hughes Helicopters in Mesa, Arizona, presented a slide program and talk on the Apache helicopter. Jim, who now has over 1000 hours in the Apache, did a fine job and it was greatly appreciated.

Around midnight, we started breaking into smaller groups. There were those that had to travel home, a group that sat around and talked in the dining room until approximately 2:00 a.m. However, the most talked about group on Sunday morning were those that set a new record at the hotel for the most people in the hot tub at one time...thirty-two!

Sunday was spent with a leisurely breakfast around the pool and the exchanging of addresses and reluctant farewells. There was a sadness that the weekend had passed too quickly, but that feeling was soon replaced by the plans and the anticipation of the next reunion in Houston.

## **CREWMEMBERS**

The orginal Constitution was worded: "It is an organization for all helicopter pilots, aviation crew members and others who have been engaged in or actively supported in any capacity, the helicopters flown in Southeast Asia during the Vietnam Era." This would have included not only crew chiefs and door gunners but also flight instructors back at Wolters and Rucker plus ground personnel in aviation units. Many present at the meeting felt that this was too broad. Others voiced their view that the VHPA should be limited to only pilots at first and perhaps later include other air crewmembers as Associate Members without voting privileges. Plans are being made to present an amendment at the next years' business meeting. If you feel strongly about this issue, either way, write to the VHPA and let us hear from you.

#### CONSTITUTION

#### ARTICLE I

#### NAME

This Association shall be known as the "Vietnam Helicopter Pilots Association", hereafter referred to as the "VHPA". It is an organization for all helicopter pilots, who flew in Southeast Asia during the Vietnam Era. (1961 - 1975)

#### ARTICLE II

#### **OBJECTIVES**

The objectives of the VHPA are to advance the knowledge of helicopters and to enhance future endeavors whether they be military or civilian. These objectives will be accomplished through annual meetings, active coordination with mutual associations and consideration by the membership of essential matters pertaining to helicopter activity during war and peace. The VHPA is dedicated to the fulfillment of the following purposes:

- Improve helicopter flight techniques by providing a forum for discussion of common ideas and problems whether military or civilian related.
- Assist all Federal agencies and civilian organizations with recommendations and professional advice on the use of helicopters.
- Represent the VHPA to national professional organizations, Federal Government offices and to the public as an organization dedicated to the improvement of vertical flight.
- Provide an opportunity for continuing education of its members.
- Improve the effectiveness, cohesiveness, espirit de corps and traditions of valor of the Aircrews who flew during the Vietnam Era.

#### VIETNAM HELICOPTER PILOTS ASSOCIATION

#### ARTICLE III

#### MEMBERS

Section I. Membership is open to all helicopter pilots who flew in Southeast Asia during the Vietnam Era. (1961-1975)

Section II. Members shall be classified as Life, General, Corporate and Honary. To be recognized as an active member in any of these classifications, the member must be in good standing and current in his dues.

Section III. Membership classifications are as follows:

- a. Life membership may be conferred upon an individual who pays
- General membership is a non life-time annual dues paying
- Corporate membership is open to any company which supports the objectives of the VHPA.
- d. Honorary membership is open to distinguished persons, such as the Commanding General. Ft. Rucker, aviation pioneers, guest speakers and aviation dignitaries. Honorary memberships must be voted upon by the Executive Council.

Section IV. All active members with the exception of Corporate and Honorary members are entitled to vote and to hold office within the VHPA.

#### ARTICLED IV

#### ORGANIZATION OF THE ASSOCIATION

Section I. The officers of the VHPA shall be as follows:

- President
- Vice President (who shall be President-elect and shall succeed the President)
- Three Members at Large.
- The immediate past President of the VHPA.

#### VIETNAM HELICOPTER PILOTS ASSOCIATION

#### Section II. The Executive Council shall consist of:

- a. The President of the VHPA who shall act as chairman.
- b. Vice President.
- c. The immediate past President.
- d. Three Members at Large.
- Executive Director, who will be appointed by the Executive Council.

#### Section III. Responsibility and Authority of the Executive Council:

- a. The Executive Council shall be the governing body of the VHPA. It shall be responsible for the management of the affairs of the VHPA, including funds, programs and regulations. It shall have authority to approve budgets, authorize expenditures, seek and accept contributions and approve annual meeting sites and program arrangements.
- b. The Executive Council may delegate authority and functions to the Executive Director or specific members of the VHPA.
- c. The President, Vice President and Executive Director will have the authority to appoint assistants to facilitate the functions of their offices.
- d. The Executive Council shall perform such other duties as are prescribed by the Constitution and Bylaws.
- e. The Executive Director shall have a vote only as a tiebreaker.

## Section IV. Committees. The following committees shall be selected annually by the President and ratified by the Executive Council:

- a. Nominating Committee is responsible for presenting its selections for Vice President and the Member at Large at least 30 days prior to the annual meeting of the VHPA.
- b. Arrangements Committee is responsible for planning the annual meeting of the VHPA. Their proposal shall be presented to the Executive Council at least six months prior to the annual meeting. This Committee may create subcommittees as required.
- c. Other committees may be appointed by the Executive Council as required.

#### VIETNAM HELICOPTER PILOTS ASSOCIATION

#### ARTICLE V

Attending eligible members shall constitute a quorum for the transaction of business at annual meetings of the VHPA.

#### ARTICLE VI

The VHPA will operate on a calendar year basis.

#### ARTICLE VII

The Constitution and Bylaws may be amended by the following procedures:

- a. Approval of the proposed amendment by the Executive Council;
- b. Adoption of the amendment at an annual meeting of the VHPA by a two-thirds majority of the members present and voting at the business session.

#### ARTICLE VIII

Should the need arise or a desire exist, local chapters may be initiated upon approval of the Executive Council. Chapters may have such officers, organizations and meetings as they may determine, not in conflict with the Consitution and Bylaws of the VHPA. Each chapter will be required to provide the Executive Council with the names of its officers and activities on an annual basis.

#### ARTICLE IX

Section I. There shall be an annual meeting of the VHPA. It shall be conducted at a place and time as determined by the Executive Council.

Section II. Holding office or other positions of influence and trust shall be limited to eligible members as defined in this Constitution.

Section III. Executive Council and committee recommendations, nominations or decisions can be made by telephonic polling but must be a majority concensus.

#### VIETNAM HELICOPTER PILOTS ASSOCIATION

#### BYLAWS

#### CHAPTER 1

#### MEMBERS

- Life, General and Corporate memberships shall be approved by the Executive Council.
- Honorary membership shall be conferred by the Executive Council for life.

#### CHAPTER 2

#### EXPULSION FROM MEMBERSHIP

- Members of any classification may be expelled for cause or conduct which the Executive Council deems contrary to the best interest of the VHPA.
- General and Corporate members shall be suspended for nonpayment of annual dues and shall be dropped from the active membership roster.

#### CHAPTER 3

#### ELECTION OF OFFICERS

- The Vice President and Members at Large shall be elected by a majority vote of those members present and voting at the annual business meeting.
- The Vice President of the VHPA shall be the President-elect and shall succeed to the presidency at the close of the next annual meeting of the VHPA.
- Members at Large are elected for a three-year term. One Member to be elected each year.

#### CHAPTER 4

### ANNUAL AND SPECIAL MEETINGS

 There shall be an annual meeting of the VHPA as determined by the Executive Council. The Council shall announce the date and place selected not later than six months prior to the annual meeting.

#### VIETNAM HELICOPTER PILOTS ASSOCIATION

- 2. Special meetings of the VHPA may be called by the Executive Council after 30 days advance notice to the membership. The notice shall state the reason for calling the special meeting.
- In the event of a national emergency, the Executive Council shall have the authority to cancel or postpone annual meetings.

#### CHAPTER 5

#### DUTIES OF OFFICERS

- The President shall preside at meetings of the VHPA and the Executive Council.
- 2. In the absence of the President or his inability to act, his duties will succeed, in order, to the Vice President, or to another member of the Executive Council selected by it. Such successors will act for the President and sign appropriate official documents.
- 3. Following their installation at the close of annual meeting, the elected officers of the VHPA shall serve for the term of office in which they are elected. The duties of the officers shall be those which are customarily ordained for such office and such other functions as may be prescribed by the President and these Bylaws.

#### CHAPTER 7

#### DUES

- 1. Individual Life membership is \$300.
- Annual General membership dues are \$20 per year. Membership renewals are based on the calendar year and are due not later than 1 January.
- Corporate membership is \$300 per year. Corporate renewals are based on the calendar year and are due not later than 1 January.

What a vote of confidence in the future of the VHPA when the first 3 members to join all chose to become Life Members! Rick Freeman, Ron Wright and Roger Searcy joined, in that order, within the first 24 hours after the VHPA was officially formed. Ron and Rick had a quick draw contest with their checkbooks to see who could get the honor of the lowest member number. Life Membership #1 had earlier been bestowed upon Larry Clark for his contribution in time and money to get the VHPA up and going. In similiar fashion Terrie Clark was recognized for her dedication by being named our first Honorary Member.
