## From the President

We've made a lot of progress on several Executive Council (EC) projects since the last newsletter.

Two of the more important are the implementation and funding of the VHPA/AAAA Scholarship Fund and a new direction for managing the annual national reunion.

The VHPA/AAAA Scholarship Fund stands at \$20,000 and our first merit-based scholarship award of at least \$1,000 will be made this year. Deadline for applications is May 1, so by the time you read this it may be too late for this year.

However, we have tried other methods to notify the membership and hopefully were successful with a large percentage.

You can make a contribution to the Scholarship Fund using the Membership Form, Reunion Registration Form, or by sending it directly to VHPA Headquarters with a notation that it's for the scholarship fund. All contributions are tax deductible.

### Changes made in reunion management

Since the tremendous growth in attendance at our annual reunion began with a 30 percent leap at Fort Worth '98 and has continued at approximately that rate annually, it had become clear by DC 2001 that we could no longer continue to plan and execute reunions the way we were doing.

One example of changes that you already have experienced is the way we are doing hotel registrations. There have been some minor snafus, as one would expect from any large-scale, coordinated process, but the direct feedback from members has been very positive and HQ has taken immediate action to correct any problems that have arisen.

This year, we also have moved some recurring tasks, such as the official reunion T-shirts and provision of the official reunion photographer, to the National Vendor Coordination Committee, thereby reducing some of the

workload of the local committee.

A key problem, however, has been that the local reunion committee is typically dumped-on with a tremendous task for which they have no professional training or experience.

(Reunion 2001 is an exception due to Mike Law's "been there, done that," as is Reunion 2002 because of the excellent job the committee is doing along with close coordination with "been there, done that" Vice President Dave Rittman).

So, we're okay near-term, which gave us time to implement a new direction for the planning and execution of the annual reunion that will be partially in effect for Reunion 2002 and fully in effect for Reunion 2003 (planning for a reunion begins two years in advance of the reunion).

### Reunion planning, execution changed

Primarily what we have done is to put the responsibility for planning and execution of the National VHPA Annual Reunion at the national level, conducted by professional meeting planners.

We will continue to have a local reunion committee, but the scope of its responsibilities, frustrations, and "headaches" will be greatly reduced.

To implement this "new management direction," we have appointed Joe Bilitzke as chairman of the National Reunion Committee.

Joe, our current senior member at large and well-known to the organization, is also directly involved with the professional meeting planning process as a "civilian."

To directly assist him with the details of planning and executing the reunion, he will have the contracted services of a professional events coordinator.

Joe has an article later in the newsletter providing greater details of this new management direction. Joe will report directly to the president and indirectly to the EC.

We look forward to Joe's success and to making R2003 a demonstration of how the new reunion planning and execution process can run smoothly.

On the membership front, Bob Wiggins resigned as chairman of the Membership Committee due to health problems. We regret losing Bob, but wish him well in regaining his health.

Dana Young was appointed as the new chairman.

# Green inducted into aviation hall of fame

Lt. Green, then a CWO, distinguished himself during more than 1,600 combat missions flown as a Cobra and OH-6 pilot in the Republic of Vietnam.

His complete fearlessness and extreme flying skills made him a living legend in the 101st Airborne Division (Air Assault). His exploits caused him to be regarded as the "heart and soul of his unit."

His squadron commander, Lt. Gen. Teddy Allen, called him "the bold-est of the bold."

Lt. Green's aggressiveness, extraordinary sense of the battlefield and rare understanding of the enemy gave him an unmatched ability to locate enemy forces and determine their capabilities.

Gary repeatedly returned from missions with a prisoner or the backpacks of enemy soldiers that he encountered and killed.

During a mission near the DMZ, flying low, he detected enemy packs laying on the ground. Landing his OH-6 to investigate, he came face to face with two enemy soldiers. His gunner/observer leaped out of the helicopter and killed



one enemy soldier, who was preparing to use his weapon, and captured the second.

Lt. Green then took off with the bewildered prisoner and a nonfunctioning tail rotor to give the NVA soldier his first and wildest helicopter ride.

On another occasion, he located an enemy 122mm artillery battery.

After dispersing the enemy artillerymen with the fire from his helicopter, he maneuvered his aircraft so that his gunner could disable the artillery pieces by inserting thermite grenades down their tubes.

Five times he landed his aircraft in the face of an attacking enemy to rescue downed aircrews. On two of these occasions, the wounded pilots were brought out straddling the rocket pods of his Cobra and firing their side arms.

Once the attacking enemy forces reached within 15 feet of Gary's departing Cobra.

In another instance, Gary's LOH was shot down and he was seriously wounded, yet he was able to remove his wounded and unconscious gunner from the aircraft and drag him down a jungle trail, while engaging in a running firefight with an estimated platoon-sized group of NVA soldiers.

While making his escape, Gary killed eight of the pursuing enemy with grenades and his AR-15.

Exhausted and grievously wounded a second time by a "punji stick" that passed through his foot, he boosted his still unconscious gunner into the rescue helicopter and continued to throw hand grenades and fire his AR-15 to cover their departure.

The .50-caliber wound he received when he was shot

down eventually resulted in the loss of his right leg below the knee.

Gary Green was shot down five times while flying the AH-1G Cobra and twice flying the OH-6A "Loach."

For these and other conspicuous acts of gallantry, Lt. Green received a total of 81 awards for valor, including the Distinguished Service Cross, the Silver Star with two oak leaf clusters, the Distinguished Flying Cross with three oak leaf clusters, the Bronze Star with "V," the Purple Heart with three oak leaf clusters, 60 awards of the Air Medal and the Vietnamese Cross of Gallantry with Gold Palm.

Lt. Gary Green was recommended for induction into the Army Aviation Hall of Fame by the Army Aviation Heritage Association. He was a life member of the AAHF.

Regrettably, on April 30, 2000, the autogyro that Gary was flying exploded in flight, killing him instantly.

## February 1968 medevac crew still has not returned

On the evening of Feb. 12, 1968, aircraft commander Lt. Jerry Lee Roe, call sign "Dustoff 90," and his crew: CW2 Alan Gunn, pilot; Spec. 5 Wade L. Groth, crew chief; and their medic, Spec. 5 Harry W. Brown, departed Ban Me Thuot in their UH-1H for an urgent medivac at the Gia Nghai Special Forces Camp.

The crewmembers and helicopter were from the 50th Medical Detachment (Helicopter Ambulance), normally stationed at Tuy Hoa, and were on standby at Ban Me Thuot in support of Special Forces operations in the area.

At about 8:19 p.m., 20 minutes out of Ban Me Thuot, Dustoff 90's blip disappeared from the U.S.A.F. TAC control radar screen.

There was no "May Day" call or indication there were any problems. That last position would have put them close to the top of a mountain we commonly called "VC Mountain".

The mountain had plenty of Triple A and small arms fire from the enemy, so it was normally avoided like the plague.

Yet the coordinates given for the last contact was about 100 meters from the top of the mountain.

Helicopter crews from the 155th Assault Helicopter Company were dispatched for search and rescue operations.

An Air Force A1E Sandy joined the search and reported seeing "fire and lights" on the mountain.

The following morning, a helicopter crew from the 50th Medical Detachment piloted by the unit's commanding

officer, Maj. Ronald C. Jones and the unit's XO, Capt. Ronnie Porta, arrived and joined the search and rescue effort.

A Special Forces soldier using a "sniffer" device which detects the presence of ammonia in human urine also joined the crew. Flying low and slow over a mountain you normally could not fly close to made the search seem almost surrealistic.

We could have reached out and picked the leaves off the trees. It was unbelievable.

SOP for search and rescue operations: After three days of searching, if the crew or helicopter had not been sighted, the operation was suspended and the crew listed as missing in action.



Per SOP, the search and rescue operation was officially suspended but many pilots from the 50th Medical Detachment would continue to search during missions in the area.

Now things begin to get strange.

It's 1970, and Ronnie Porta is back in Vietnam as a major and in command of his own dustoff unit. He receives a call at Cu Chi from a friend at Ban Me Thuot who was there when Dustoff 90 went down.

His friend tells him the aircraft was found intact, minus rotor blades, of course. His friend believed the crash was survivable. They found an ambu bag, a pair of gold-rimmed glasses, spent M-79, M-16, and .30-caliber carbine ammo casings, and part of a flak jacket.

Memorial Day, 1986: I had a report pulled from the POW/MIA database maintained by the National League of POW/MIA Families. Lt. Roe and Spec. 5 Brown were identified as POWs.

In April of 1969, the CIA was asked to analyze a positive identification by a "Rallier" who had selected their pictures from a book of personnel listed as missing in action.

The CIA had determined it was only a "coincidence" a "Rallier" could positively ID two people from the same helicopter crew; one black, one white, one located in the front of the book under Brown, and the other listed near the back of the book under Roe? (Just a coincidence?)

According to the "Rallier" the location of the POW compound where they were being held at the time was about two miles from Camp Eagle, "home" to the 101st Airborne.

I decided to look up Wade Groth, also. In 1979, about six years after all POW/MIA's not returned in "Operation Homecoming" had been declared dead by Hanoi and Washington, Groth had been seen alive and in good condition in a place called Bong Song about 40 miles south of Hanoi, working on a railroad section.

An IRA gunrunner by the name of Sean O'Toolis spoke to Groth, Brendon Foley, and another POW named MacDonald. O'Toolis was able to obtain a fingerprint of Foley and a note for his brother.

He gave the CIA sketch artist a description so accurate it was easy to tell it was Groth — red hair, freckles and all.

O'Toolis' word supposedly couldn't be "trusted". He was a gunrunner and worked for the IRA, and, therefore, was disreputable in our government's eyes. Since he freely took this evidence to the CIA, I would think he had some connections there.

October 26, 1992: A search team finds what it believes is the burn spot left by a crashed and burned UH-1H. Members of the team also find the same things I mentioned before: Ambu Bag, gold-rimmed glasses, part of a flak jacket, spent M-79 casings, and all the rest, but they are here to bury this crew, not to find them (my personal view).

So, due to the size and depth of the burn spot, the team reported the aircraft crashed into the mountain with such force it exploded and the entire crew was killed.

Excuse me, but the search team grossly oversimplified its "findings" on this point, 22 years after the aircraft had been found comparatively intact in 1970. No human



## Air museum small, but very impressive

I had a project to check on at Vancouver Barracks last week. After we finished our site visit, we stopped off at the Pearson Air Museum, adjacent to Vancouver Barracks along the Columbia River.

This is a small, but first class aviation museum, with a focus on the "golden years" of aviation.

Several years ago, they were given a Cobra, tail No. 22791. Since they are now on the Historical Registry, and are focusing on the golden years, they need to get rid of the Cobra.

The Cobra is not flyable, there is no engine and, of course, no weapons, but the airframe is complete.

Spread the word please, it could be made available to a museum with a more recent theme or an organization such as the VHPA, if we had a place to serve as a storage/museum facility.

remains were found!

What really happened to Jerry Roe and the crew of Dustoff 90? Are they prisoners of war or are they dead?

I am looking for anyone from the 155th Assault Helicopter Company who may have witnessed the finding of Dustoff 90's helicopter in 1970, or the person who called Maj. Porta with the information.

The standard procedure when I was in Vietnam (1967-68) was, if the aircraft couldn't be recovered, it was to be destroyed in place. In other words, the helicopter would have been blown up or burned by our side.

So, if an otherwise intact "bird" had been blown in place by our forces, the search team, not knowing this, would naturally come to the wrong conclusions, based only on what they saw at the crash site.

You would think also that nearly everyone "in the business" would know the difference between spent rounds that have been fired and those that have simply exploded in a fire.

The implication, of course, is plain: If the cartridge casings were from fired rounds, then Dustoff 90's crew was alive enough to engage in a firefight after they were on the ground.

They were never confirmed KIA (killed in action). Three of them were reported as having been seen alive. Therefore, they are still missing in action! We have one mission still out: Dustoff 90.

So, to all those who helped me and shared with me the reunions last year, to Don and Angelia Agren who not only shared their home but also their hotel room, I say a very big "thank you."

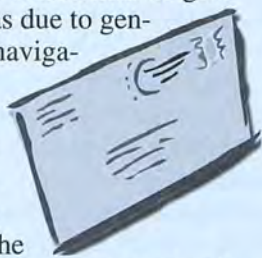
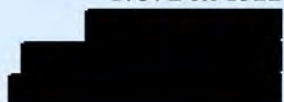
To all of those contemplating their first reunion . . . just go. To all of you in Denver, when you raise a glass to absent friends, think of me because I'll be thinking of you.

## Newsletter article answers pilot's 30-year question

At the end of 1999, I read a short note in *The VHPA Newsletter*. A former Army pilot was looking for AH-1 pilots who wore red helmets in Vietnam.

This article led me to the answer of a nagging question I had carried for over 30 years.

War is really about saving life rather than about dying. I had saved a life and that was what it was all about.

I never knew whether Gary had made it or not. In fact, I never knew him at all until some time in January of 2000 when he visited me with a case of Scotch in his car to thank me for being there.

He and his wife Rusty and my wife Kate and I sat and finished off the first bottle and recounted the story of so

long ago.

The year 1968 — sometime shortly after the famous Tet offensive. I think it was still going on to some extent because there was a real firefight happening in the Plain of Reeds in IV Corps.

Our AH-1 from Can Tho was assigned to assist a Cav unit from Vin Long that was in support of a ground action. Heavy contact was encountered and a day-long battle resulted.

In the course of this battle, several helicopters were hit and some shot down.

Gary was attempting to rescue one of his comrades when his OH-6 was hit. Gary sustained what for most of us would have been mortal wounds.

His observer was able to lift the OH-6 out of harm's way, but soon found that flying a crippled OH-6 is something even an experienced pilot could not do well. That observer deserves a lot of the credit for this rescue.

Our AH-1 was escorting another crippled helo back to the staging area when we spotted a wisp of smoke in the distance.

Knowing our charge was out of danger, we investigated. Approaching the area, we discovered a smoking OH-6 and one dazed observer on the ground.

There was only one choice and that was to land in the water-soaked paddy and do what we could.

I was flying that day with Lt. Joe Bryant (24W-074). We frictioned down the controls and went to the smoking OH-6.

Gary was still pinned inside by the twisted controls. Joe and I pried him loose and I carried Gary to our AH-1, while Joe attended to the observer.

We strapped them on the ammo bay doors with our web belts and made a hasty exit to the staging area, which had a Special Forces hospital.

## Promoting attendance draws pilots from units

I read an article in the July/ August 2000 VHPA Newsletter in which a member said he had attended several VHPA reunions in hopes of seeing some of the 50-plus pilots he served with. He said his disappointment is in finding only two or three at each reunion.

I know the feeling. I attended my first VHPA reunion in Atlanta in 1992. Eleven 361st ACE/Aerial Weapons Company pilots were there — five of whom I had served with.

I didn't go again until Santa Clara in 1997. Only nine Pink Panthers were there. I knew three.



I decided to get active. I recruited other unit members. We made phone calls, e-mailed, located buddies through Social Security numbers, wrote letters, threatened, lied, cajoled, whatever it took to involve our unit members. Orlando had 18, Fort Worth had 23, Nashville had 32 and last year DC had 38.

The 361st ACE/Aerial Weapons Company was a Cobra Unit. About 195 pilots flew in the company from April 1968 to August 1972. Five died in combat, 19 have passed away since returning home, and 17 are still missing (haven't been located). That means we have about 155 guys on our unit roster.

As of today (March 31), 83 have registered for Denver or have indicated they intend to be there. Our goal of 50 is out the window and is now 90.

### Two quick stories:

I called David "Smitty" Smith. I ask if he's coming. He said "No," he has a wife's family reunion in Arkansas.

I suggest he take the family to Arkansas, then go to Little Rock, catch a flight to Denver, stay a couple of days and then return to the family reunion in Arkansas.

He likes the idea and plans to talk to his wife and check on flights that night.

I get an e-mail at 6:30 p.m. His wife, the understanding

## William Thomas 'Bill' Graves

William Thomas "Bill" Graves, 59, of Tucson died Sept. 1, 2000, after an eight-month fight with cancer.

It was his second war.

A retired U.S. Navy commander, Graves served four tours in the South China Sea as a helicopter pilot flying search-and-rescue missions over North Vietnam. In 1968, Graves was awarded the Air Medal with two stars for 60 successful SAR missions to pick up downed fighter pilots. At the time, he was attached to HS-2, "Big Mothers," aboard the U.S.S. Hornet. His squadron's motto: "You fall, we haul."

Graves was a member of the Gulf of Tonkin Yacht Club.

During his overseas tours, he wrote faithfully to his wife, Sue, who was holding down the fort, caring for their children and praying for his safe return.

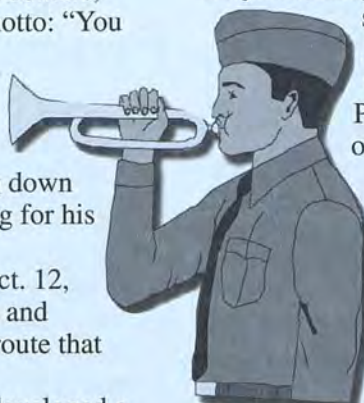
He was born William Thomas Graves, Oct. 12, 1940, in Prattville, AL, to Walter C. Graves and wife Fannie. As a boy, Graves had a paper route that taught him the value of a dollar.

He was proud to be an Eagle Scout and developed a lifelong passion for the outdoors. Graves led his kids to the top of Mount Whitney before they were teens.

He was a 1958 Tucson High School graduate. Although the Navy would send him around the world, Graves considered Tucson his home.

He graduated twice from the University of Arizona, in 1962 with a degree in zoology, and in 1987 with a degree in architecture.

He retired from the Navy in 1982 and returned to Tucson to become an architect. He and wife Sue later moved to Phoenix, then Prescott. By then, they had acquired Holmes, an odd little dog who just showed up one day at their Tucson home on Calle Guaymas. Graves loved that mystery mutt.



In Prescott, Graves grew a ponytail, bought a Harley and made exquisite silver jewelry. He took a summer off to work as a cook aboard a salmon boat in Alaska.

Jim did these things, like so many other Americans of that era, because it was his turn to serve. This he did, always to the best of his ability; always in a manner that earned him the universal respect of the people who had the pleasure of working with him.

The very minor fact that I am here today is due in no small measure to his advice and counsel along the way, and his repeated bravery under enemy fire.

The quality that Jim possessed that stands out in my

mind, even more than his moral and physical courage, is that he genuinely liked people.

No matter how bad you thought things were, there was a bright side that Jim could always find.

His upbeat mood had much to do with the reality that I can look back on that experience as one of the most positive of my life.

Jim was my best friend. I know others who have referred to Jim in this way. I am sure there are others still, who I will never know, who remember Jim as the best friend a man could have.

Someone so profoundly capable, brave, decent and fun to be around. I will miss Jim. I can now only be grateful that fate allowed me to know him during the time of our Vietnam service.

To Candy, and the rest in his immediate family, I can't even begin to imagine the void in your lives as a result of Jim's passing. I hope you will know that Jim will always be in the thoughts and prayers of those with whom he served in Vietnam.

# National reunion takes new direction

The Vietnam Helicopter Pilots Association has experienced tremendous growth over its short history.

We also will experience the inevitable decline.

While still in the growth stage, we have come to rely on a management company for administrative actions and a financial management company for our investments.

The time has come to expand our vision of our one, big, organized annual event, the VHPA reunion. In an earlier time, when we were much smaller, VHPA could rely on the spirit, dedication and tireless work of a group of individuals who lived in the area of a proposed reunion site.

The event has become too big, too complex and too costly to ask our local chapters to shoulder this tremendous responsibility.

The reunion is no longer fun for those tasked with its execution. From the reunion chairman to the president, we are asking individuals to take responsibility for a mission that potentially may be far above their pay grade.

Good intentions, long hours and devotion to duty all are admirable qualities when it comes to putting on a reunion. But the early reunions have now grown into the national VHPA annual reunion and we must grow with that reality.

To that end, your Executive Council has formed a new position within our organization. I have been asked to assume the responsibilities of this new position, chairman, National VHPA Reunion Committee.

This is an unpaid, volunteer position giving the entire membership a single, defined target to express frustrations, questions, and — I hope — glowing reports and kudos for future reunions. Some of my ideas and vision for this new direction follow:

- Location, activity or size of a local chapter should no longer deter-

mine the national VHPA annual reunion sites. The sites should be chosen using the following criteria:

1. The hotel should be affordable, and able to house the entire reunion under one roof.

2. The hotel should be in a location that offers easy access and cost effectiveness by air and maintain the standards of a destination acceptable to the majority of the membership.

3. The hotel should offer room, food, and beverage costs within the parameters acceptable to the VHPA.

- The chairman, VHPA Site Selection Committee (VHPA SSC) will contact all major hotel chains having properties exceeding 1,500 rooms. A Request For Proposal (RFP) is requested with the following:

1. Provide properties located within CONUS that would allow VHPA to contract a minimum room block of 1,200 rooms over the July 4 holiday. The hotel sites will be rotated geographically as best as circumstances allow.

2. VHPA Site Selection Committee would recommend a hotel chain offering properties in three cities that meet the above criteria.

3. With EC approval, the VHPA SSC would negotiate with each national chain having hotels described. A contract would be executed for a long term (e.g., three-year) period with the chosen chain. Subsequently, each year, a reunion would be held in one of the three properties held by the national chain.

4. Guaranteeing a three-year contract would greatly improve our bargaining position. And hotel acquisition would be negotiated at a national level, both by the chains and VHPA also helping to ensure a national VHPA annual reunion.

- The chairman, National VHPA Reunion Committee will establish the position of event coordinator, national VHPA annual reunion. Duties follow:

1. Report to the chairman, National VHPA Reunion Committee.

2. Assume daily duties much like

the VHPA management company.

3. Participate in site selections, hotel negotiations, budgeting, and preliminary duties as directed by the chairman, National VHPA Reunion Committee.

4. During the national VHPA annual reunion, assume responsibility for execution of a successful reunion. This includes coordination with the chairman, National VHPA Reunion Committee, and the hotel staff.

5. Provide sufficient local staff and/or local VHPA volunteers to adequately staff, but not limited to, the following areas of responsibilities:

- a.) Coordination of room block
- b.) Registration
- c.) Banquet
- d.) Transportation
- e.) Vendors
- f.) Mini-reunions
- g.) Ancillary food functions
- h.) Business Meeting
- i.) Ladies' events
- j.) Golf Tournament
- k.) Raffle

- l.) Fulfillment items, e.g., pins, decorations, handouts, gifts, programs, etc.

- The event coordinator, national VHPA annual reunion will be paid a retainer, plus travel expenses required for maintaining the position. Areas not reimbursed include office, administrative staff, reasonable and usual communication, and logistical equipment required of an existing business.

- The event coordinator, national VHPA annual reunion will be an established, event/meeting planner with sufficient experience to assume the role of the position.

- Local chapters and/or individual VHPA members are not being excluded from the reunion process. This will continue to be an event for and by the membership.

The chairman and event coordinator, national VHPA annual reunion may utilize the local chapter and/or local area members, if available, to recommend attractions, events, and sites that might be of interest to the membership.
