### From the President

We are blessed that there is much good news within our country these days.

As of April 1, the economy appears to be rebounding, our military has prevailed in Afghanistan with relatively few casualties, our transportation system (including the airlines) is back to normal, and there is much reason for

optimism that even better times are ahead for most in the months ahead.

Much has been happening within our association, of which a few key subjects are covered in the following paragraphs.

#### Finding our missing comrades

We have shared with you that our highest priority is the need to find the fellow pilots who flew with us in Southeast Asia, but who we have not heard from since.

Gary Roush, Mike Law, Dana Young and many others have been working very hard on this. Details have been printed in the past few newsletters, and I am pleased to report that just in the month of March more than 300 newly found pilots have signed up and joined our association as a result of these efforts.

Many also have indicated a desire to attend their first reunion this July in Las Vegas.

Add the 32 new members we registered in late February, and our overall membership has risen to more than 11,209 as of April 1.

We're not done yet. Lists of all the newly found prospects were provided to each chapter last month and they also are working on contacting prospective members who reside in their geographical areas.

By the time you receive this newsletter, I anticipate a follow-up postcard will have been mailed to this same list of comrades we have not heard from in more than 30 years to further assist in encouraging this group of newly found pilots to join our association.

Said simply, many new members also will join in the months ahead.

#### Las Vegas reunion — what a time it will be!

As this column is being written April 1, we have just 90 days before our reunion in Las Vegas! Time does truly fly! Are you coming? If so, have you registered yet?

As of today, more than 1,100 pilots and their guests have registered, up significantly from this time last year.

This puts us on track to have more than 2,500 people at our host hotel this year. Add to this the many recently found and new members who will be registering in the weeks ahead, and this reunion is shaping up to be a very special time for us all, with fellow pilots attending who we have not seen in years.

Details on the reunion are contained later in this newsletter, but I would like to mention a few key items of interest.

First, based on current actual hotel registration rates, 96 percent of our membership will be checking in at the Riviera by Wednesday, July 3, in time to attend the welcome reception, at which the original show band Sha-na-na will perform.

It's a major event. If you have already registered, but do not have tickets call or e-mail our HQ at (800) 505-VHPA or hq@vhpa.org and Linda will adjust your registration package.

Advance registrations also reflect there will be 500-600 pilots and their guests will coming in early on Tuesday, July 2, thus many of our comrades will be starting the party early. The same discounted VHPA rates apply up to three days before and three days after the primary dates of the reunion.

One minor change you will note in the schedule of activities is we have moved the business meeting and the ladies brunch from Saturday to Thursday morning, July 4.

This was done to facilitate the need for your Executive Council's involvement in overseeing the massive logistical, technical setup, and rehearsals for our final night banquet Saturday, July 6, at which more than 50 performers, dancers and musicians will present a very memorable and highly patriotic 90-minute stage show just after the dinner and before the dance.

The ladies brunch is a very special event this year. We have hired a complete show with numerous actors to put on a murder mystery, complete with costumes, props, audience participation, all intermingled with a three- or

# Contacts group asks: Take another look

The Family Contacts Committee of the Vietnam Helicopter Flight Crew Network was formed in 1997.

Since then we have worked with more than 300 families of KIA/MIAs, helping them find answers to 30-year-old questions, to reach peace with the past and with their loss. Often, it's the small things that do it.

They come to us to learn how someone died, and take away the treasure of knowing how they lived.

More and more, our work is proceeding in the opposite direction: We are fielding requests from helicopter veterans seeking to find family members of the buddies who didn't survive their tour — or who died afterward.

Perhaps it's only to pass along a special memory or a photo. For others, it sparks a long-term connection. While we are sometimes — miraculously — able to provide an immediate connection between a veteran and a buddy's brother, sister, son or daughter . . . at other times, we are only able to take the point-of-contact info. for safekeeping, until a family member should come forward and start asking the questions. We are more than happy to do this.

If there's someone whose memories you have been keeping alive in your heart, and if you'd feel comfortable sharing those memories with his family should they come forth, contact our committee chairman, VHPA member Gary Thewlis.

All you need to provide is your name and your contact info, and the name, unit, and KIA date of the person you knew.

We will keep whatever information you wish to provide and, if his family or friends should inquire of our Family Contacts Committee, we would have a great resource for helping them to learn about his life in Vietnam or flight school: You.

- Do you recall an anecdote about them? Even secondhand?

  - Did you ever go on R&R with them?

These sorts of memories can be pure gold to their families, even after so many years.

Let us know. We will record the link and will know to get in touch with you if we are contacted about the KIA/MIA. We will contact you first and let you decide what is appropriate at that time.

# Mason oldest aviator when he retired in July

CW4 James W. Mason (Class 66-19/21) retired from U.S. Army Aviation service in July 2001.

Mason, at 60, was the oldest aviator still actively flying for the Army. He served two tours in Vietnam between January 1967 and June 1970.

For the last 12 years, Mason was senior instructor pilot in Company A/1-114 Aviation Battalion, AR.ARNG, Addi-

tional responsibilities included gunnery IP, night vision goggle IP and instrument flight examiner. He is a dual rated aviator.

Interviewed for this letter, Mason said: "Wearing these Army wings has been an interesting and very challenging 36year experience. The guys coming out of flight school today are just like the ones I graduated with years ago, but their actively flying. names are different.

"I commented at the retirement ceremony that, except for my wonderful wife and family, no other accomplishment in my lifetime has given more pride and satisfaction than having earned and worn those silver wings."

Two years ago, Mason qualified for and successfully completed the U.S. Navy Underwater Survival Course for flight crewmembers at Pensacola, FL.

After completion, one of the instructors told him that, at 58, he was the oldest individual to have ever earned a certificate.

Mason said later, "Hell, I was mentally prepared to drown, rather than give up. There was absolutely no way those younger Navy, Coast Guard and Air Force pilots were going to see an old Army aviator quit. Almost one-

fourth of the younger pilots didn't finish, though."

More recently, on three occasions he has been part of an Army aviation element tasked to support U.S. Navy SEAL teams during their land warfare phase of training.

"Each time, we flew support for about a

week or 10 days. Those guys are just simply top-notch. Daylight was spent in mission briefings, detailed planning and walk-through rehearsals. All missions were conducted at night, under goggles. Everything is timed almost to the second and there's no margin for error.

"Live ammo is utilized, both by the SEAL teams and by the Army choppers. Lots of close-in fire support, insertions, extractions, the kind of stuff we experienced in Vietnam," he said. "It's as close to the real thing as you'll see without getting some bullet holes in your aircraft. One of our slicks did have a window blown out though, during an insertion. Pyrotechnics in the treeline. Woke that young

pilot up, that's for sure!

"After each mission we'd have extensive debriefings and often crawl into the sack well after midnight. A few days and nights on that kind of schedule and you're running on pure adrenaline. Not unlike Vietnam."

Last March and April, Mason was part of an AR.ARNG element that went to Hohenfels, Germany, supporting an active duty avia-

tion detachment located there.

He observes that the interface between active duty units and the ARNG seems to be pretty outstanding, unlike it was even a few years ago.

"ARNG flight crewmembers have the same training and annual flight hour requirements as our active duty counterparts," Mason said. "Often, the Guard pilots have a greater

wealth of flight time and experience, but on both sides of that fence there are outstanding units and some that are not. Leadership makes the difference.

"Mine happened to be a hard-training outfit that set high standards and expected maximum effort from its people. That attitude was instilled, top to bottom," he said. "Fully half of the Army's combat forces today are from the ARNG side of the house. In combination, it makes a hell of a "can-do-team."

Asked about his memories of Vietnam, Jim said, "I'm not much of one for war stories. My best memories of Vietnam are of the guys I flew with. Talk about some heroes . . . you saw gallantry almost on a daily basis out of both the slicks and the guns. It was simply a common occurrence.

"Night scrambles and gunfights were pretty frequent for our gun platoon, too. Most of my first tour was with the 128th AHC 'Gunslingers.' Every single one of our pilots, crew chiefs and gunners in the 128th was prepared to make any sacrifice necessary if it would buy another American soldier's life.

"Helicopter crewmember losses in Vietnam were horrible. I suspect that almost all of us who made it home alive owe our good fortune to the actions of our other crewmembers. These were guys with huge cojones, willing to die not just for each other, but for that poor grunt on the ground. To one extent or another, I'd bet we all carry a certain amount of "survivor's guilt" even today.

"There will probably never be a day of my life that, in some small way, a fleeting memory of that war doesn't creep through my thoughts, but it's often the face or the smile or a memorable act of valor associated with a fellow crewmember. Talk about heroes . . . you bet, I've got some."

Mason recalled an experience following the war with Iraq.

"It took years before those of us who went to Vietnam were once again accepted by our own society. We weren't ashamed of our service, but we simply didn't talk about it because it was a highly controversial subject with the public. My own personal feelings about that matter have always been that any young man of the Vietnam era who was eligible to go, but refused, has purchased his manhood too cheaply.

"Every helicopter pilot was a two-time volunteer. We volunteered for flight school and we volunteered for Vietnam duty. Both were hazardous to your health. I suppose we were all probably crazy.

"Back to the story though. In 1991, I was enjoying a cold one in the club at Fort Rucker one evening after a day in the air, when a younger Army pilot walked over to my

table. Both of us were still in flight suits. Usually, when two pilots approach each other they'll take note of three uniform items: wings, right shoulder combat patch (or none) and then rank . . . often in that order.

"His was a Desert Storm patch and he asked about my Vietnam shoulder patch. I briefly mumbled something about the old B model gunships, realizing they were well before his time and then he said: 'Welcome home. You don't know how much we appreciate what all of you did for our country.' It took a little while for me to regain my composure."

Mason's awards and decorations include Master Army Aviator Wings, the Legion of Merit, Distinguished Flying Cross, two Bronze Star Medals, the Meritorious Service Medal, 43 Air Medals (three for valor), two Army Commendation Medals, two National Defense Service Medals, GCM, Army Reserve Component Achievement Medal, four overseas bars, Arkansas Commendation Medal, two Arkansas Service Ribbons, individual award of the Vietnam Cross of Gallantry with Bronze Star, Vietnam Campaign Ribbon for six campaigns and the Vietnam Service Medal.

Unit awards include the Valorous Unit Award, Meritorious Unit Award and the Vietnam Cross of Gallantry with Palm.

He and his wife, Marianne, reside at Texarkana, Texas. His son, Derek, and daughter-in-law, Kelly, reside in LaVaca, AR.

Subtitled "Stories to Stir the Pride and Honor the Courage of Our Veterans," the book is composed of nearly 100 short stories by veterans about war.

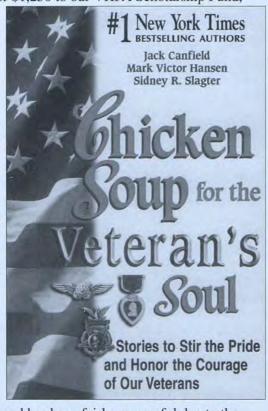

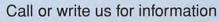

In flight school, we were taught that if the worse case scenario happened and the main blade came off, fly the aircraft to the ground because you never know when divine interference would help you to land safely.

Chuck's hands were still clutching the cyclic and collective as he lay in his coffin. The coroner could not straighten them out. He flew the helicopter all the way to the water, and was trying his best to fix things that were unfixable.

"Squeaky," you will be missed always.

There is no other way to define the original members of the 33rd Transportation Company (Light Helicopter)(CH-21), except as pioneers in U.S. Army Aviation history.

All original members of the 33rd left their families in the United States and quietly departed Fort Ord, CA, with their destination as — "unknown."

The move was classified as Top Secret and no one was able to tell anyone, including families, where they were going under penalty of court-martial.

Vietnam was not classified as a combat zone in 1962, but as an advisory zone . . . but no one told the VC.

The 33rd originally was to deploy to "unknown" locations in March of

1962. The orders were delayed and many of its helicopters were transferred to two other transportation companies — the 8th and 57th — which did deploy.

Then the United States was scoured for low-time CH-21s to replace the ones given up by the 33rd. The unit again was alerted to move in August 1962. All aircraft and all other equipment finally departed for Hawaii by ship, scheduled to stop in Hawaii to pick up the aircraft and equipment of a sister unit, the 81st, before continuing on.

## Brandt diagnosed with pneumonia

Then, the day before the main body of personnel was to depart Travis Air Force Base, Brandt was diagnosed with pneumonia.

After spending a night in the Fort Ord hospital and receiving a massive dose of penicillin that led to a rapid improvement, Brandt told the Army doctor he HAD to go with his unit the next day.

Convinced by his improvement, the doctor loaded Brandt up with more penicillin and off he went. He recovered en route with no ill effects.

The arrival at Tan So Nhut and Saigon was exactly as anyone who has been there remembers: A sensory shock and memorable.

The year was 1962 and Saigon was "unspoiled" by Western influences; full of interesting, foreign sights, sounds and smells.

The USNS Croatan, carrying 40 cocooned helicopters and equipment, arrived within 48 hours, on schedule. After unpacking, unwrapping and assembly, the 33rd's 20 CH-21s were flown to Tan So Nhut and, ultimately, to their new home on Bien Hoa airbase about 30 miles north of Saigon.

The time was the monsoon season and no member of the unit had experienced the tropics or the problems the heat and moisture would ultimately bring to their aging CH-21 helicopters. The 33rd had arrived and "Wow," were the conditions primitive!

Throughout the remaining pages of Thunderbird Lounge, Brandt tells a complete story of the first year of the 33rd in Vietnam. People, places and incidents are described in vivid detail.

Almost every pilot is mentioned, as well as many of the key enlisted men and NCOs.

Using letters sent home to his wife, along with the help of several comrades, he is still in contact with, Brandt reconstructs many events that tell the story of their first year.

Combat assaults, resupply and medical evacuations are carried out in two-aircraft flights because of engine and maintenance concerns. The red soil and extreme moisture conditions made maintenance of the CH-21 radial engines and wooden rotor blades very, very difficult. Brandt estimates his engine shop rebuilt a CH-21 radial engine every eight days!

Thunderbird Lounge is a story of missions, mainte-

nance and mayhem.

Never has a book been written after 40 years that is more complete with dates, names

and locations. Every page is brimming with tales relating the many humorous incidents and events that made life in combat and the poor living conditions of Bien Hoa airbase bearable.

Great photos are placed at the end of each chapter that complement and highlight the people and incidents within the chapter. Brandt carefully remembers some of the sad events of the year, concluding with the loss of the first two 33rd pilots just after his return home.

Thunderbird Lounge is truly a wonderful book. It tells a positive story about men as pioneers overcoming adversity, boredom and the enemy.

Some of the participants may have seen things differently than Brandt, as he looks back after 40 years. However, no one can say he didn't tell it candidly, and fairly, as he saw it. After all, 40 years is a long time.

The year1962 was truly a time when real men pioneered the use of helicopters in combat and developed the textbooks for U.S. Army Aviation airmobile operations. Those textbooks, as well as the lessons learned, were effectively used by thousands of pilots over the next nine years in that "unknown" location so very far away.

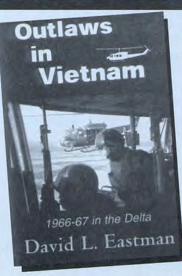

# Motorcycle rides planned at reunion

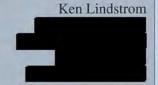
There will be two motorcycle rides in conjunction with the Las Vegas Reunion:

# Staying up to date:

## VHPA forms Technology Steering Committee

CHARLES HOLLEY CHAIRMAN TECHNOLOGY STEERING COMMITTEE

A Technology Steering Committee was established last July to provide continuing review and recommendations regarding the VHPA's technology and office automation needs, and the best ways to implement them.

The purposes of this committee are to:

- Review the organization's technology, automation, hardware, and software needs.
- · Develop plans, requirements and specifications, schedules, budgets.
- Update our association technology at our Headquarters operation to enhance operational efficiency.
- Allocate tasks to ensure the implementation of ECapproved plans and budgets.

Those of you who

Members of the Committee are: Dan Ferguson, Marcia Fritz, have used the online Charles Holley (Chairman), Mike Law, Gary Roush and Dave Rittman.

The first priority of the Committee was to have automation needs

in place to support R2002 in Las Vegas, along with the development and integration of the online reunion registration and hotel reservation process.

Those of you who have used the online registration process are aware it has been reasonably successful for a "first-pass" implementation (for those who read the instructions) and we're now experiencing about an 80 percent-90 percent success rate.

We are aware of a few glitches that we will be working on and correcting for next year.

For example, some members with older versions of web browsers occasionally had difficulties with the new technology, and some of the user-interface aspects need to be improved for less-experienced internet users.

For Reunion 2003, we will be striving for a 98 percent success rate for the online system, along with complete integration with the Headquarters office system. When completed, it will really make a difference for all involved.

Through the efforts of the committee, most of the issues with the vendor provided online software that surfaced in the first few weeks were corrected. Some

enhancements (such as automatically pulling up your current address and database information when you log on to the system) will need to wait until after the reunion so that we can change some of the technological approaches.

A second priority of the committee has been to move the entire VHPA membershiprelated business processes (for example, renewals, address changes, directory information updates) into the e-commerce areas.

A third priority has been to assist the **Executive Council in** better dissemination of information about the VHPA as an organization.

This task has also been progressing well, and as the reunion workload becomes less will receive even more emphasis.

A third priority has been to assist the Executive Council in better dissemination of information about the VHPA as an organization; for example business-related reports, and EC meeting agendas and minutes.

We have established http://www.vhpa.info as one means for accomplishing this objective (see related article: "Your Executive Council Forum").

We also continually strive to update the e-mail database for our membership so that we can immediately alert them to particularly time-critical information, such as the deadline for the AAAA/VHPA Scholarship Fund that occurred last year, wherein we received a short notice notification for applications.

## Spotter sees boxes scattered in area

EDITOR'S NOTE: A Battle in the Renegade Woods was documented by the 25th Infantry Division's 18th Military History Detachment. This action occurred April 2-6, 1970, in Tay Ninh Province. The source documents were obtained and provided to the VHPA by former crew chief Ron Leonard, Diamondhead 085, who also is webmaster for the 25th Aviation Battalion Association.

#### RON LEONARD

An artillery spotter in an LOH made a visual reconnaissance of the area and saw numerous boxes scattered on the ground, leading to the assumption a supply bunker had been destroyed.

In the afternoon sweep, Companies A and B, 2nd Battalion, 27th Infantry, moved northwest to establish a line, and then began sweeping south-

west toward two large clearings. Companies A and B, 2nd Battalion (Mechanized), 22nd Infantry provided security for them and then continued toward PB Blue for the night. During the sweep, B/2-

27 Infantry located several bodies and miscellaneous equipment.

At 12:20 p.m., they located 10 KIA (BC), of which six were credited to their small arms fire, two to the artillery, and two to air strikes.

At 12:30 p.m., two bodies were located which had been killed by D/3-4 Cavalry, and one RPG-2 launcher was evacuated. Fifteen minutes later, one pound of documents, 660 small arms rounds, nine 82 mm mortar rounds, and one RPG round were evacuated to Cu Chi.

Troops of A/B/2-27 Infantry halted at 4 p.m. in the large clearings to eat their evening meal, which was brought in on resupply helicopters. At this time the evening rainstorms set in.

Before he could contact the company commander, his men told him the force was composed of 200-250 heavily equipped NVA.

During this meal, A/B/2-27 Infantry used

binoculars to select sites for platoon-size ambush patrols which would be sent out that night.

At 7:30 p.m., the patrols moved out. Company B selected locations for its platoons along the northwest edge of their clearing.

The 1st Platoon set up an L-shaped ambush at the clearing entrance, the 2nd Platoon chose an area to their northeast, and the 3rd Platoon with the command element remained between them.

By 8 p.m., the 1st and 2nd Platoons had become established but the 3rd still had not found a suitable site.

Just after dark (about 8:10 p.m.), 1/B/2-27 Infantry saw an unidentified element moving toward its positions from the southwest. A platoon leader, Lt. Dennis Heitner, wanted clearance before engaging the estimated 20 men because there were indications they might be allied troops.

Before he could contact the company commander, his men told him the force was composed of 200-250 heavily

Heitner ordered his men to lay down and let the enemy pass. The column, which had no forward or flank security and was observing lax route discipline, passed in so close to the platoon's position they walked over the wires strung out to the platoon's Claymore mines.

The enemy force paused for about 45 seconds near the platoon's position to allow stragglers to close up, and the

open fire on the enemy who were disappearing into a large wooded area to the east.

The other two platoons, concentrated at the 3rd Platoon location, set up a crossfire.

Company A, 2nd Battalion (Mechanized), 22nd Infantry, was recalled to the scene and helicopter gunships, flareships and artillery were brought in.

A/2-27 Infantry never saw the enemy, most of whom had escaped into the woods when contact was initiated.

B/2-27 Infantry gathered at the 3rd Platoon site, where it was joined by A/2-22 Infantry (M).

The mechanized company had taken sniper fire, which wounded two men in its effort to join B/2-27 Infantry, but had seen few enemy.

Resupply was brought in to the consolidated NDP, but no further activity occurred that night.

It was the opinion of the officers of Company B that the element they engaged was returning to its base camp

and was unaware of the presence of any allied units in the

It is possible this unit was part of the force which attacked FSB Jay on March 30.

April 5

Companies A and B, 2nd Battalion (Mechanized), 22nd Infantry, and Companies B and C, 2nd Battalion, 27th Infantry were ordered to continue their ground reconnaissance of the contact area, concentrating on the vicinity of the previous night's encounter.

Company A, 2-27 Infantry, would go to Cu Chi Base Camp for a 24-hour maintenance standdown and be relieved in place at noon by Company C.

At 9:25 a.m., an LST from D/3-4 Cavalry located two enemy KIA which were credited to A/2-22 Infantry (M) from the previous evening's action.

At 3 p.m., Lt. Col. Custer's C&C ship engaged and killed one enemy with three flame baths. There was no return fire.

At 3:45 p.m., a UH-1H from the 25th Aviation Battalion, flying at 500 feet and 50 knots, received small arms fire from an unknown location.

No damage occurred and there was no return fire.

Plans for the final day of the action called for Company A, 2nd Battalion, 27th Infantry, to return to Cu Chi for a 24-hour maintenance standdown.

The remaining companies (C/2-27 Infantry and A/B/2-22 Infantry (M)) were to make a sweep through the area and move west to NDPs.

Results: This action was a successful ground reconnaissance operation carried out by 3rd Brigade elements.

Enemy personnel losses during the five-day operation were 101 KIA (BC); one prisoner-of-war captured, and two Hoi Chanh received by U.S. forces.

Large amounts of enemy equipment also were captured or destroyed.

U.S. forces suffered 11 men killed and 35 wounded, of whom 18 were treated and returned to duty immediately, but one of whom subsequently died of wounds.

The Army Aviation assets used: Company A, 25th Avn Bn: two Night Hawk per day; 17 flamebaths; C&C helicopters; Resupply. Co B. 25th Avn Bn: night LFT per day; two Flareships per day; Resupply. D/3-4 Cav three LST per day; Lift for Rangers. 116th AHC Lift, 187th AHC Lift, 118th AHC one lift (April 2).

Members of D/3-4th Cavalry received 3 Distinguished Flying Crosses and 6 Bronze Star Medals with V.
