EC solicits comments on reunions

As you may or may not know, the VHPA is contracted with the Marriott Corp. to hold our next four reunions at its hotels in Phoenix (2007), San Antonio (2008), Philadelphia (2009) and San Diego (2010).

In the near future, VHPA will start to negotiate a new contract for post 2010 reunions. Your Executive Council is interested in your input as to where you want these reunions to be held.

Additionally, there has been interest shown in changing the dates of our reunions.

Many express the fact that the Fourth of July is a big "family holiday," many of us have children who are grown with children of their own, our grandchildren, and we get

together for a family reunion over the Fourth.

Westy was a great help getting me into Cobras

Reading the letters from other members about wanting to fly Snakes reminded me of my own quest for a AH-1G "Cobra" transition and to fly with the 361st ACE/AWC "Pink Panthers" and how Gen. William C. Westmoreland helped me get what I wanted.

At best, I was an average flight student; good at flying the helicopter, weak on how or why the helicopter was able to fly. The thought of flying a "slick" with a load of troops in the back into and out of an LZ in Vietnam or, for that matter, anywhere, scared the hell out of me.

Don't get me wrong, I wasn't afraid of the mission. I just didn't want to screw up and accidentally kill someone. The only course open to me was to try and get in to Cobra School.

Mentioned 'godfather' to Branch

I started calling "Branch" about two months before my class, 70-48, was to graduate.

I called every day. I begged. I pleaded. I mentioned the name of my godfather, William Westmoreland, and offered to remember the kindness shown to me by the major in Infantry personnel to "Westy."

Finally, a week before the class was to graduate, I received a slot. I would graduate and receive my wings at Fort Rucker on a Thursday and my class at Hunter Army Airfield would start the following Monday. I was ecstatic. I was going to be a gunship pilot.

Thirty days after that, I would graduate from Cobra Hall. Thirty-five days of leave and then off to Vietnam on May 5, 1971.

Arriving in Vietnam, we were bused to the Repot Depot. After getting assigned to temporary barracks, I was told to go to personnel for in processing and assignment.

Now, I knew where I wanted to go and what unit I wanted to fly with. Mike Harsh was one of my best friends

at North Georgia College, a primary military college in Dahlonega, Ga., and was eight months in to his tour flying Snakes with the 361st ACE "Pink Panthers."

His wife, Gail, told me he really enjoyed flying in that unit. Standing in front of the captain in Long Binh, I requested that he assign me to the 361st at Camp Holloway in Pleiku and how much my godfather, Gen. Westmoreland, would appreciate his assisting me.

I had no idea where Pleiku was, but that's where I wanted to go.

Friend based at Tuy Hoa

The next day I was on my way to 17th Group in Tuy Hoa. My good friend and college classmate, Cannon Ramey, was based there, flying "guns" with the 134th Assault Helicopter Company.

He was glad to see me, but was not impressed I was Cobra rated. Charlie model gun drivers were like that. I stayed with him that night and reported to the flight line at 1 p.m. the next day for transportation to Pleiku and the 52nd Combat Aviation Battalion.

There were eight or nine of us there, all rotary-wing aviators. One guy, Penn Papini, was in flight school with me.

About 1:30, a slick landed and taxied to POL. We were told that was our ride to Holloway. We were almost to the aircraft when Mike Harsh jumped out.

"Hello, Hunter, I knew it was you when I saw you heading toward us. Nobody walks as bowl-legged as you do."

"How'd you know I was here?" I asked.

"I didn't," Mike replied, "they just scheduled me to come pick up some FNGs."

He scrounged me a headset and we talked once we were in the air. I had spoken with his wife just before leaving home on my way to Vietnam.

Mang Yang Pass very spooky

The flight took us through the Mang Yang Pass, by far the spookiest place in Vietnam. Even the "Bad Guys" avoided it.

More than 7,000 dead Frenchmen were buried there in neat rows. You could still see all the lines of graves because the grass never grew back on the top of them. They say three dead Legionnaires were buried standing up in each grave, all facing France.

It still gives me the creeps thinking about it. But I digress.

The weather started to turn to crap, so Mike made the decision to RON at An Khe. We landed there and the first person we ran into was Lee DeVault, another friend and classmate. He was assigned to the 75th Rangers. He put Mike and me up for the night.

The next morning we arrived at Holloway. We were dropped off at the Hot Spot, met by an NCO from the battalion, who led us to Headquarters. We were fed and then ushered into the office of Lt. Col. Ronald H Merritt, our battalion CO.

He welcomed us, gave a brief history of the unit, told us how lucky we were to be there and then started telling us which units we were assigned to. There were four Cobra pilots.

John Renzetti and I went to the 361st, Penn went to the 57th and the other guy was assigned to B/7/17.

Slick pilots split up

The three slick drivers were split up, two going to the "Gladiators" and one to "Chickenman."

One of the 57th guys was Steve Egger. I can't remember the other two. The last two guys were second-tour guys with brand-new Chinook ratings. The colonel apologized to both and told them they were being assigned to B/7/17 as scout pilots due to a shortage of qualified aviators. To say the least, those two guys were not happy campers.

The 361st commanding officer took us to the company area for in processing and a pep talk.

He told us he expected more from us than he did from the warrant officers because we were REAL officers and the warrants were just pilots. He would turn out to be a real butthead.

He then handed us over to Mike, who found us a place to sleep. I got Lash's room temporarily. Lash was 5 days late returning from a 30-day extension leave and was believed to be lost somewhere in Bangkok, Thailand. John got Woody's room. Woody was with Cousin Brucie, trying to find Lash. They all returned a couple of days later.

Well, that's the story. To this day, I wonder what all I could have accomplished in the Army if "Westy" had really been my godfather.

Thomas W. Blalock, 64, of Fredericksburg, Va., died Oct. 7 at Mary Washington Hospital after a yearlong battle with leukemia.

Blalock was born in Fredericksburg in 1942, and lived much of his childhood in Richmond and Winston-Salem, N.C. He graduated from North Carolina State University with a BA in history, and was commissioned as an officer in the Army in 1967.

He served as a helicopter pilot in Vietnam, earning the Bronze Star Medal for valor and 14 Air Medals.


After leaving the service, Blalock settled back in the Fredericksburg area, working as a manager for McLean Trucking Co. and as a traffic manager at General Products.

He is survived by his wife of 39 years, Judi; and three sons, Maj. Brian Blalock of New Bern, N.C.; Brandon Blalock of Chesapeake, Va.; and Kyle Blalock of Kennesaw, Ga.

Fred H. Caylor Sr.

Fred H. Caylor Sr., 62, of Sasakwa, Okla., died Feb. 14, 2006, of cancer.

He was an Army aviator who served at Chu Lai, South



Vietnam, in 1970-71.

Caylor retired from the Army in May 1986 with the rank of CW4.

He then worked as a civilian flight instructor at Fort Rucker, Ala., until 1999.

Caylor is survived by his wife, Debra G. Caylor of Sasakwa; and two sons, Fred H. Caylor of Daleville, Ala., and Michael A. Caylor of Atlanta, Ga.

Lawrence E. Corser Jr.

Retired Lt. Col. Lawrence E. Corser Jr., 83, of Columbus, Ga., died Dec. 17 at St. Francis Hospital.

Corser was born Oct. 14, 1923, in Hibbing, Minn.

He was a member of the Vietnam Helicopter Pilots Association, the American Legion and the Disabled American Veterans.

Corser began his military career in the Army Air Corp., then the U.S. Army, serving his country for more than 30 years as an aviator.

He served in World War II and the Vietnam War, receiving the Bronze Star Medal, Air Medal with 21 Oak Leaf Clusters, and the Distinguished Flying Cross.

Texas, James Corser of Duluth, Ga., Mark Corser of Columbus, and Hans Corser of Cullman, Ala.; and eight grandchildren.


Norman "Wes" Ford



Jess Gossage



VHPA offering new Reunion Refund Guarantee

Last year the Executive Council (EC) experienced an unusually high number of cancellations for the Washington, D.C., reunion after the published reunion cutoff date.

More than 15 members cancelled, with a dollar figure exceeding \$9,750. Luckily, the reunion had a positive cash flow.

Although the published Reunion Refund Policy states no refunds, the EC decided to make an exception to the policy and grant refunds.

As the shepherds of VHPA's funds, this indicated to us the potential for a huge problem if a significant number of attendees were to cancel after the cutoff date and expect refunds.

Decision made to enforce policy

The decision was made that in all future reunions the Reunion Refund Policy will be enforced with no exceptions.

However, to protect the association and still show compassion to our members and their guests whose plans for attending the reunion have fallen apart at the last minute, the EC decided to implement a Reunion Refund Fee to protect our members and our association.

This is how it will work: All those attending will have the option to purchase a Reunion Refund Guarantee for a cost equal to 10 percent of the price of all the tickets purchased for events; the banquet, the welcome reception, special entertainment, side trips, etc. If all the tickets pur-

chased came to \$290, the cost would be \$29.

Each person registering will have to check he has read the Reunion Refund Policy and chooses to accept or reject the Reunion Refund Guarantee in order to complete the reunion registration process.

Full refund available, minus fee

If the person cancels before the published cutoff date, he will receive a full refund of all charges, less a \$10 administrative fee to cover the costs of handling the cancellation. VHPA has done this for quite a few years.

If the person cancels after the cutoff date and has purchased the Reunion Refund Guarantee, he will receive a full refund on all ticketed events he purchased.

He will forfeit the non-ticketed registration fees and the Reunion Refund Guarantee he paid and he will not be charged an additional \$10 cancellation fee.

If the person cancels after the published cutoff date and elected not to purchase the Reunion Refund Guarantee, he will forfeit all monies paid with the exception of any ticket that is limited in number, has sold out and has a waiting list of people wanting to purchase those tickets. Those tickets will be sold and a full refund will be given to the person on those tickets only.

The EC trusts our members understand the need for this action.

Worthington was born on Valentine's Day 1938 in San Antonio, Texas. He was a graduate of the University of Tampa and received a Master's from the Florida Institute of Technology in Melbourne.

after photo of the resort. Imagine yourself in this kind of ambiance for \$115 a night. What a deal!

8 a.m., returning about noon

- Trip to Tucson and the Pima Aviation Museum and "Bone Yard," where thousands of vintage and Vietnam-era aircraft, including helicopters, are stored. There is a list of all the serial numbers of aircraft there and it's possible you may be able to find your old helicopter. Included are a lunch and other special activities at the historical site. Tentative departure time: 6:30 a.m., return mid-afternoon.

Sunday, July 8

This is a special reunion post trip requested by many members on last year's survey. Due to the distance to the Grand Canyon, it is not feasible to do a day trip and still get members and their guests back to the hotel in time for evening activates.

Writer recalls sound of Huey's blades in Vietnam

Music of helicopter blades still holds a chill

I never met Jack Barker, but I'm familiar with his music.

Barker, a Waycross native, his copilot and two-man crew were killed in March 1971, when his helicopter was shot down over Laos as he tried to rescue South Vietnamese Rangers pinned down by North Vietnamese soldiers.

Barker, a company commander, organized what most called a suicide mission. His was the only helicopter that pressed on in the face of daunting ground fire.

About that music — it wasn't really music. It was the dull percussion of Huey helicopter blades beating the air. Barker was on a rescue mission.

To me, anytime the helicopters flew to the bush to pick up soldiers — even when no bullets were flying — it was a rescue.

As an infantry sergeant with the 196th Light Infantry Brigade, I loved the sound of those choppers coming. We'd hear that characteristic whopping sound faintly at first, then the hum of the engines. They'd come into sight and we'd move from cover into the open landing zone and climb aboard. The "slicks" had no doors, so we'd fly seated on the metal deck with our feet dangling over the skids.

They'd take us back to the rear, where we showered — always cold — shaved and put on clean, wrinkled uniforms, sometimes the first time in weeks.

Guys would head to the club and buy beer for 15 cents, mixed drinks for a quarter and eat pizzas made with bologna and cheddar cheese.

At the post exchange at Freedom Hill, you could eat banana splits made creatively by Vietnamese women. Sure, you sometimes got coffee or mint ice cream, but the tree-ripened bananas made up for that.

At night we would crawl onto gritty mattresses that were brown from the sweat of dozens of soldiers before. There was no such thing as an assigned cot and you sometimes wondered if you were sleeping in a bed where a man dreamed of a wife and kids he never lived to see again.

But thanks to pilots like Jack Barker, at least we weren't sleeping on the ground with rain puddling around us.

Back in the rear, you could sit around, talk at night and get your mind off things. You could brag about a girl you used to date or lie about how fast your Mustang was. You could laugh out loud, smoke a cigarette in the open and eat hot sausage, eggs and pancakes in the mess hall.

In the bush all you could do was lie silently in the dark and wish the mosquitoes would leave you the hell alone as you ached for someone. Or you aimlessly gnawed a mouthful of cold C-ration meat and remembered how good your grandma's chicken and dumplings tasted after church.

Those pilots brought mail, food and ammo to thousands of troops, sometimes with green tracers whacking into their birds.

Once, a medevac crew flew through a mountain fog that was like gray bisque to hoist Richard Graham, one of my soldiers, up through the trees on Charlie Ridge after he took four AK-47 rounds in the thighs.

I admit that I hated outgoing flights when the birds started dropping toward an LZ and the door gunners cranked up their M60 machine guns. But they always got us out.

That's what Barker and his crew were trying to do when they died. Their sparse remains were found more than 30 years later and next week Barker will get a hero's burial at Arlington.

Many other chopper pilots already are in their graves. Many, blessedly, are still with us.

They're all heroes to me. Maybe that's why Huey music still gives me chills.

Pleiku 6

Pilot asks for correction about his status in series

Please be advised that a request has been made of me to change a small part of the thrilling story of Pleiku 6 by one of the pilots who lived it.

James L Siegfried, better known to those who flew with him as "Ziggy," has asked that I change the part concerning his departure from the unit and Vietnam. As one with great respect for accuracy, please allow me to grant Ziggy his wish. See correction below.

Ziggy continued flying missions

Ziggy did not leave the unit right after Mike Kieren and me, as I stated in Episode 4. He continued to fly with the Panthers until June 30, 1972. On that date, he was AMC in a flight of two returning from shooting at bad guys and their armored toys in and around Kontom.

Northwest of Pleiku he contacted Pleiku Air Force Base and requested permission to cross the base's extended west runway low level en route to Camp Holloway. Permission was granted and, as he crossed, 26 AK-47 rounds made Swiss cheese of his AH-1G Cobra, 12 going through the cockpit. Several hit his front-seater, "Fearless" Forrest Snyder, in the left foot, behind the left calf and left knee. Ziggy took two in his right foot. There were also holes in the tail boom and tail rotor.

Ziggy notified his wingman, Bernie Busby, he had taken hits, both Fearless and he were wounded, and he was putting the Snake down. Bernie notified Panther OPNS and called for a medevac.

Pilots remained alert

Both pilots remained alert and headed for the pad at Artillery Hill, Ziggy using his left foot and Fearless, his right.

Three Chinooks occupied that space, so Ziggy and Fearless landed in a parking lot across from the pad. Bernie was in behind them. The medevac arrived and carted both of the wounded guys to the 94th Evacuation Hos-

pital in Pleiku.

When John Debay, the 361st maintenance officer found out, he was concerned about the pilots. When he saw the aircraft and realized it would have to be sent back to the States for repair, he was irate. The Cobra was a new aircraft in Vietnam, with less than 10 hours on it.

Several days later, when he went to visit Ziggy and Fearless in the hospital, he said, and I quote: "If you two assholes wanted to low level home, why didn't you fly 295? That thing is a piece of s*&# and needs to be shot up and shipped home."

The crew chief, Roy Snisko, also was fit to be tied when he saw the aircraft. There was blood everywhere in the cockpit. "I'm not cleaning this. Those two officers can do it when they come back to the company," he reportedly said.

Ziggy and Fearless stayed in the hospital in Pleiku until July 6, then were flown to Japan. From there, they were flown to Travis Air Force Base on July 16.

Pilot spent months in hospital

Ziggy spent several months in an Army hospital in San Francisco. Fearless was flown on to Washington, D.C., and spent almost a year in Walter Reed. Oh, don't be too concerned about him, he got to go home every night.

Ziggy attended the 1992 Atlanta reunion with Mike Kieren and me. It was the first time either of us had seen him since Vietnam. He still looked the same.

I located Fearless in the spring of 1999. He attended his first VHPA reunion that year in Nashville. He and Paula, his beautiful wife haven't missed one since.

After the Nashville reunion, Fearless was flying to California to meet Paula and visit their son, a Navy man who lived on the West Coast. He made a point of going to see Ziggy. It was the first time they had seen each other since July 16, 1972.

Well, I hope Ziggy is happy now, the record is straight, and the tale has been corrected.

Stolen valor

House OKs tougher punishment for imposters

WASHINGTON — A bill mandating tougher punishment for military imposters gained final approval from the House on Wednesday, and will now go to the president to be signed into law.

The legislation, dubbed the "stolen valor act," calls for up to six months in prison for anyone who falsely claims to have earned a military honor, and up to a year in prison for fraudulently wearing a Purple Heart, Silver Star or other high military honor.

Both crimes would also be classified as felonies, which can carry additional penalties such as limits on gun ownership and disqualification from certain public offices, depending on the state.

Under current law, anyone caught wearing a military medal they did not earn faces a misdemeanor charge and up to six months in prison, but law enforcement can't do anything to someone simply displaying or claiming to have earned the honor.

House officials on Wednesday said the change closes that critical loophole and helps protect the integrity of the military awards.

"These frauds have diminished the honor of our military heroes," said Rep. John Salazar, D-Colo., who introduced the original version of the measure. "They use it to gain credibility for themselves, and often go on to commit even worse crimes."

Along with cases of individuals using the fake medals to gain speaking engagements and community leadership roles, Salazar referenced crimes committed in 2004 by

retired Marine Sgt. Gary Lakis, who claimed fake combat experience and nonexistent Silver Stars in order to gain \$66 million in defense contracts to provide training to the service.

The military revoked those contracts once Lakis was found to be lying about much of his military career, but he fled the country before FBI investigators could arrest him and charge him with fraud.

Rep. John Kline, R-Minn., said awards such as the Purple Heart "hold a deeper meaning and value for servicemen that far outweighs their monetary worth," and called the bill a chance to honor the sacrifice of all troops by preserving the military's legacy.

The tougher penalties are backed by a number of veterans groups, including the Vietnam Veterans of America and the Military Order of the Purple Heart.

As of late last week, supporters thought the bill likely wouldn't pass this session because of House Republican leadership's resistance to moving a measure proposed by Salazar, a first-term Democrat.

The measure approved yesterday was a nearly identical bill sponsored by Sen. Kent Conrad, D-N.D., which was approved by the full Senate in September.

The White House has not released any timetable for when the bill could be signed into law.


