FIRST OF TWO TAKES--ND ON PEACE SABOTAGE

((NHAN DAN 20 JUNE COMMENTARY: "THE UNITED STATES IS THE CHIEF CONSPIRER IN SABOTAGING PEACE"))

((TEXT)) AFTER THE U.S. AND NGUYEN VAN THIEU ADMINISTRATION DELEGATIONS HAD DELIBERATELY STALEMATED THE SESSIONS OF THE TWO-PARTY JMC AND THE FOUR-PARTY JMC TEAM, THE U.S. EMBASSY IN SAIGON ON 18 JUNE ISSUED A STATEMENT FILLED WITH VERY UGLY WORDS. IT FALSELY ACCUSED THE DRV GOVERNMENT OF INTENSIFYING ACTS OF WAR, IN ORDER TO CONQUER THE SOUTH VIETNAMESE PEOPLE BY MEANS OF PURE MILITARY FORCE, OF NOT RESPECTING THE CEASE-FIRE, OF OPENLY TEARING THE PARIS AGREEMENT AND OF NOT RENOUNCING THE FOOLISH DREAM OF CONQUERING ALL OF SOUTHEAST ASIA.

MOREOVER, THE U.S. EMBASSY IN SAIGON LAVISHED PRAISE ON THE THIEU ADMINISTRATION FOR SCRUPULOUSLY FULFILLING ITS OBLIGATIONS TO THE PARIS AGREEMENT, FOR DISPLAYING ITS GOODWILL IN AN EXTREMELY CLEAR MANNER, AND SO FORTH.

THIS VILE TRICK OF THE UNITED STATES AND THE THIEU CLIQUE WAS PREPARED IN ADVANCE AND AIMED AT SPREADING DECEITFUL ARGUMENTS. UPI REPORTED THAT ONLY A FEW MINUTES AFTER THE SESSIONS OF THE TWO-PARTY JMC AND THE FOUR-PARTY JMC TEAM HAD BECOME DEADLOCKED, THE U.S. EMBASSY ISSUED THIS STATEMENT. AT THE 18 JUNE SESSIONS, THE STUBBORN REFUSAL BY THE UNITED STATES AND SAIGON TO RECOGNIZE AND GUARANTEE THE PRIVILEGES AND IMMUNITIES ACCORDED TO THE MILITARY DELEGATIONS OF THE DRV GOVERNMENT AND THE PRGRSV, AS STIPULATED IN THE PARIS AGREEMENT, WAS THE MAIN CAUSE OF THE DEADLOCK AT THESE SESSIONS. RESORTING TO THE TRICK OF SABOTAGING THE NEGOTIATIONS AND THEN ADVANCING A PRETEXT FOR SPREADING SLANDERS IS A FAMILIAR TACTIC OF THE U.S.-THIEU CLIQUE.

THE PARIS AGREEMENT WAS SIGNED NEARLY 17 MONTHS AGO, AND THE JOINT COMMUNIQUE WAS SIGNED MORE THAN A YEAR AGO. HOWEVER, THE SITUATION IN SOUTH VIETNAM CONTINUES TO BE INCREASINGLY SERIOUS. REGARDLESS OF ITS COMMITMENTS, THE UNITED STATES CONTINUES TO INVOLVE ITSELF MORE AND MORE DEEPLY AND INTERVENE MORE AND MORE BRAZENLY IN SOUTH VIETNAM. THIS INVOLVEMENT AND INTERVENTION, WHICH IS A U.S. STRATEGIC SCHEME, HAS BEEN OPENLY AND CLEARLY EXPOSED BY MANY COMPETENT OFFICIALS OF THE NIXON ADMINISTRATION. FOR INSTANCE, U.S. DEFENSE SECRETARY SCHLESINGER STATED ON 21 MAY 1974 THAT THE UNITED STATES HAD ITS TACIT ((MAVCJ NHIEEN)) COMMITMENT; U.S. SECRETARY OF STATE KISSINGER STATED ON 4 JUNE 1974 THAT THE UNITED STATES HAD A MORAL AND POLITICAL COMMITMENT, NOT TO MENTION A LEGAL COMMITMENT, TO THE THIEU REGIME; KISSINGER STATED ON 25 MARCH 1974 THAT THE UNITED STATES HAD ADMITTED THAT IT WAS OBLIGATED BECAUSE OF "OUR LONG AND FAR-REACHING INVOLVEMENT IN VIETNAM."

PURSUING THAT NEOCOLONIAL SCHEME, THE UNITED STATES IS SEEKING BY EVERY POSSIBLE MEANS TO SABOTAGE THE PARIS AGREEMENT AND CONTINUE THE WAR. THE UNITED STATES HAS HELPED, ENCOURAGED AND INSTIGATED THE THIEU LACKEY CLIQUE TO INTENSIFY MILITARY ACTIVITIES WHILE CONSTANTLY SPREADING ARGUMENTS TO COVER UP ITS EVIL DESIGNS AND STYLING ITSELF AS PEACE-LOVING.

THE ORGANIZATIONS BEING MAINTAINED BY THE UNITED STATES IN SOUTH VIETNAM, SUCH AS THE DAO RPT DAO, THE SPECIAL OFFICE TO THE AMBASSADOR FOR FIELD OPERATIONS, USAID, THE U.S. CONSULATES-GENERAL AND CONSULATES IN THE VARIOUS MILITARY REGIONS AND IN MANY PROVINCES IN THE AREAS UNDER THIEU'S CONTROL ARE ALL CAMOUFLAGED WAR MACHINERIES, WITH MORE THAN 25,000 U.S. MILITARY PERSONNEL DISGUISED AS CIVILIANS CHARGED WITH COMMANDING AND DIRECTING THE SAIGON ARMED FORCES AND POLICE. FOR NEARLY 17 MONTHS, THE UNITED STATES HAS ILLEGALLY INTRODUCED INTO SOUTH VIETNAM MORE THAN 1 MILLION TONS OF BOMBS AND MUNITIONS, 1,100 TANKS AND ARMORED CARS, 800 ARTILLERY PIECES, MORE THAN 200 WAR VESSELS AND NEARLY 700 AIRCRAFT OF VARIOUS TYPES, INCLUDING 80 MODERN F-5E'S.

AIRCRAFT OF THE CIA AND EVEN F-5E PLANES PILOTED BY AMERICANS THEMSELVES HAVE TAKEN PART IN OPERATIONS CONDUCTED BY THE SAIGON ARMED FORCES. MORE 201300 T/CHATELAIN 21/0720 TH.

((TEXT)) THE NIXON ADMINISTRATION RECENTLY ALSO SOUGHT BY EVERY MEANS POSSIBLE TO PRESS THE U.S. CONGRESS TO ADOPT ENORMOUS DRAFT AID BUDGETS IN FAVOR OF THE THIEU CLIQUE. ACCORDING TO VARIOUS U.S. DISPATCHES, THE U.S. MILITARY AND ECONOMIC AID TO THE THIEU CLIQUE IN THE COMING FISCAL YEAR WILL AMOUNT TO \$3.7 BILLION DOLLARS. THE INCREASING U.S. AID TO THIEU IS AIMED AT CONTINUING THE NIXON DOCTRINE AND THE VIETNAMEZATION OF THE WAR AFTER THE UNITED STATES HAS HAD TO BRING HOME ITS EXPEDITIONARY ARMY. NISSINGER HIMSELF ADMITTED THAT THIS AID WAS DESIGNED TO SERVE THE VITAL INTERESTS OF THE UNITED STATES.

IT HAS BECOME EVIDENT THAT THE SOURCE OF THE PRESENT EXTREMELY DANGEROUS SITUATION IN SOUTH VIETNAM IS THE UNCHANGED POLICY OF THE NIXON ADMINISTRATION IN USING THE WARLIKE NGUYEN VAN THIEU CLIQUE AS AN INSTRUMENT TO CONTINUE THE WAR IN AN ATTEMPT TO IMPOSE U.S. NEOCOLONIALISM. THEY ARE THE CULPRITS IN ALL THE CRIMES AGAINST OUR COMPATRIOTS. WHATEVER ALLEGATIONS THE UNITED STATES MAY ADVANCE, IT CAN NOT COVER UP THE TRUE NATURE OF THE UNITED STATES AND ITS SAIGON LACKEYS AS THE SABOTEURS OF THE PARIS AGREEMENT AND PEACE. THE FACT THAT MARTIN, THE U.S. GOVERNOR GENERAL IN SAIGON, ISSUED A STATEMENT SLANDERING THE DRV GOVERNMENT AND PRGRSV SIDE DECIDEDLY CANNOT DECEIVE WORLD PUBLIC OPINION.

NOT LONG AGO, MARTIN HIMSELF SAID THAT THE UNITED STATES WAS INCREASING MILITARY AID TO THIEU IN ORDER TO INSURE SOUTH VIETNAM'S RIGHT TO SELF-DETERMINATION. IF THE UNITED STATES WANTS TO INSURE THE SOUTH VIETNAMESE PEOPLE'S RIGHT TO SELF-DETERMINATION, IT MUST END ITS NEOCOLONIAL POLICY OF AGGRESSION, CEASE ITS MILITARY INVOLVEMENT IN THIS REGION, RESPECT ALL THE PROVISIONS OF THE PARIS AGREEMENT AND GIVE UP USING THE THIEU CLIQUE AS AN INSTRUMENT TO CONTINUE THE WAR. THE SAIGON ADMINISTRATION MUST RENOUNCE THE PATH OF SABOTAGING THE NEGOTIATIONS AND SERIOUSLY RESPOND TO THE FAIR AND REASONABLE SIX-POINT PROPOSAL OF THE PRGRSV. IF THEY STUBBORNLY CONTINUE TO FOLLOW THE PATH OF SABOTAGING THE PARIS AGREEMENT AND PEACE, THEY MUST BEAR FULL RESPONSIBILITY FOR ALL THE CONSEQUENCE OF THEIR ACTIONS.
