(TEXT) HANOI, JUNE 21, 1974 (HSINHUA) -- THE FOREIGN MINISTRY OF THE REPUBLIC OF SOUTH VIETNAM MADE PUBLIC A MEMORANDUM ON JUNE 15, CONDEMNING THE UNITED STATES AND THE SAIGON ADMINISTRATION FOR SERIOUSLY SABOTAGING THE PARIS AGREEMENT ON VIETNAM AND THE JUNE 13, 1973 JOINT COMMUNIQUE, ACCORDING TO LPA.

THE MEMORANDUM DENOUNCED THE UNITED STATES FOR INVOLVING EVER DEEPER MILITARILY AND INTERFERING EVER MORE BRAZENLY IN THE INTERNAL AFFAIRS OF SOUTH VIETNAM IN DEFIANCE OF THE PROVISIONS OF THE AGREEMENT AND THE JOINT COMMUNIQUE. IT SAID: THE UNITED STATES STILL MAINTAINS IN SOUTH VIETNAM A MACHINERY WHICH DIRECTS THE NGUYEN VAN THIEU ADMINISTRATION IN CONTINUING THE WAR ACCORDING TO A PLAN MAPPED OUT BY WASHINGTON. MORE THAN 25,000 U.S. MILITARY PERSONNEL IN CIVILIAN GUISE ARE DIRECTING MILITARY ACTIVITIES AND "PACIFICATION" PROGRAMS, DIRECTLY COMMANDING THE ARMED FORCES AND POLICE OF THE NGUYEN VAN THIEU ADMINISTRATION. ALONG WITH THESE ACTIVITIES, THE UNITED STATES HAS CONTINUED ITS ILLEGAL INTRODUCTION OF WEAPONS, AMMUNITION AND MEANS OF WAR INTO SOUTH VIETNAM. ACCORDING TO STILL INCOMPLETE FIGURES, FROM JANUARY 28, 1973 TO APRIL 30, 1974, THE UNITED STATES BROUGHT TO SOUTH VIETNAM MORE THAN ONE MILLION TONS OF AMMUNITION, NEARLY TWO MILLION TONS OF FUEL, OVER 1,100 TANKS AND ARMoured CARS, 800 CANNONS OF VARIOUS CALIBRES, OVER 200 MILITARY VESSELS, NEARLY 700 AIRCRAFT OF VARIOUS TYPES INCLUDING 30 F-5ES. THE UNITED STATES HAS ALSO USED AIRCRAFT OF THE CENTRAL INTELLIGENCE AGENCY AND THE SAID F-5ES MANNED BY U.S. PILOTS TO TAKE PART IN THE OPERATIONS OF THE SAIGON ARMY. RECENTLY, THE UNITED STATES HAS PUSHED FORWARD THE CONSTRUCTION OF AMMUNITION FACTORIES IN SOUTH VIETNAM.

IT SAID: THE UNITED STATES HAS ALSO TRIED TO INCREASE CONSIDERABLY ITS MILITARY AID TO THE NGUYEN VAN THIEU ADMINISTRATION, WHICH IS OFFICIALLY PUT AT 1,126 MILLION DOLLARS IN THE FISCAL YEAR 1973-1974. BUT IN REALITY, ACCORDING TO FIGURES OF THE ARMED FORCES COMMITTEE OF THE U.S. HOUSE OF REPRESENTATIVES, SPENDING ON THE USE, MAINTENANCE AND PURCHASE OF ARMAMENTS FOR SOUTH VIETNAM IN THE FISCAL YEAR 1973-1974 AMOUNTED TO MORE THAN THREE BILLION DOLLARS.

IT WENT ON: TO JUSTIFY THE POLICY OF MILITARY INVOLVEMENT AND INTERFERENCE IN THE INTERNAL AFFAIRS OF SOUTH VIETNAM, THE AUTHORITATIVE CIRCLES IN THE U.S. GOVERNMENT HAVE STATED EXTREMELY CYNIC AND DECEPTIVE ALLEGATIONS VAINLY ATTEMPTING TO "LEGALIZE" THE INVOLVEMENT AND INTERFERENCE. THEY CONSIDER THE PARIS AGREEMENT AS A NEW POLITICAL AND JURIDICAL BASIS TO PROLONG THEIR COMMITMENTS TO THE NGUYEN VAN THIEU ADMINISTRATION, CONTINUE TO MAKE USE OF THIS ADMINISTRATION TO IMPOSE U.S. NEO-COLONIALISM ON SOUTH VIETNAM AND PERPETUATE THE DIVISION OF VIETNAM.

IT POINTED OUT: WITH THE SUPPLY OF BILLIONS OF DOLLARS, MILLIONS OF TONS OF ARMAMENTS, AMMUNITION AND MEANS OF WAR BY THE UNITED STATES, THE WARLIKE AND FASCIST NGUYEN VAN THIEU CLIQUE HAS MOBILIZED AN ARMY OF MORE THAN ONE MILLION MEN AND A MACHINE OF COERCION OF HUNDREDS OF THOUSANDS OF MEN TO CONDUCT DAILY LAND-GRABBING AND "PACIFICATION" OPERATIONS TO REPRESS, TERRORIZE AND PLUNDER THE PEOPLE, TO TRAMPLE UNDERFOOT ALL DEMOCRATIC LIBERTIES AND TO CONTINUE MALTREATING MORE THAN 200,000 POLITICAL PRISONERS, BRINGING SO MUCH SUFFERING AND MOURNING TO THE POPULATION OF SOUTH VIETNAM, OPPOSING THEIR ASPIRATIONS FOR PEACE, INDEPENDENCE, DEMOCRACY AND NATIONAL RECONCILIATION AND CONCORD. ((TEXT)) IT DECLARED THAT THE PROVISIONAL REVOLUTIONARY GOVERNMENT OF THE REPUBLIC OF SOUTH VIETNAM AFFIRMS ONCE AGAIN ITS UNCHANGED POSITION OF STRICTLY RESPECTING AND SCRUPULOUSLY IMPLEMENTING THE PARIS AGREEMENT ON VIETNAM WHILE RESOLUTELY STRUGGLING TO MAKE THE UNITED STATES AND THE NGUYEN VAN THIEU ADMINISTRATION DO LIKEWISE.

IT SAID THAT TO ENSURE THE STRICT IMPLEMENTATION OF THE PARIS AGREEMENT AND THE JOINT COMMUNIQUE AND THE RIGHT TO GENUINE SELF-DETERMINATION OF THE SOUTH VIETNAMESE PEOPLE, THE PRG HAS ON MANY OCCASIONS PUT FORWARD VERY REASONABLE AND FAIR PROPOSALS WHICH CONFORM TO THE REALITIES IN SOUTH VIETNAM. IT PUT FORWARD A SIX-POINT PROPOSAL ON MARCH 22, 1974 AIMED AT ACHIEVING PEACE AND NATIONAL CONCORD IN SOUTH VIETNAM.

IT SAID: BUT THE WARLIKE AND FASCIST NGUYEN VAN THIEU CLIQUE HAS ARROGANTLY REJECTED THE SIX-POINT PROPOSAL, STEPPED UP THE WAR AND COMMITTED MORE CRIMES AGAINST THE SOUTH VIETNAMESE PEOPLE. MEANWHILE, IT HAS GROSSLY SABOTAGED THE NEGOTIATIONS. IT ARROGANTLY SUSPENDED SINE DIE ITS PARTICIPATION IN THE CONSULTATIVE CONFERENCE BETWEEN THE TWO SOUTH VIETNAMESE PARTIES AT LA CELLE SAINT CLOUD, SERIOUSLY VIOLATED THE DIPLOMATIC PRIVILEGES AND IMMUNITIES OF THE MILITARY DELEGATIONS OF THE PROVISIONAL REVOLUTIONARY GOVERNMENT OF THE REPUBLIC OF SOUTH VIETNAM AND THE GOVERNMENT OF THE DEMOCRATIC REPUBLIC OF VIETNAM, UNDERMINED THE NORMAL ACTIVITIES OF THE JOINT MILITARY COMMISSIONS, AND CAUSED DEADLOCK TO THE NEGOTIATIONS, THUS RENDERING THE SITUATION IN SOUTH VIETNAM MORE CRITICAL.

THE MEMORANDUM SAID, "THE PROVISIONAL REVOLUTIONARY GOVERNMENT OF THE REPUBLIC OF SOUTH VIETNAM STRONGLY DENOUNCES AND STERNLY CONDEMNS THE UNITED STATES AND THE NGUYEN VAN THIEU ADMINISTRATION FOR CONTINUING THE WAR, UNDERMINING THE PARIS AGREEMENT AND WRECKING THE NEGOTIATIONS. IT RESOLUTELY DEMANDS THAT THE UNITED STATES AND THE NGUYEN VAN THIEU ADMINISTRATION STRICTLY RESPECT AND SCRUPULOUSLY IMPLEMENT THE PARIS AGREEMENT ON VIETNAM AND THE JOINT COMMUNIQUE OF JUNE 13, 1973. THE UNITED STATES MUST END ITS MILITARY INVOLVEMENT AND INTERFERENCE IN THE INTERNAL AFFAIRS OF SOUTH VIETNAM, STOP USING THE NGUYEN VAN THIEU ADMINISTRATION TO CONTINUE THE WAR AND IMPOSE U.S. NEO-COLONIALISM ON SOUTH VIETNAM. THE NGUYEN VAN THIEU ADMINISTRATION MUST GIVE UP THE ROAD OF WAR, NEGOTIATE IN GOOD FAITH AND RESPOND POSITIVELY TO THE SIX-POINT PROPOSAL OF THE PRG SO THAT PEACE AND NATIONAL CONCORD MAY BECOME A REALITY IN SOUTH VIETNAM.

"THE PROVISIONAL REVOLUTIONARY GOVERNMENT OF THE REPUBLIC OF SOUTH VIETNAM ALWAYS RESPECTS AND SCRUPULOUSLY IMPLEMENTS THE PARIS AGREEMENT ON VIETNAM. AT THE SAME TIME, IT IS RESOLVED TO PUNISH THE UNITED STATES AND THE NGUYEN VAN THIEU ADMINISTRATION FOR ALL THEIR ACTS OF WAR AND CRIMES IN ORDER TO DEFEND THE LIBERATED ZONE, DEFEND THE LIVES AND PROPERTY OF THE PEOPLE, SAFEGUARD PEACE AND PRESERVE THE PARIS AGREEMENT ON VIETNAM."
