PRG MILITARY DELEGATION 18 JUL NOTE TO ICCS CITES VIOLATIONS

((TEXT)) THE PRGRSV MILITARY DELEGATION TO THE CENTRAL
TWO-PARTY JMC ON 18 JULY 1974 SENT A NOTE TO THE ICCS CHAIRMAN
CONDEMNING THE SAIGON ADMINISTRATION FOR CONDUCTING DIVISION-
SIZE NIBBLING OPERATIONS AGAINST THE PRGRSV-CONTROLLED AREAS
IN KY PHUOC, KY ANH AND KY BINH VILLAGES, THANG BINH DISTRICT,
QUANG NAM PROVINCE, FROM 1 TO 10 JULY.

THE NOTE POINTED OUT: ALONG WITH OTHER NIBBLING OPERATIONS
CONDUCTED BY THE SAIGON ADMINISTRATION SIDETHROUGHOUT SOUTH
VIETNAM, THE CRIMINAL ATTACKS NOW BEING ACCELERATED IN THESE
THREE VILLAGES SHOW THAT THE SAIGON ADMINISTRATION, UNDER THE
U.S. COMMAND AND SPONSORSHIP, HAS CONTINUED TO STUBBORNLY
PLUNGE ONTO THE PATH OF UNDERMINING THE CEASE-FIRE AND THE
PARIS AGREEMENT EVER MORE SERIOUSLY AND SYSTEMATICALLY, THUS
CREATING A VERY TENSE AND DANGEROUS SITUATION IN THIS AREA.

THESE ACTS HAVE BEEN CARRIED OUT IN COORDINATION WITH THEIR
MANEUVERS AND ACTIONS AIMED AT ORAVELY UNDERMINING THE ORGANS
CHARGED WITH IMPLEMENTING AND SUPERVISING THE IMPLEMENTATION
OF THE AGREEMENT, THEREBY GRAVELY VIOLATING ARTICLES 2 AND 3
OF THE PARIS AGREEMENT ON VIETNAM, AND ARTICLES 3 AND 4 OF THE
13 JUNE 1973 JOINT COMMUNIQUE.

THE UNITED STATES AND THE SAIGON ADMINISTRATION SIDE MUST
BEAR FULL RESPONSIBILITY FOR ALL CONSEQUENCES OF THESE AGREEMENT-
