PROTEST CITED ON CUTTING WATER SUPPLY TO TAN SON NHUT DELEGATIONS

Liberation Radio [Clandestine] in Vietnamese to South Vietnam 0500 GMT 12 Mar 75 SG

[Text] The Saigon administration has since 17 February 1975, cut off the main water supply to the PRGRSV and DRV military delegations at Tan Son Nhut and has instead provided them with only one or two water tanks daily.

On 6 March, after this act of sabotage was exposed, the Saigon administration resorted to the trick of displaying its good will by supplying the two delegations with six water tanks daily. However, on the morning of 11 March, under the pretext that the tanks were broken, the Saigon administration again stopped its water supply to the two delegations.

The above incident indicates that after sabotaging the regular weekly liaison flights between Saigon and Loc Ninh, the Saigon administration has taken another step in hindering the normal activities of the PRGRSV and DRV military delegations.

PRG 2-PARTY JMC DELEGATION PROTESTS CEASE-FIRE VIOLATIONS TO ICCS

[Text] On 12 March, the PRGRSV military delegation sent an official note to the ICCS chairman concerning 200 serious cease-fire violations perpetrated by the Saigon administration side in PRGRSV-controlled areas in the provinces of the Tay Ninh, Binh Duong, Bien Hoa, Sa Dec, Vinh Long, Tra Vinh, Can Tho, Soc Trang, Bac Lieu, Chuong Thien, Rach Gia, Chau Ha and Ca Mau from 10 February through 6 March.

The note points out: The criminal cease-fire violations by the Saigon administration, which have been continuously stepped up throughout South Vietnam, prove that the Saigon administration side, directed and assisted by the Americans, is constantly stepping up the war and sabotaging the agreement in a comprehensive, systematic and increasingly serious manner.

The PRGRSV military delegation to the central Two-Party JMC vehemently denounces and sternly condemns the schemes and very serious acts of sabotage of the cease-fire and the agreement by the stubborn Saigon administration.

The Americans and the Saigon administration must bear full responsibility for all the consequences of their acts of sabotage.

PRG 2-PARTY JMC DELEGATION PROTESTS INDONESIAN, IRANIAN INVESTIGATION

[Text] On 12 March, the PRGRSV military delegation sent an official note to the ICCS chairman concerning the so-called investigation by the Indonesian and Iranian ICCS delegations of a "cease-fire violation" fabricated by the Saigon administration in northern Thanh An, Pleiku Province.

The note stresses that this separate observation in Pleiku by the Indonesian and Iranian ICCS members is at complete variance with the stipulations in Article 18-F of the Paris agreement and Article 9-A of the protocol concerning the ICCS.

This is not a solitary action, but a systematic and deliberate erroneous action which has been repeated many times.

The PRGRSV military delegation to the central Two-Party JMC requests that the ICCS take measures to put an end to these erroneous actions of the Indonesian and Iranian delegations.
