Mov Data: This is an advance movement order. This order authorizes movement of families of assigned deployable personnel to a designated location under provisions of JTR. This order does not authorize unit to depart home station or preposition trans auth to depart home station and preposition transportation will be contained in the final movement directive. CINCSIX has responsibility for movement planning and deployment. Pers and equip will move by surface or air as directed by CINCSIX. Equip shipped dir by sources of supply WB marked with Proj Code and supplementary address code to be provided by the overseas commander. Each individual traveling by air is auth 450 lbs. This includes individual body wt, baggage and MEE. Accompanying baggage and MEE cannot exceed 15 cubic feet.

Proj Code WA used for supply requisitioning and identification of shipment. Unit commander will conduct an orientation as prescribed by AR 360-81. Responsible Major Commands will report unit move to CG, USAIC, ATTN: AJIGT-O in accordance with para 8 and 9, Annex C, USAIC Cir 220-10, dtd 3 Jan 67. Classification of unit movement and inquiries from news media will be in accordance with para 6, USAIC Cir 220-10, 3 Jan 67.
