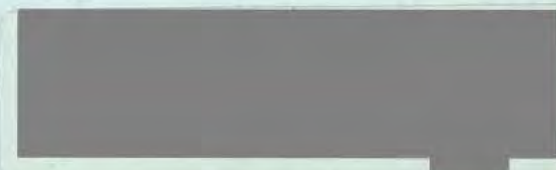

READERS RESPONSE

NOTE: In the last Newsletter I wrote an article called "OLLIE NEEDS OUR SUPPORT", even though it was clearly marked as MY OPINION, it really had no business being in the newsletter. I apologize to anyone it may have offended, I will try not to let it happen again. I thank those who responded, they help keep our Association what it was intended to be. Most of the readers response was about the Oliver North article. Here are the responses.

Dear Jim: Enclosed is a check renewing my membership. While I appreciate the time and effort you have put into forming the Association, I strongly object to the article "Ollie Needs Our Support" in the March 1988 issue of the Newsletter.,

The Newsletter states that the Association is "...a fraternal organization... established for the purpose of holding reunions, writing unit and battalion history, and to re-establish the comradery of the Battalion..., The article does state clearly that it is your opinion. In my opinion, however, this Newsletter is not the appropriate forum for you to express your opinions regarding national and international events. Can we expect a 1988 presidential endorsement in a future issue of the Newsletter?

You state that North is "...willing to standup and fight for justice..." The fact is, North and his lawyers are using all legal strategies possible to avoid such a fight. For example, they have tried to get the indictments against North overturned on the basis that the law establishing the independent counsel is unconstitutional. Is this the action of a man who has not committed a crime and who wants his day in court to prove it?

Are you aware of the fact that, when he realized the FBI was going to confiscate the files in his office, North spent the night feeding these files into a shredding machine? Are you aware of the fact that he had his secretary pull letters out of files, change the dates or contents of these letters, and then reinsert them into the files? This is the innocent man to whom you are going to lend your moral and monetary support?

Nobody is questioning the sincerity of North's motives in helping the Contras. However, we are a nation of laws, not of people acting on their well-intentioned motives. Children are being blown up by car bombs in Belfast and Beirut. They are starving by the hundreds of thousands in Ethiopia while food convoys are being attacked. The people responsible for these actions firmly believe that their causes justify these actions. North firmly believed that his cause justified breaking the law. (Even you, Jim, have to admit that, at a minimum, he broke the law making it a crime to destroy documents belonging to the federal government.) You are correct, of course, in stating that you did not vote for the independent counsel. You did have the opportunity, however, to vote for one representative, two senators, and one president who were involved in making the law establishing the independent counsel. And by the way, I didn't vote for Ollie North to conduct foreign policy.

I enjoyed reading your letter, and would not have objected to your using the Association mailing list to distribute it (at your own expense, of course). If this type of commentary is going to appear in the Newsletter, I would suggest changing the Association by-laws to indicate as such. Sincerely, R Curtin

Hopefully all will be forgiven and this issue will be over and done with.

I have made some mistakes in the past and will probably make more in the future, but I learn from them. In the future if I make some mistakes or do something that offends you please let me know, I'll try to correct it, I've put too much time, effort and money into our Association to lose any members because of my mistakes. So please bare with me and with your guidance we'll build an organization we'll all be proud it be a member of.

For those people that have been located in the last year or so here is a little of the history of how our association got started and how I became the National Director/Coordinator. In September of 1985 I went to a large Vietnam Veterans gathering in Kokomo, IN, while there I checked the sign in roster many times looking for names of other aviation people from the 3 Corp area in 1969 and 70. A few days later another Vet suggested inviting some people from my old unit to the next years get together. After locating a few people we decided a reunion would be great, I placed some ads in some Veterans magazine for people from the 68th to contact me. In a few weeks I started getting calls and letters from other former Top Tigers. I also got calls and letters from people from the other units of the battalion saying if we were having a reunion

they would like to be there, so we had a Battalion reunion in Kokomo, IN in Sept. 1986, where we formed our Association. By that time I was starting to get pretty good at locating people, which I really enjoyed. The people at the first reunion voted me to head up the association, I figure, because of my skills in locating people. It certainly wasn't my speaking or organizing skills, of which I had none. Since that time I have been learning how to manage an organization and working on my speaking and writing skills. I was re-elected at the 87 Reunion to serve till the 89 Reunion. Should anyone want to run for National Director/Coordinator at that time I would only ask that they let me help with locating new people. That's the part of the job I really enjoy.

And another response was from Gary B Roush who takes care of the memorial list for the Vietnam Helicopter Pilots Association. In the last newsletter in the article "Battalion History, The Early Days (Continued)" I reported that Dana Edward Brann was the youngest Army Aviator to be killed in Vietnam, he was born on 8 August 1946 and died on 16 November 1965, he lived 7040 days. It turns out that Dana E Brann was the second youngest Army Aviator to be killed in Vietnam. The youngest was WO1 Raymond Howard Chase, Jr., born 13 August 1948 and died 10 November 1967, he lived 7028 days. Thank you Gary for pointing this out, your doing a very valued service for the VHPA, hopefully soon we'll have volunteers for our Memorial Committee.

And in the same article I report that the 117th left the 145th in August of 1965, in a letter from Carl Vogel who served with the 117th in 64-65, he stated that the 117th at that time was with the 52nd CAB., do any of you from the 117th remember when the 117th left the 145th the first time. Carl also sent some copies of orders and information on the history of the 117th. Thank you Carl.

Mike Hannum who served with the 68th from 1965 to 1968 sent me a detailed report about his time with the 68th, 30 pages, and many copies of orders. Thanks Mike it was very good reading and is very helpful in writing the unit history.

Jim Aretz, 334th 66-68, sent me some orders, company roster, and some old address. Thanks Jim, these will be very helpful.

Terry Carney, 68th 69-70, sent some orders and is planning on being at the 89 Reunion.

And Emmett Knight who served as an Officer in the 57th Trans. Co., sent me a copy of the unit history for the 57th Trans. Co. and the 98th Trans. Det. that he and the Boeing Vertol Company put together for a unit reunion at Fort Rucker in June of 87. He has volunteered to be the unit historian for the 57th and 98th for us. The unit history book goes into great detail of the history of the 57th and the H-21. If any of you from that time period would like a copy he has a few left, please contact him. Thank you for the book and all your effort, Emmett.

UNIT HISTORY

Although the purpose of a fraternal veterans organization is to continue the comradery of its members, a more lasting, and in my opinion, the most important task which confronts us is to publish each unit history.

We owe this not only to ourselves but to our families and fallen comrades. We want our accomplishments on record for the entire world to know of our role in that conflict.

Every member of the association carries within himself the knowledge that would write that history. We all therefore, must contribute.

Most units, that at one time comprised the battalion, have a designated unit historian. For those not covered, we ask for volunteers to represent those units. The unit historian becomes the focal point for the production of the history with the assistance of representative members. Your unit historian will contact you for specific information. Everyone should, however, prepare personal experiences and gathering appropriate photographs, maps, diagrams and other visual and textual material.

The battalion historian will consolidate the substance of each unit history.

Now is an appropriated time for us to complete our unit history. The publishing world is going full-bore with turning out Vietnam material. Much of this, in my opinion is sadly lacking or inaccurate. We can render a service by printing our true picture. If nation-wide distribution of our results is accomplished, it would provide a substantial source for association funding.

I would like to add a few notes on Col. Joost article on the unit history. First, I will be writing an article about Col. Joost, Battalion Commander 20 Feb 1966 to 25 June 1966, later in this newsletter. Second, I have written articles in the last few newsletters about the battalion history. I have tried to put in as many details as I could, but the history is a little vague and maybe inaccurate. I realized when I started writing the articles that, even though I had experienced the 68th AHC in 1969 and 70, I could only guess on the details of the unit in the early days. A lot of the details like, type and number of aircraft, normal and special missions, weapon systems used, basic set up of units and detachments, and many other things, were missing from the printed material I have. These are details that most of us know from our own time period. As an example, I couldn't tell you how many aircraft or if they were H-21 or UH-1 were in the 118th or 120th in 1964, but I bet a lot of you could. If most of you would write down that basic type of information and sent it to the unit historian or me it would be a big help in putting together the history, no details are too simple or unimportant. Look over the list of topics list above and see if you can write down anything on any of the topics, please put down the unit and the dates you serve with the unit, we need this type of information from everyone to be completely accurate.

I will be writing to all the Unit Historians and Regional Director/Coordinator to see what type of a basic floorplan we can come up with in writing the units history so they will be able to be put together to form a complete Battalion History.

Third, I have gotten a little more information on the people from our battalion who were killed in action. As we put our history together let's not forget these people. Each one of them should be remembered and recorded in our history, their being and their deaths.

I printed a list of the unit historian in this newsletter on page 4.

BATTALION HISTORY

THE BUILD-UP YEARS

1 January 1966 started off with LTC Charles M Honour commanding the Battalion. In the next two years the 145th would be credited with many "First" and many awards. Although I don't have the exact dates, the 145th was the first Aviation Battalion to fly "Fire Fly" combat operations in Vietnam and the first Aviation Battalion to fly "Smoke Ship" combat operations in Vietnam. Starting in 1965 the Army started building up many new helicopter units and battalions, Vietnam would become known as the Helicopter War. The 145th played a large part in the build up and set the example for other battalions to follow.

On 18 February 1966 LTC Charles M Honour was killed in action. LTC Horst K Joost, who was the executive officer of the 173d Airborne Brigade at the time, replaced LTC Honour on 20 February 1966.

The 1st Aviation Brigade was formed on the 1st of March 1966 and the 145th served under the 12th Group of the 1st Aviation Brigade. This was done for better command and control of all army aviation units and operations.

Under LTC Joost command the 118th Assault Helicopter Company received the Meritorious Unit Commendation for the period June 1963 to June 1966. And the 117th and the 135th Assault Helicopter Companies were awarded the Valorous Unit Award for the period 1-20 June 1966 while serving with other battalions in Operation Hawthorne/Dan Tang in Kontum Province.

LTC Walter F Jones replaced LTC Joost on June 28, 1966. Under LTC Jones the 118th Assault Hel. Co. was awarded the Valorous Unit Award for their actions on 19 July 1966. The 120th A.H.C. was transferred to Capital Avn Bn in July of 1966. The 184th Avn Co (Surv Light) arrived in Vietnam and was assigned to the 145th on 13 August 1966. While serving with 10th C.A.B. the 117th Assault Hel. Co. was awarded the Meritorious Unit Commendation service for the period of December 1965 to September 1966. And the 135th was also awarded the Meritorious Unit Commendation for the period January 1966 to December 1966 while serving with the 10th C.A.B.

September 1966 brought another name change for the 197th A.H.C., they became the 334th Armed Helicopter Company, this was the fourth and would be the last name change for them. The 334th A.H.C. retained their fine history earned under the names UTT, 68th A.H.C., 197th A.H.C., and continued with many more first and unit awards. Co A, 82nd Avn Bn name was changed to the 335th Avn Co in September 1966. The 1st of September 1966 brought a name change for A Co, 501st Avn Bn to the 71st A.H.C..

From the 14th of September 1966 to the 24th of November 1966 the 145th was involved in Operation Attleboro, the largest U.S. operation to date in Vietnam. On 19 October 1966 a sizable enemy base area was uncovered in War Zone C (Tay Ninh Province).

On 1 December 1966 LTC Howard M Moore replaced LTC Jones. The 335th A.H.C. (formerly Co A, 82nd Avn Bn.) earned the Meritorious Unit Commendation for the period 1 August 1966 to 31 January 1967. The Valorous Unit Award was earned by the 145th C.A.B., 68th A.H.C., 118th A.H.C., and 334th A.H.C. for their actions on the 19th of March 1967 under the command of LTC Howard Moore. The Vietnamese Cross of Gallantry with Palm was awarded to the 145th C.A.B., 68th, 118th, 120th, 147th, 213th, 334th, 335th Aviation Companies for the period 1 March 1966 to 26 March 1967. These last to awards were earned during Operation Junction City in Tay Ninh Province, 2,728 known enemy casualties. The 117th was awarded the Meritorious Unit Commendation for the period 5 September 1966 to 31 March 1967. In March of 1967 the 184th Avn Co was transferred to the 11th Avn Bn and in April of 67 the 71st A.H.C. was transferred to the 14th Avn Bn.

LTC John A Todd replaced LTC Moore on the 7th of August 1967. The 190th A.H.C. arrived in Vietnam and was assigned to the 145th in September 1967, shortly there after to be sent on temporary duty to I Corp with the Marines. The 213th Assault Support Helicopter Company was awarded the Meritorious Unit Commendation for the period 13 February 1967 to 15 October 1967. And under the Command of LTC Todd the Presidential Unit Citation was awarded for the

period of 6 to 23 November 1967 by the Commander-in-Chief of the Armed Forces of the United States to the 335th Assault Helicopter Company. The award to the "Cowboys" was for extraordinary heroism during Operation Mac Arthur in Kontum Province in November 1967.

Part of the 334th A.H.C. was transferred to Thailand the 24th of November 1967 on temporary duty to fly escort duty over the Ho Chi Minh Trail. They were to fly gunship cover for troops placing and picking up listening devices all along the Ho Chi Minh Trail. Their refuel point was to be Khe Sanh which went under seize shortly there after, the mission was called off the 3rd of March 1968.

On 1 December 1967 LTC Robert M. Deets replaced LTC Todd. The Battalion History article in the next newsletter will cover LTC Robert M Deets command of the 145th and their role in the victory of TET, 1968.

George "Pops" Ecker, 1923-1988

George "Pops" Ecker - father, husband, Marine, Army Aviator, friend and founder of the Viet Nam Helicopter Crew Member Assn. Int. passed away June 12, 1988 after a short battle with cancer.

My first contact with George was in January of 1987, George had been reading the Army Times and seen the ad I had sent in about the Association. George was excited about seeing the ad and give me a call, it was 4 AM Indiana time, something I kidded him about each time I talked to him after that. George had served with the 81st Trans. Co. in 1962 and 63 and with the 68th Aslt. Hel. Co. from April 1968 to September 1968 as Maintenance Platoon Sergeant, and other tours in Vietnam. George quickly sent in his membership. He planned on attending the 1987 Reunion, he left Huachuca City, AZ and headed for Texas to visit some army buddies and rest up a few days, he called me from Texas to let me know the trip was to hard on him and he should head back home. I never got to meet George in person but I talked with him many times on the phone, times when I got discouraged I could count on George to get me going again. I'll miss George as will those of you who served with him those who knew him.

George was born in Michigan on December 17, 1923. He was a career military man and retired after serving 26 years. George is survived by his wife Kathryn Ecker of Huachuca City, AZ; two sons, Michael Brunofski of San Jose, CA., and John Brunofski of San Francisco; two daughters, Lodi Evens residing in the Phillipine Islands and Connie Batton of Michigan, five grandchildren. Graveside services were held June 15, 88 at the Fort Huachuca Cemetery. George "Pops" Ecker was buried with full military honors. In lieu of flowers the family suggests remembrances be made to the Viet Nam Helicopter Crew Members Assn., P.O. Box 4888, Huachuca City, AZ. 85616

The 145th C.A.B.V.A. will be making a \$30 donation to the Viet Nam Helicopter Crew Members Assn. in remembrance of George Harold "Pops" Ecker so that the work he started with them will continue and that he will be remembered. This is outlined in our By-laws, Article 15.

So long Pops, we'll be thinking of you till we meet again, rest in peace.

WATCHFIRE

In June of 87 I received a letter from Mrs Titus, mother of Karl W Titus, 68th AHC, KIA 2 Oct. 1970, the letter included articles about a Watchfire they had around Middletown, NY. (Watchfire is a Revolutionary War custom, revived to remember those who died in service to our country). Karl had shared a room with me and Bill Sheets for a few months before his helicopter crashed. When I read the article I made a commitment to myself to have a Watchfire here this year.

The 1987 Watchfire in New York was lit at 2400 hrs (mid-night) on Friday night on Memorial Day Weekend for 24 hours till 2400 (mid--night) on Saturday night. Following the same tradition the 1988 Northeastern Indiana Watchfire was lit at 2400 Hrs on May 27, 1988, and the bonfire burned until 2400 Hrs May 28th. There was about 130 Veterans and family members at the lighting any about 50 at the closing ceremony. The 1987 New York Watchfire was for Vietnam Veterans but the 1988 NE Ind. Watchfire was expanded to include all Veterans and family members.

The site for the NE Ind. Watchfire was the National War Veterans Memorial Shrine of American History, Inc., a 40 acre site of partly wooded rolling country located 2 miles west of Fort Wayne, IN., belonging to all Veteran, (I'll report more on the Shrine later). The grounds officially opened for Watchfire at 6 PM on the 27th of May, with the Colors being posted at 8 PM. A stage and sound system were set up for Watchfire and a DJ was on hand till 11:30 PM on the 27th. At 11:30 we started the Memorial service led by an in-country Vietnam Veteran Minister with the fire being lit at 2400 Hrs, in the name of all Veterans, then reading a list of names of people to be remembered turned in by people attending the service, as the fire grew larger. Most of those attending were Vietnam Vets, about 10 Korean War Vets and about 15 WWII Vets. We even had 9 WWI Veteran come out Saturday afternoon from the VA Medical Center here in Fort Wayne. There was an estimated hundred or so people stop by on Saturday afternoon to visit and show support for what we were doing.

Saturday afternoon a few of us tried to put into words what the Watchfire meant to us and why we were there, what we came up with was that the moment of silence before the Indy race and the Veterans Day parade with all the High School Bands just didn't seem to be enough to honor those who died in service to our country. One vet seemed to sum it up pretty well for us Saturday night, he had worked all day Saturday till about 7 PM, arrived home in time to watch his 4 year daughter while his wife went to work, he turned on the TV just in time for the 8 PM news brief about Watchfire, he said when he heard about it he had to be with us.

About 10:30 Saturday night one of the guys wanted to know if we could do something more than just say a few words than put the fire out, what we did was, each person there that wanted to, put a shovel of dirt on the fire in memory of those they remembered. Some just put the shovel of dirt on, some spoke of those they remembered, some couldn't find the word to express their feelings, some you could see the hurt and anger coming out after all these years. There wasn't a dry eye there. About 15 minutes before midnight we lit 6 torches from the embers of the main fire, one for each of the branches of the service and one for the Lady veterans. The torches burned out during the services at midnight.

There were about 6 others who had spent many hours with me getting the site ready for Watchfire and many others helped with the planning. We all made some very close friendships which is continuing. And there are many more who found out about Watchfire just before it happened and are now working to help improve the site for next year. Next year we estimate about 4 times as many people will attend and the idea of Watchfire will continue to grow. All the local TV and newspaper media gave us some very positive press.

There were two other Watchfires that were spin off from this Watchfire, one in Marion Ind. and one around Lexington KY., some people there heard about what we had planned, and planned one for their area. And after being involved with the Watchfire here I would love to see them in every part of the country next year. If any of you would like more information about organizing a Watchfire in your area please let me know.

Colonel Horst K. Joost

Colonel Horst K. Joost was in-country as Executive Officer of the 173d Airborne Brigade in 1965 being supported by the 145th Combat Aviation Battalion. On the death of LTC Honour, he assumed command of the 145th on 20 Feb. 1966.

Col. Joost retired in Tampa, Florida after serving 31 years which began 1937 with his enlistment at age 15. He served in every rank (except WO) in both enlisted and officer category. He is a member of the Infantry Hall of Fame, and served for many years in airborne. In the early 1960's, he became FW and RW qualified and became involved in the early development of airmobile doctrine and techniques.

Following his retirement, he pursued advanced university degrees, having completed his undergraduate work while in the service and became a professor at the University of South Florida, Tampa.

Col. Joost is currently involved in the antiquarian book trade, specializing in early Americana. He and his wife of 40 years reside in Tampa. His son born at Fort Benning, is a professor at anthropology.

Although Col. Joost has a very busy schedule he is very interested in getting the history of our Battalion put together. It's people like Col. Joost that will make and keep our association a very fine organization. Thank you Col. Joost.

NATIONAL WAR VETERANS MEMORIAL SHRINE

"NO VETERAN WILL EVER BE FORGOTTEN", this slogan began as a promise to The Almighty in the trenches of Marne, France in 1918 by the late Mr. Eric Scott, a six-star combat veteran of the Sixth Engineers, Third Infantry Division, U S Army. During a night which saw many of his buddies killed in action, Eric made a pledge that if he were spared he would build a shrine dedicated to all veterans.

The years passed quickly after the end of WWI, WWII ended and Eric still missed his buddies from WWI. He started making plans to someday try to locate his old friends and make good on his pledge. In 1952 Eric was finally able to arrange a Battalion reunion for his WWI buddies and another reunion in 1953. By 1954 Eric had built a large room 80x30 onto the back of his house for holding reunions to keep the cost down. As time went on it became a Regimental reunion. At each reunion more and more War Relics were brought, it was at this point that the Scotts made the decision to make the room a permanent Memorial to all Veteran. Thus, the National War Veterans Memorial Shrine of American History was created.

In 1973 the Shrine became totally tax exempt as a non-profit corporation. The Portico of the Memorial Chapel was built by Eric and dedicated by Indiana's Governor Otis R. Bowen, MD., on July 31, 1976. Eric dream was to build the rest of the Memorial Chapel, which was not to be in his life time.

Eric Scott died 13 August 1981, at the age of 82, his wife Cleo died last September, they died before seeing their dream completed. Between the time Eric made his pledge until the death of the Scotts, Eric and his wife earned many awards for their dedicated service to veterans.

With their passing the Scotts left everything they had to the Shrine, through the Board of Directors, for all Veterans to use. Along with the house, Museum and the start of the Chapel there is 40 acres of ground. The Board of Directors of the Shrine, of which I am a member, have made a commitment to continue the dreams that the Scotts worked so many years to complete but time ran out for them. May they rest in peace knowing that the dreams they had, will be completed and the ideals of the Shrine will continue.

When you read the article about "Watchfire" keep in mind the history of the National War Veterans Memorial Shrine of American History, I think that you will agree that I couldn't have found a better place to hold Watchfire to honor the memory of all who have died in service to our country.

The Shrine is funded only through donations and associate memberships, no government money is accepted, associate memberships are five dollars a year. If any of you would like an associate membership or would like to make a donation you can send them to me, make checks payable to: Veterans Memorial Shrine (the full name doesn't fit on a check very well). The work I do at the Shrine and the donations I make are in memory of those served with the units associated with the 145th, some day I would like to see a complete Memorial List from the 145th along the Battalion History on display at the museum.

The Shrine belongs to all of us.
