

(EDITORIAL NOTE) Thank you Lee for your support and the historical information, you will find the 93rd Trans. Co./ 121st Avn. Co. early unit history printed in the Bn History section of this newsletter. I added the three names, Cpt Donald B Toth, 1Lt Lewis L Stone, and 1Lt Charles M Fitts to our Memorial List. The report also says one other member was Killed In Action on 2 January 1963 but does not give a name. If anyone has the name please send it to me, I have Sgt William Leander Deal who served with the UTT that was Killed In Action on 2 January 1963. Along with the historical report was a picture and description of the unofficial unit crest for the 121st Avn Co. The crest was made of cheap metal with two back clips. Measuring 1 1/4" by 1 1/4" in size. Shield was black enamel, border was red & tiger was yellow with a red tongue. 121 Avn Co was always in red with the senior Army aviator wings & scroll in siver. The lightning bolt on tigers neck, depending on flight platoon this was colored Red, White, or Blue. This emblem appeared on the tail of each CH-21 and was found embroider on the side of the ball caps worn by unit members. I think for making up the T-shirt design for the entire unit I'll make the lightning bolt all three colors, Red, White, and Blue, 1/3 each color.

November 2, 1989, Dear Jim: I have enjoyed receiving your newsletters and commend you and Debbie for making the effort to pull the association together. In the past I too have tried to kindle the embers of groups that should have associated and fully recognize the time and effort this requires. Congratulations and thank you for doing a great job.

I was attached to the 187th Assult Helicopter Company in Tay Ninh from 1969 until they were reassigned to Dian, near Saigon in 1971. I was NCOIC of the medical detachment (541st Med Det CA) which supported the entire Tay Nihn base camp after the MAST Hospital was closed following the rotation of the 25th Infantry Division and likewise at Dian where I believe the 118th and or 134th were located 1971-1972. Within the next few days I will be returning to Vietnam to survey the locations and set up for the filming in mid 1990 of a documentary entitled "The Reunion, Those Who Served". The concept for this project was born on the day of the big battle scene during the filming of The Iron Triangle on which I served as the technical advisor. Something happened to methat day as I was laying in the rice patty in uniform directing the helicopters and some of the action. I realized there and then that I wanted to, needed to find and see again, those good friends of mine that I had somehow lost after coming home. The reunion is about all of us who served, and came home only to try and forget an unpopular segment of our life. I am proud to be an American who served in Vietnam, and while I would question it today, I did my duty and for that I am proud.



My memory has been destroyed by cortisone given to me for lung ailments caused by ingesting too much JP4 while topping off tanks as a crewman. I have also been force fed thorazine, mellaril, anti-depressants for memtal problems in VA Hospitals. I also handled defoliants during my first tour in Vietnam with the 173rd Airborne. T want to ask other members a question, who in the 68th, 334th, and the 118th and the other companies I gunned for remember me. I suffered a 6 month bout of amnesia, I blacked out in the 173rd and came to muself while in the 68th Assault Co. My nick name was "Airborne dog". I remember a few names like SFC Broome, "The Grim Sweeper", ship number I OJT'd on - Top Tiger 23A and that we either crashed or were shot down somewhere. Also remember Duc Hoa rescue mission. Whoever remembers me please write. I was awarded basic Air Medal but never received subsequent awards - was put in for Bronze medal for delivering ammo & rockets under fire while under enemy rocket and motar attack Tet 1968, never received it. Please print this warning to members: Beware of blaming disabling ailments on Agent Orange etc, look into problems caused by ingesting helicopter fuel please, Tolvene isocyanates - same as in Bhopal, India. Also beware of taking leva-dopa anti-parkinsonian agent for depression - it can really finish screwing you up. M. Fisher, P.S. Membership dues inclosed.

It took about two or three hours to get away from Hatch as that is where we drove on to report the accident to the High Way Patrol. If I had set down when I got home to write this would have been longer. While at Angel Fire I looked through photo and a directory of KIAs and picked up some names of Vietnam Army Aviation personnel. (EDITORIAL NOTE) Thank you Bob for joining and we won't forget about the 74th. The information I have is the 74th Avn Co, later redesignated 74th Recommaissance Airplane Company was activated on 26 March 1965. The company was formed from the assets of the 1st, 13th, 14th, 52nd, and 145th Aviation Platoons (FW) (Prov). The 74th RAC had the 563rd Trans Det and 320th Signal Det assigned to it. During the course of any day, the ALOFT pilots covered the complete III Corps Tactical Area rendering invaluable reconnaissance, adjusting artillery, providing convoy cover, and radio relay for ground units engaged against the Viet Cong. In January 1968 the 74th was reassigned to the 210th CAB until July 1971, then assigned to the 11th CAB until they departed Vietnam on 20 March 1972. James E Sparenburg, has volunteered to be the 74th RAC unit historian, you might want to contact him about helping to put together a 74th RAC history report for the newsletter.

Dear James: Thank you for the January issue of the Newsletter. As always, it seems to get better and better with each issue. As you recall from our previous correspondence, I am the first commander of the 145th and was privileged to command it for the first six months or so of its life, before passing it on. I am also the last commander of the 45th TC Bn, from whence the men, officers and equipment came, when the 145th was formed. I also was saddened to be present at the inactivation of the 145th at Ft Stewart, GA. 30 September 1982. If anyone has copies of the Army Aviation Magazine for 1963, there is quite a bit of information on the 145th and its associated units in my periodic VIETNAM REPORTS. Lots of units, names and places. In late 1963, I approved the first pocket patch for the 145th. It was a V design, red, with white borders. Superimposed were the numbers "145" with a wing, of blue and white, coming out of each side. I only have one left, but shall try to get a copy for you at the first opportunities. Some of the 1st shift members (1963) will remember. The 145th commanded all helicopter units in Vietnam including UTT, except for the 57th Med Air Ambulance. Later we broke out the 52nd Combat Aviation Battalion in the Highlands and the Delta Combat Aviation Battalion in the Delta. More for your next issue. Keep up the good work.

Good luck. Hi to all the old gang that might remember me. We had a great outfit in 63 and I know the 145th held that reputation throughout its life time, short as it was. The pocket patch was designed with pilot wings on an anchor, above the anchor are the letters U.S.A. R.A.N., below the anchor are the letters EMU, sorrounding this is the olympic wreath, below that it said "GET THE BLOODY JOB DONE". I sent William Murphey a copy of the history from the yearbook referred to in Mark Bryant and sent Michael Hickman and Paul Petrie a copy of the last newsletter. Thank you Bill, please read on for another letter about the 135th.

Dear Jim and Deb: In your Jan. newsletter I received the Pink Slip. Thanks for reminding me that I'm a little late on my dues. So I'm sending you last years and this years dues and I appreciate that it didn't hurt. I also took interest in your letter from J.L. Baratz. He was the First Shirt for the 135th at that time. Olello Sarge) We departed as a unit from Grey Army Airfield at Fort Hood, Texas, Sept 67. From what I can remember our call sign was the Texas Rangers. We entered and were TEMP station at Vung Tau then relocated to Black Horse, the 11th CAV Compound at Xuan Loc. The Australians we merged with was an element of the Royal Australian Navy. I'm sorry I can't remember which unit. The EMU was the revised call sign and it was that bird we were nick named after. But until your newsletter I didn't know that E.M.U. was derived from Experimental Military Unit. I was the youngest man in the company up until my tour was over. I turned 18 about 2 or 3 weeks before we departed to Vietnam. I was a Mach., door gunner, then Crew Chei'. I'm very proud of being part of that history. Because of America's dissatisfaction of it all, and the memories of the fallen or missing, I tend to want to separate myself from it.

I want to thank you, and Deb, and everyone involved with the 145th. Thank all of you for putting together a very possitive mission for the 145th. I'm looking forward in growing with the Association, and learning more about Our Heritage. Little Man, Theodore A Nazaroff

P.S. Jim, I looked thru what I still have and I ran copies of them. I hope you can benifit from them. The photo was taken of the logo on the nose of the company Command ship. Most of the slicks had a side profile of an orange colored silhouette of the Emu. The patch is a second print (Vietnamese version) made in Vung Tau 1967, 1st company issue after the merge with the Aussie. Orginally we had some made in Texas and with a Texas & American flag. I would love to have or see a copy of that patch (never issued). About the museum, go for it.

(EDITORIAL NOTE) Along with the letter was a color photocopy of the patch described above and a color photocopy of the picture of the C&C nose cover. I would love to be able to make color photocopies of the quality he sent. I will enter the info from the orders he sent into the Help Find file. It is my guess that the copy of the pocket patch he sent was of the first one used in Vietnam and the pocket patch described earlier was the second design used by the 135th, would some of the other members of the 135th help me out with info. I would like to make unit T-shirts with these designs. The pink slip he referred to at the beginning of his letter was suppost to be a red paper, but Deb picked up the wrong color when she got paper. The idea behind it is to get people's attention that their dues are do. I wouldn't send out pink slips, I use to be a flight simulator instructor at Rucker and people always disliked it when I gave out pink slips. The pilots will know what I mean. And I would like to say that when I went to Vietnam, I did what I thought was right, that's all that counts, I'm a Vietnam Veteran, and very proud of it.



BATTALION HISTORY 93rd Trans / 121st AHC Early History

On 15 December 1961, the 93rd Transportation Company departed from Quonset Point, Rhode Island, aboard the U.S.S Carr for their long voyage from their deep rooted homes at Fort Devens, Massachusetts, to a new challenge in the Republic of South Viet Nam. After arriving at Subic Bay, Philippines Islands, the company transferred their men and equipment aboard the U.S.S Princeton and continued to Da Nang, Viet Nam, arriving on 25 January 1962. On 1 February 1962, only six days later, the 93rd Transportation Company was operational and began their dangerous flying mission in Viet Nam.

The 93rd Transportation Company readily accepted their new challenging tactical mission of providing air transportation for combat troops of the Republic of South Viet Nam to expedite the tactical operations and logistical support in the forward areas of the combat zones. This also includes transportation of troops, equipment and supplies into inaccessible areas and evacuation of combat casualties.

The CH-21 Army helicopters rapidly became "the pack horses of the Viet Namese mountains and jungles" flying dangerous supply routes that a few months earlier took land parties week to negotiate. Soon the helicopters crews were much at home shuffling equipment across the mountains. Loads varied from howitzers attached to slings riding below the ships to disassembled parts of two bull dozers which were flown to a U.S. Army Special Forces outpost to build an airstrip.

On 27 June 1962, General Hightower selected the 93rd Transportation Company and attached units as the most outstanding company visited in the Republic of South Viet Nam. General Hightower visited a majority of the organizations in Viet Nam but chose an aviation unit, the 93rd Transportation Company as the most outstanding.

On 2 August 1962, the 93rd Transportation Company conducted the first large scale heliborne operation ever conducted in the I Corps Tactical Zone which consisted of a two company raid on the Viet Cong 5th Region Headquarters in th Do XA area. The participation of the 93rd Transportation Company permitted the rapid capture of the Viet Cong radio station and caused heavy casualties to be inflected upon the enemy.

On 30 August 1962, the 93rd Transportation Company participated in Operation "Lam Son II" another air-mobile combat assault against a hard-core Viet Cong Battalion deep in the jungles of Quang Ngai Province, complimented by 10 CH-34 helicopters of the 1st Helicopter Squadron VNAF, a heavy ground fog covered the landing zone preventing the first lift until two hours after the pre-strike, instead of immediately after the strike as planned. Despite encountering heavy fire from the alerted and prepared Viet Cong the loss of two CH-21 helicopters to enemy ground fire and the wounding of four crew members, the 93rd Transportation Company successfully completed two air lifts into the heavily enemy infested landing zone. Of the twelve helicopters from the 93rd Transportation Company, nine were hit and damaged by enemy fire and two shot down. Six persons were killed and five wounded in helicopters during "Lam Son II". All objectives were taken, 40 Viet Cong guerrillas were killed, six prisoners were taken, many enemy supplies including an ammunition dump were destroyed and valuable intelligence documents were seized. The psychological effect of this successful raid deep within enemy held territory was immeasurable.

On 12 September 1962, the advance party departed Da Nang on a classified mission to relocate the 93rd Transportation Company. On 19 September 1962 the 1st Marine Aircraft Wing of Soc Trang and the 93rd Transportation Company of Da Nang exchanged locations, the 93rd saying farewell to the mountains and jungle thus moving to their present location at Soc Trang Airfield in the flat Mekong River Delta. Air lifting the company to Soc Trang required transporting 47 loads; 855,299 pounds of cargo; 196,142.2 cargo-ton miles; 53,068 passenger miles and 96 hours of flight time. On 23 September 1962, the first operational mission in the Delta area was flown.

On 17 December 1962, orders were received assigning the 18th Aviation Operating Detachment from Okinawa to Soc Trang per General Order 45, USASG, effective 5 December 1962. The 18th A.O.D. has the mission of facilitating all Army flight operations by providing flight information planning data, coordination of day, night and instrument flights, navigational aids, and Air traffic control for the aviation unit to whom it is attached. The 18th A.O.D. is

established with 39 Enlisted Men and 5 officers to provide it services for handling a daily air traffic count of 50. At Soc Trang, the 18th A.O.D. normally handles as aircraft count of 103 daily.

In December the 93rd Transportation Company established another mile-stone and record by

flying 1,017.2 hours in a single month in the Republic of South Viet Nam.

AP BAC - 2 January 1963, on 2 January 1963 the 93rd Transportation Company started the new year on a tragic note. While supporting the 7th Infantry ARVN Division from a staging area located at a small dirt strip at Tan Hiep, the entire flight of the CH-21, U.S. Army helicopters from the 93rd Transportation Company was ambushed by an entrenched hard-core Viet Cong reinforced Battalion on the fourth assault rifle lift committing the reserve forces. In the final stage of the approach from contour level, heavy machine gum and automatic rifle fire was received. Without regard for personal safety, the ten helicopters proceeded past the armored personnel carriers and the main advancing body to land their troops in the designated landing zone. Not one helicopter aborted or failed to complete its mission of getting the troops into the landing zone.

Although hit by ground fire the first four aircraft were able to make successful take-offs from the area. The fifth aircraft, however, was shot down due to heavy ground fire. The crew of the sixth helicopter unhesitatingly diverted their take-off and attempted to pick up the crew of the downed aircraft and were immediately shot down also. The landing zone was untenable due to enemy fire which prevented further rescue attempts. The remainder of the flight departed for the staging area although the second aircraft had to make a force landing due to damage from the ground fire received. The downed crews were left to fend for themselves in the rice paddies ahead of the main attacking force, where they remained under enemy fire for the next eight hours. One man was dead and five had been wounded by enemy fire.

Upon return to the staging area, assessment of damage to the seven remaining helicopters revealed only two were flyable. Approximately one hour later information was received from ground troops in the area that firing had subsided and evacuation of the downed crews could be made. The rescue aircraft was landed despite sporadic ground fire and damage to the aircraft. When the loading of the wounded and crews was attempted, the tempo of enemy fire increased and a heavy volume of fire entered the cockpit wounding the pilot. This forced the aircraft to make an immediate take-off leaving the wounded and crews behind. The aircraft was flown out of the landing zone, but 1/2 mile away a forced landing had to be made due to damage from enemy fire. Meanwhile, at the staging area, two other helicopters had been rapidly repaired from parts of other downed aircraft. For the remaining hours of the afternoon, ammunition and medical evacuations were flown by these ships into the first three landing zones.

Approximately eight hours from the time they were shot down, the crews and their wounded were finally picked up by ARVN armored personnel carriers. Then they had to ride for approximately two hours through attacks with the armored personnel carriers until an area was reached where they could be evacuated by helicopter.

At the days end, nine Americans had been wounded and one killed in action. Of the ten helicopters committed on the mission, all ten had been hit by enemy fire, four had been shot down and only three helicopters were flyable to return to the airfield.

On 3 and 4 January maintenance personnel from the 93rd Transportation Company flew to the downed aircraft and with disregard for their personal safety and only concern for their equipment and the ultimate recovery of the downed aircraft, they went into the areas for two days under hostile fire, remaining there to effect repairs.

The heroism, esprite-de-corps and comradish displayed throughout the entire action upholds the common knowledge of the spirit the officers and men to the 93rd Transportation Company have as being perhaps among the best if not the best in the Army.

On 10 January 1963, the 93rd Transportation Company suffered another air tragedy when a CH-21 helicopter from the 57th Transportation Company enroute from Soc Trang to Saigon crashed with Three 93rd officers riding as passengers. All seven persons aboard the aircraft were killed. The three officers from the 93rd Transportation Company were Captain Donald B. Toth, 1st Lt Lewis L. Stone and 1st Lt Charles M. Fitts.

On the brighter side in January the unit received a playful 9 month Bengal tiger mascot named "Tuffy" from MAAG Laos. After his arrival, Tuffy was showered with attention and affection

from Privates to Generals, Tuffy was good natured, playful and usually harmless. For many in the company a scratch or scar from Tuffy was a treasured memory never to be forgotten. Tuffy's diet was not that of a normal tiger. His favorite dishes included weiners, steaks, meat balls, and spaghetti. In the cool of the evening, Tuffy always took his daily swim in his own private swimming pool. Thus with a playful Bengal tiger as company mascot, the members of the 93rd Transportation Company soon became widely known as the Soc Trang Flying Tigers.

On 4 March 1963, Major Edward C. Seymour, the present commander, assumed command of the 93rd Transportation Company relieving Major Paul E. Ewing who was reassigned to the 45th

Transportation Battalion at Ton Son Mhut.

On 27 March 1963, the first Machine Gun Platoon, of 1 officer and 20 Enlisted men, arrived for 90 days TDY from the 25th Infantry Division in Hawaii for duty as gunners on the CH-21 helicopters of the 93rd Transportation Company.

On 25 June 1963, the 93rd Transportation Company was redesignated as the 121st Aviation

Company (Air Mobile Light) retaining their men, equipment, location and history.

Also in June, Tuffy, the Soc Trang tiger mascot weighing over 250 pounds and 15 months old, departed the 121st Aviation Company for the Toledo Ohio Zoo. Tuffy no longer will have his own private pool but will also suffer a reduction in rank from Number 1 Top Tiger of the 121st Aviation Company to Number 6 Bengal Tiger of the Toledo Zoo.

In July, the 121st Aviation Company topped their previous record flying time by having a

busy flying month totaling 1,064 hours.

On 23 August 1963, the 121st Aviation Company again established another record by having the largest Decorations and Awards Presentations Ceremony in the history of Viet Nam by decorating forty-four (44) individuals (almost 1/4 of the company). Lieutenant Colonel Wayne N. Phillips, Commanding Officer of the Delta Aviation Battalion and Major Edward C. Seymour, Commander of the 121st Aviation Company presented on the date, three (3) Distinguished Flying Cross, one (1) Bronze Star with Valor, thirty-seven (37) Air medals and fifty-four (54) Dak Leaf Clusters to the Air medal, and 14 Purple hearts.

In August the 121st Aviation Company again topped the 1000 hour a month mark by flying 1.019.1 hours.

"In appreciation of the outstanding service and support rendered the 2nd Infantry Division (ARVN) during the conduct of combat operations", reads the inscription on one of the more important unit citations of the many awarded this company during the period they have been in Viet Nam "for outstanding continuous service and support in combat".

During the short period of time the 121st Aviation Company has been in Viet Nam, it has established many milestones and records to include having flown 14,243.8 hours, completed 20,201 sorties, hauled 14,968,952 pounds of cargo, transported 66, 781 passengers and evacuated 1,439 medical casualties.

As evidence throughout the history stated above, the accomplishments, milestones and records in addition to being the MOST decorated unit in Viet Nam, one can readily see why the men claim with honor, prompt and pride, the 121st Aviation Company, Home of the Soc Trang Tigers.

SOC TRANG by Carl E Bartecchi, M.D.

Right after writing this Historical Report about the 93rd Trans Co / 121st AHC, I received a letter, book, and membership dues from Carl E Bartecchi who served with the 41st Med Det of the 121st AHC in 1965 and 66. WATCHFIRE 1990

I would like to announce to all those living within easy driving distance of Fort Wayne, IN, the plans for the 1990 Watchfire here in Fort Wayne. And I invite you to join us.

I first heard of Watchfire from the mother of Karl William Titus, Killed In Action 2 Oct 1970 with the 68th AHC, my room mate. I decided that I would make sure that there would be a Watchfire here every Memorial Day Weekend. This will be the 3rd Annual Watchfire here in Fort Wayne. The Watchfire that Mrs Virginia Titus sent me newspaper clipping about told how a group of Vietnam Veterans in New York State spent their Memorial Day Weekend, remembering those killed in Vietnam with a 24 hour memorial service. Many of us here in Indiana, Ohio, and Michigan have used their idea and use Watchfire as a 24 hour memorial service to remember Veterans from all the American Wars. The idea of Watchfire was taken from the old military custom (dating back to the days the Bible was written) to light a fire to guide ones comrades back safely from battle. The Watchfire burns for 24 hrs.

The first year there was about 100 people attending. Last year we had about 450 people come out to participate. This year we expect many more Veterans and other patriotic people willing to take the time to honor and remember our departed and missing Veterans. The Watchfire here is held at the Veterans National Memorial Shrine, 2122 D'Day Rd, Ft Wayne, IN. Its located 3 miles west of I-69, 2 miles south of US 30. Here is the schedule:

BACK PAY 0ct 72 - Jan 73

When reading the Army Otter-Caribou Crew Association newsletter and came across this article I thought might be of interest to some of you:

VETERANS, MILITARY PERSONNEL, DUE BACK PAY The federal government has been ordered by a United States Court to pay a salary differential of approximately 6.14 percent to all military personnel and veterans who served on active duty between 1 Oct 1972 and 1 Jan 1973.

Military personnel still on active duty will receive the differential automatically, while veterans whose active duty ended some time after 1 Oct 1972 will have to apply for the pay. To make a back pay claim, veterans need to write a short letter to their branch of service. They should include their: Social Security number, "military service number if assigned, rank, current mailing address, date of separation from the service, and duty station between 1 Oct 1972 and 1 Jan 1973.

Army personnel should send this information to: Commanding General, U.S. Army Finance Support Agency, ATTN: FINCS-A, Indianapolis, IN. 46249 (Source: DLA Memphis Bulletin No. 3, 18 Jan 1990).

After reading the article in the Army Otter-Caribou Crew Association newsletter, I got out my old military records and found my pay records. I computed my pay differential and it came out to \$75.90, that's for a E5 just under 4 years in service figuring base pay only. So for that amount I think I will send them a letter with the required information, I think I will also include a copy of my Leave and Earnings Statements for those months. Maybe I will even receive the money, I'm always suspicious when I hear that the government has a gift for me. But for a 25 cent stamp I am going to give it a try. If you were on active duty at that time go ahead and send in for your pay differential.

H.R. 3037 UPDATE

United States Congress, House Resolution 3037, budget authority approved for \$7 million for fiscal year 1991, Passage of Bill is next. So far we have got the money now we need to get H.R. 3037 passed. Congressman Jim Jontz and Congresswoman Jill Long (both serve on the Veterans Affairs Committee and are from NE Indiana) worked with a group us Vietnam Veterans from NE Ind and wrote H.R. 3037 for us. Now I need for you to write your Congressman and Senators and ask if they will support H.R. 3037, The Veterans PTSD Treatment and Psychological Readjustment Act. In summary H.R. 3037 would: *expand inpatient treatment for Post-Traumatic Stress Disorder (PTSD) by adding 30

*expand inpatient treatment for Post-Traumatic Stress Disorder (PISD) by adding 30 additional PTSD units within V.A. medical facilities over the next 5 years; *expand outpatient treatment for PTSD by adding 40 additional Vet Centers over the next 5 years; *establish a stable funding base for the contract PTSD counseling program, which serves veterans in rural communities; *encourage the recruitment of qualified PTSD specialists by including them in the Health Professionals Educational Assistance Program, which provides scholarships for graduate study in return for service in the V.A. medical system; *provide statutory authorization for the V.A.'s Advisory Committee on Readjustment of Veterans; *create a PTSD treatment research program; *establish a pilot halfway house program for veterans with PTSD.


I hope that you will find the time to support H.R. 3037. At one time I didn't believe in PTSD, there was just a few things wrong in my life, and even a couple of divorces didn't fix it. Well back in 1984 a Vet Center here in Fort Wayne helped some of it, I was lucky. I would say that there is no cure for PTSD but with some training and insight PTSD can be used to make life much more productive. Some would say that only a crazy Vet would try to put our Association together and I believe that my PTSD gives me the strength and energy to do what I do for our Association. I ask that you try to find it in your heart to be able to support H.R. 3037, the life we save may have been our best friend in Vietnam. Lets give them a chance, write in favor of H.R. 3037, today.





