Dear Mr. Reed:

This is in reply to your letter regarding ORLLS from the 3rd Brigade, 25th Infantry Division, and the 1/35th Infantry and the 2/35th Infantry for the period June and July 1966.

We searched the records of the United States Forces in Southeast Asia, 1950-1975 (RG 472) but were unable to locate an ORLL from either the 3rd Brigade, 25th Infantry Division or the 4th Infantry Division for the time period you requested. Additionally, we do not generally have ORLLS from individual battalions like the 1/35th and the 2/35th.

Copies of "Operational Reports - Lessons Learned" for the 4th Infantry Division, however, should also be available from the National Technical Information Service (NTIS), 5285 Port Royal Road, Springfield, VA 22161. These reports are accessed by the NTIS "AD" number. To obtain this "AD" number, you should write to the U.S. Armed Services Center for Research of Unit Records (USASCRUR), 7798 Cissna Road, Suite 101, Springfield, VA 22150-3197. Their telephone number is (703) 806-7835. They will provide you with the "AD" number of the ORLL or ORLL's pertinent to your inquiry. With this information, you may then order the specific document or documents directly from the NTIS.

With regard to the daily journals you sent, we went and checked the records and found that we are missing the last pages from 3 June 1967 and the page 6 you sent to us is actually from the 15 June 1967. We are not quite sure what happened in the copying process, but unfortunately we do not have the last pages from 3 June.

Dear Mr. Anderson:

This is in reply to your letter regarding the 2/35th Infantry between 1966 and 1969.

We searched the records of the United States Forces in Southeast Asia, 1950-1975 (RG 472) and located daily journals for February 1968, March 1, and 4-11, 1968. We have enclosed a price quote for these records. If you wish to order these records by check or money order (payable to "NATF-NWCTM"), send it with the enclosed order form to the National Archives Trust Fund Board, P.O. Box 100793, Atlanta, GA 30384. If you wish to pay by using a MasterCard, VISA, Discover, Bravo, Private Issue, or American Express credit card, you should return the enclosed NATF Form 72 (annotated with type of credit card, account number, expiration date, and your signature) to the National Archives Trust Fund, Cashier (NAT), 8601 Adelphi Road, College Park, MD. 20740-6001. Your account will be verified before copies are shipped. Please allow 10-12 weeks for delivery of your order.

Additionally, we located daily journals from March through May 1967 (approximately 400 pages), August through November 1967 (approximately 2500 pages) June 1968 (approximately 100 pages) and October through November 1968 (approximately 800 pages). Due to the large number of pages we did not include these records in your price quote. If you would like to narrow down your request or come and look at the records yourself, we will be happy to assist you. The Modern Military Reference Branch (NWCTM) is located at 8601 Adelphi Road, College Park, MD, near the University of Maryland--College Park campus. Research room hours are 8:45 a.m. to 5:00 p.m. on Monday and Wednesday; 8:45 a.m. to 9:00 p.m. on Tuesday, Thursday, and Friday; and 8:45 a.m. to 4:30 p.m. on Saturday, except legal holidays. Please call (301) 713-7250 before 3:30 p.m. Monday through Friday to request records for evening hours (after 5:00 p.m.) and Saturdays. We were unable to locate daily journals for the 1966 or 1969 dates you requested.

In the future, please limit your request to 8 separate dates or fewer.






