The attached table sets forth the record to date of obligations and expenditures against PRO/AG amounts in the Counterinsurgency Master Project. The amounts given are accurate as of September 30; the figures for October should be submitted by the DGBFA between the 10th and 15th of November.

As you know, obligations within each sub-project are maintained against activities. These activities are listed in the second column of the table. The third column contains amounts in the Sub-Project agreements. The fourth column includes both actual expenditures and releases by DGBFA to the Provinces. For example, the total amount obligated for the Phu Yen sub-project is recorded as having been released to the Province Chief by DGBFA. Actual expenditures in the Provinces are not available.
