The attached EGL memo is for the background information of you and Rufe. As of October 16 EGL has not received a reply. The memo has not been discussed by us with anyone else.

Also enclosed is a copy of an EGL to Connell letter re you and Rufe accompanying H cubed.

[] has been in Saigon about a week and has made an absolute ass of herself with us. She couldn't have picked a worse time to arrive. EGL has not seen her (though she came uninvited to Cong Ly three times yesterday), and is not going to see her. I personally consider her to be an enemy of ours (not due to intent but because of her personality, ambition, personal frustration, nosiness and flagrant pushiness) and to be treated as such i. e., totally ignored. I talked to her briefly since she said Rufe had told her to see me.

As of today everything is up in the air but I expect the picture will be clearer by the time you receive this note.

I might say I am very happy about the attached EGL memo; to me it states quite clearly the essence of the problem and the essence of EGL's true ability -- helping develop leaders who believe in the right things and act in the right way at the right time to translate these beliefs into effective action.
