Dear Lt Col Cecil

Thank you for participating in the Air Force Health Study. Your current dioxin body burden is 7.00 parts per trillion (ppt). There is currently no known relationship between health and dioxin body burdens of this magnitude. Dioxin levels in persons not occupationally exposed to dioxin are generally less than 10 ppt. A part per trillion is equivalent to one second in 32,000 years.

To date, serum specimens of 932 Ranch Hands and 888 Comparisons have been assayed for dioxin by the Centers for Disease Control. The Ranch Hand dioxin results ranged from 0 to 617.7 ppt; the Comparison results ranged from 0 to 54.8 ppt. The five highest Ranch Hand values were 257.6, 303.0, 313.0, 544.7 and 617.7 ppt. The five highest Comparison values were 18.5, 21.3, 26.3, 26.6 and 54.8 ppt. One half of the Comparisons and 10.7% of the Ranch Hands had values below 4.2 ppt.

The report of the 1987 physical examination was released by the USAF Surgeon General on 23 February 1990. Attached to this letter is a copy of the executive summary as well as an abstract of the findings and conclusions of the complete report. A longer summary (about 100 pages) that contains statistical descriptions of the findings is also available. Please remember that we are still very interested in pathology reports of any "lumps or bumps" that are surgically removed or otherwise treated.
