IN RESPONSE DEPTTEL 2084 PROPOSE TO TAKE FOLLOWING ACTIONS WITH
RESPECT TO BINH DINH CROP DESTRUCTION SCHEDULED BEGIN MARCH 26.
REFERENCES ARE TO TARGETS LISTED EMBTEL 3004. IN VIEW FACT IT
ALREADY PARTIALLY HARVESTED, NO. 7 WILL BE CANCELLED. NO. 5, TO
WHICH COMPARATIVELY POPULATED AREAS CONTIGUOUS, WILL ALSO BE
CANCELLED. WILL THEN BEGIN SPRAYING LEAST CONSPICUOUS AREAS

FIRST, STARTING WITH NOS. 1 AND 2 WHICH ARE MOST REMOTE, OVER
3-4 DAY PERIOD. WILL THEN RE-EVALUATE BEFORE PROCEEDING WITH NO.
3 OVER 3-4 DAY PERIOD. WILL THEN WAIT AS LONG AS POSSIBLE PRIOR
TO ANTICIPATED HARVEST BEFORE SPRAYING NO. 6 WOULD BE PREPARED
INTERRUPT SPRAYING AT ANY POINT, OF COURSE, IF ANY ADVERSE
REACTION OBSERVED. SPRAY PLANES WILL OPERATE FROM NHATRANG AND
QUI NHON. AGREE IT DESIRABLE AVOID PUBLICITY DURING OPERATIONS
AND WILL ATTEMPT TO TAKE ALL APPROPRIATE MEASURES TOWARD THAT
GOAL.

ALTHOUGH WE HAVE AT THIS TIME INSUFFICIENT EVIDENCE ON WHICH TO
BASE DETAILED EVALUATION OF CROP DESTRUCTION OPERATIONS, SECTOR
ADVISORS ARE TO SUBMIT TO MACV IN APRIL RESULTS OF SIX-MONTH
ANALYSIS OF ALL HERBICIDE OPERATIONS. THUS WE HOPE IN NEAR
FUTURE TO BE ABLE TO PROVIDE MORE DETAILED ANALYSIS THESE
OPERATIONS.

IN MEANTIME, WE OFFER FOLLOWING TENTATIVE CONCLUSIONS ON RESULTS
OF CROP DESTRUCTION OPERATIONS:

1. ALTHOUGH RURAL GROUPS HAVE FROM TIME TO TIME PROTESTED (OFTEN UNDER VC PRODDING) TO PROVINCIAL AND MILITARY AUTHORITIES AGAINST USE OF ARTILLERY AND AIRCRAFT IN OPERATIONS AGAINST CFN 1 2 3-4 3 3-4 6 NHATRANG QUI NHON MACV 1. VC

ENEMY, WE HAVE RECEIVED NO RPT NO REPORTS OF GRASS ROOTS PROTESTS AGAINST CROP DESTRUCTION OPERATIONS;

2. THERE HAS BEEN SOME MOVEMENT OF VC UNITS OUT OF VC-CONTROLLED AREAS AFTER CROPS DESTROYED, NOTABLY IN BINH THUAN PROVINCE, OCCASIONALLY TO ATTACK HAMLETS FOR SUPPLIES AND SOMETIMES TO BUY RICE IN HAMLETS;

3. WE HAVE SOME EVIDENCE OF FOOD SHORTAGE AS RESULT OPERATIONS CONDUCTED IN ZONE "D" AND IN I CORPS, AND LIBERATION RADIO LAST AUGUST BLAMED CROP DESTRUCTION OPERATIONS FOR SHORTFALLS IN VC AGRICULTURAL PRODUCTION IN WESTERN DELTA.

ALTHOUGH MISSION HAS MADE CONTINUING EFFORT DETERMINE WHETHER THERE HAS BEEN ANY STRONG INTERNAL PSYCHOLOGICAL REACTION TO CROP DESTRUCTION OPERATIONS, ON BASIS AVAILABLE INFO, WE BELIEVE THAT POPULATION REACTION TO OPS REMAINS AS DESCRIBED BY MACV-EMB TEAM IN ITS OWN EVALUATION OF HERBICIDE OPERATIONS DATED OCTOBER 10, 1963: "THERE IS NO EVIDENCE THAT INTERNALLY OR EXTERNALLY GENERATED COMMUNIST PROPAGANDA ON DEFOLIATION/ CROP DESTRUCTION OPERATIONS HAS HAD ANY REAL IMPACT ON THE VIETNAMESE POPULATION."

NOT PROPOSE TO MAKE OPERATIONS PUBLIC WHILE THEY ARE IN PROGRESS, IN ORDER FORESTALL SUBSEQUENT ADVERSE PRESS COMMENT BASED ON INSUFFICIENT OR INCORRECT INFORMATION, WOULD RECOMMEND LOW-KEY REFERENCE BE INCLUDED IN DAILY BRIEFING BY MISSION REP FOLLOWING COMPLETION OF OPERATIONS, MAKING FOLLOWING POINTS:

1. GVN HAS LONG HAD PROGRAM OF DENYING FOOD TO VC BY MANUAL CHOPPING, BURNING AND USE OF CHEMICALS. ON MARCH 20, 1963, THE DGI OFFICIALLY STATED THAT ONE OF PURPOSES OF GVN HERBICIDE PROGRAM WAS TO DENY FOOD TO ENEMY BY DESTROYING VC CROPS AND PREVENTING MOVEMENT OF VC FOOD SUPPLIES.

2. CHEMICALS USED ARE HARMLESS TO HUMANS, ANIMALS, SOIL AND WATER.

3. CHEMICAL CROP DESTRUCTION NORMALLY CARRIED OUT BY VIETNAMESE WITH HANDSPRAY OR SPRAYED FROM VNAF AIRCRAFT. IN VIEW LIMITED NUMBER OF VN PILOTS AVAILABLE FOR SUCH PURPOSES, AT REQUEST OF GVN AT TIMES SPRAYING NOW BEING DONE BY US PILOTS.

4. EXPECTED THAT SOME NON-VC POPULATION WILL BE PERMITTED, OR FORCED, BY VC TO LEAVE AREAS. GVN HAS PLANS AND EXPECTATION OF HANDLING THEM WITHIN PROGRAM ESTABLISHED FOR OTHER REFUGEES.
