I was on the Ranch only for a short while.

While training in C-123's at Hurlburt Field, Fla., the 81st Force "Volunteers" or directed that I be placed in ~~that~~ Ranch Hand with a couple other guys, one was Karl Marguerat, one was ~~Randy~~ ^{Roger} Custer.

After we got to V.A. ^{now} Ralph Dresser, the Commander of RH at the time informed us that it was a "Volunteer" outfit.

Karl Marguerat and I asked to get out since we had not volunteered.

Dresser let us out - we flew C-123 cargo planes the rest of the year too.

In the Ranch, I picked up 3 hits the 1st flight, and 2 more ~~the~~ ^{the} 2nd flight. After getting out - I only picked up 2 more hits during the tour.

My decision to get out was the best decision I ever made ~~otherwise~~, I would probably not be around to write this.

We were told the chemicals were safe for humans.
