MEMORANDUM FOR THE SECRETARY OF DEFENSE

The Air Force has sought guidance from the Interagency Work Group on the Possible Long-Term Health Effects of Phenoxy Herbicides and Contaminants on whether it should proceed with the Epidemiological Study of Ranch Hand Personnel because the National Academy of Sciences review of the Air Force protocol had expressed concern about the credibility of the Air Force to conduct the study.

Ranch Hand personnel, who applied Agent Orange between 1962 and 1971 in Vietnam, are the only population whose frequency and duration of exposure to Agent Orange are known with any accuracy. The Interagency Work Group agrees with the Air Force that the results of the Ranch Hand study should provide valuable information about the long-term health effects of exposure by veterans to Agent Orange in Vietnam.

Over the past 20 months, the Air Force has made a conscientious effort to design a scientifically valid study responsive to the recommendations of five separate peer reviews, including that of the National Academy of Sciences. After a thorough review of the proposed final study protocol, which includes certain changes based on the separate peer reviews, and after consultation with the Air Force scientists responsible for the study, the Work Group recommended to me that the Air Force be instructed to carry out the Ranch Hand study. In light of the progress already made by the Air Force and the need to proceed expeditiously with this important study, Frank Press and I concur with the Work Group's recommendation.

There remains deeply felt concern among some Vietnam veterans and others about the objectivity of the Air Force to study the possible health effects of Agent Orange. While affirming the capability of the Air Force to assure the proper conduct of the study, the Interagency Work Group has suggested that this concern can be reasonably addressed by independent review and monitoring of the study. I believe that the Scientific Panel of the Interagency Work Group, which is already familiar with the Ranch Hand protocol, is the appropriate body to oversee the study and to provide technical assistance, as needed, to the Air Force scientists responsible for the study. For the purpose of assuring the public that the study results are reliable and valid, the Work Group plans to augment the Scientific Panel with reputable scientists from outside the government, including those suggested by veterans organizations.

The Interagency Work Group noted that the evaluation of Ranch Hand personnel may have to continue for a lengthy period of time in order to have a better chance of detecting latent or subtle health effects, particularly related to cancer. The Air Force, in consultation with the Scientific Panel, has already designed the protocol to reflect this recommendation.

I am advised that the Ranch Hand study presents a number of difficult technical problems. While recognizing the need to obtain study results promptly, the Air Force's primary responsibility must be to assure that the results will be reliable and valid. I urge the Air Force to utilize fully the expertise of the Scientific Panel of the Interagency Work Group to advise them on the difficult decisions that will surely arise during the course of the study.

In closing, I would like to reaffirm the importance of the Ranch Hand study to Vietnam veterans and their families. The Interagency Work Group and the White House are prepared to offer any assistance that the Air Force may require in discharging its responsibility to conduct a high quality scientific investigation.

Since 1966 the Ranch Hand Vietnam Association has tried to keep in touch with as many veterans of "the Ranch" as possible. Over the years this number has dwindled but again we'd like you to know the Association is alive and well. Annually since 1967 we gather for a reunion in mid-October.

Many of you have undoubtedly read some of the recent press concerning "Agent Orange" - the defoliant 24D/245T sprayed in Vietnam. For the past couple of years readers have been bombarded with vast amounts of sensationalized writing on the subject, which for the most part is scientifically flawed, emotionalized and often riddled with inaccuracies. In addition, some individuals are claiming that their present medical problems are a result from contact with the defoliant while serving in Vietnam. For this reason and others, the United States Air Force is going to perform the study outlined in the above White House memo.

Each of us will be asked to volunteer again for one last mission for "the Ranch". This time, however, the mission will not be over the jungles of SEA but here at home. The Air Force will be asking many of us to take part in their study. For some this may mean travel, and some minor pain! The Association believes it is our duty to answer the call as we did more than a decade ago.

To date there is no valid scientific data to indicate that contact with the defoliant 24D/245T represented a health hazard or that it causes insomnia, sleepiness, increased sex drive, diminished sex drive, cancer, birth defects, etc. The emotional manner in which this subject has been treated in "journalistic circles" however, is in part responsible for the desirability of one "final" study.

The Association presently has \$1100 in the Eglin Federal Credit Union. Contributions are needed to pay for this and future newsletters. There were over 800 announcements sent in this mailing. Your support is appreciated. Please make checks payable to Ranch Hand Vietnam Association.

Many of you will be happy to know that "Patches", C123, 56-4362, has flown her last mission at the age of 23. Friday night included cocktails aboard a Greek sponge fishing boat while motoring down the Anclote River and then a magnificent Greek dinner on the Sponge Fleet Dock. Saturday was spent swimming, shopping and drying out prior to cocktails and dinner at the Elk's Club. Following an excellent dinner, we were honored to be addressed by Lt. General Paul Myers (USAF Surgeon General). Gen. Myers outlined the USAF study that is currently underway, and answered questions from the floor. The Ranch Hand II study is outlined as follows:

Each of us will soon receive official notification that the study is to be conducted. We will also receive a letter from Lt. General Myers outlining how the study will be conducted, what is desired of us, and the benefits to us. In March 1981 (approximately), by appointment and at our convenience, we will be interviewed by personnel from a nationally recognized medical survey organization working with a scientifically prepared health questionnaire. The survey will be done in the privacy of our homes, or a place of our choosing. After our medical history, past and present, is obtained, the information will be screened by computer and the first physicals can be expected to start in June 1981 (approximately). Physicals will be performed at a nationally recognized medical facility at a time convenient to each participant. Travel expenses and per diem will be paid by the USAF. A control group that has not had contact with the herbicide 24D/245T will be identified and will receive the same scrutiny. Each Ranchero will have counterparts who will receive the same intensive medical review. Ranchero and counterpart will be matched by age, race, time in Vietnam and job speciality, as well as physically. Follow-on examinations will be conducted at specific intervals over the next 20 years. By comparing histories and any current medical problems, any significant abnormality should be detected.

Having been privileged to learn more of the details of the Ranch Hand II study than space will allow at this time, I assure you that if in fact a needle does exist in the haystack and that needle is the defoliant 24D/245T, this study will in all probability find it. The science that has gone into this study is unprecedented and the protocol and methodology used has received the scrutiny of the nation's leading scientists.

Due to time limitations on my part, coordination with the USAF/SG on the above description of the Ranch Hand II study was not possible; and any errors, omissions and/or changes since the address by Gen Myers are mine.

As has been stated many times before, to date there is no valid scientific evidence that links the defoliant 24D/245T with alleged health problems. However, the current controversy can only be answered once and for all with the Ranch Hand II study. The single weakness in the study would be lack of participation of Ranch Hand personnel and personnel in the control group. The validity of the results is highly proportionate to the degree of participation. For this reason, it is desirable that each of us volunteer again as we did more than a decade ago and "Saddle Up" for one last mission with "The Ranch".

The Vietnam conflict created only 1,195 Ranch Hand veterans and Uncle Sam needs all of us again to make this study valid. Let's not let him or each other down.


