
Dear Mr. Cecil:

I just received notice from Professor Ben Proctor that you are to participate on a panel which I am to chair at the Southwestern Social Science Association meeting in Houston in April, 1978.

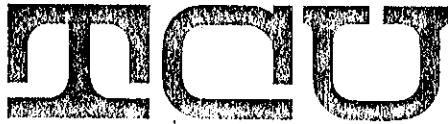
In order that I might know more about you for my introductory remarks, would you please send me a copy of your current vita? I would appreciate it.
