A. SUBGROUP: RECORDS RECEIVED FROM OTHER AGENCIES.

1. Documents Received from Executive Offices 3 bx

Arranged by agency of origin.

Memoranda, correspondence, lists, and reports from the offices of the Director of the CIA, Department of the Navy, Joint Secretariat, Secretary of Defense, and Intelligence Community Staff. The bulk of the material is from the Secretary, Under Secretaries and Assistant Secretaries of Defense.

2. Dept. of State, Paris Peace Accords: Records of the Peace Accords Team 10 bx

Arranged in two subseries: 1) Transcripts of meetings and related documents; and 2) Documents passed to the other side at technical meetings.

Selected transcripts of Paris Peace Accord meetings and related documents arranged chronologically by date of meeting, May 1968 to January 1973. The associated documents include telegrams to the State Department in Washington, texts of speeches, analyses, and memoranda. (box 1-6)

Documents passed to the other side are arranged by country: Vietnamese (box 7-9), Lao (box 10), Cambodians (box 10), and thereunder chronologically. The documents passed to the other side consist of narrative POW/MIA reports prepared by the Joint Casualty Resolution Center. The reports have case numbers, and the reports passed at each technical session are usually arranged in ascending numerical order.

3. Dept. of State, Washington SOG TWX Traffic 16 bx

Text of cable traffic is arranged chronologically in two subseries, after a reference file on State Dept. personnel.

Subseries one (bx 2-13) is a selected TWX file, concerned with POW/MIA affairs at the Paris Peace Accords originating from Washington DC, 1973-1992. The records include the text of telegrams and copies of related documents.

Subseries two (bx 14-15) consists of computer generated texts of cable messages sent and received by the Secretary of State in Washington concerning the POW/MIA issues from 1973 to 1992.

Box 1 contains a file of documents that may assist researchers to identify key names in the files: excerpts

from State Department telephone directories, computer printouts, foreign service lists, and employee lists of persons who served in Bangkok, Vientiane, Laos from 1961 to the present. Box 16 contains miscellaneous declassified State Department documents.

4. Dept. of State, Paris Peace Accords: Paris Embassy
TWX Traffic 27 bx

Arranged by Records Center accession number.

Selected TWX file concerned with POW/MIA affairs at the Paris Peace Accords originating from the US Embassy, Paris, France. The records consist of the text of telegrams and copies of related documents.

This series consists of copies of State Department documents which were drawn from a number of Records Center accessions. The file is arranged by accession, and does not have an overall meaningful arrangement that would assist researchers. However, within the individual accessions the records are often arranged chronologically.

5. Dept. of State, Selected Record of Frank A. Sieverts 43 bx
Unarranged.

Selected records from the desk of Frank Sieverts, Special Assistant to the Deputy Secretary of State for Prisoner of War Matters. The files include copies of telegrams and airgrams (most of which were prepared or approved by Sieverts), lists of POWs and MIAs in Southeast Asia, memoranda, clippings, translations of various documents and messages including newspaper and magazine stories and propaganda, transcripts of audio messages, document analyses, and correspondence. The documents primarily cover the years 1965 through 1972, but may include later material. The records appear to be mostly unarranged, but some folders appear to contain records relating to specific subjects such as getting mail to prisoners or travel of families of prisoners.

6. Dept. of Defense, Office of the Secretary
Policy Files 9 bx

Arranged in six subseries as follows: a) subject file of the POW/MIA Task Group; b) Correspondence and documents received by Brigadier General Daniel James, Jr., Deputy Assistant Secretary of Defense. c) POW/MIA Task Group records on Bo Gritz; d) records relating to the Smith/MacIntyre/Gregson video tapes; e) records relating to the sinking of the US drill ship Glomar Java Sea; and f) Additional documents tabbed by Mr.

Tourison during review of the Special Office for POW/MIA Affairs

a) Documents culled from the records of the POW/MIA Task Group and arranged in numbered folders on various subjects. The records include policy statements, speeches, statistics, rosters, lists, answers to queries, historical information, Egress recaps, organizational support of the National League of Families and COLIFAN, and an After Action Report on Operation Homecoming by the Four Party Joint Military Team (FPJMT). Arranged by folder number in ascending numerical order.

There is a hardcopy "document index" which lists the contents of each folder, and there may be an electronic file which produced the hardcopy, which could serve as an actual index to these records. (box 1-4)

b) Correspondence and documents received by Brigadier General Daniel James, Jr., Deputy Assistant Secretary of Defense. (box 5)

c) Records of the DOD/MIA Task Group including a Dept. of the Army inquiry on LTC. "Bo" Gritz, and POW/MIA Daily Reports (September 1981 to February 1983).

d) Files relating to the Smith/MacIntyre/Gregson video tapes. (2 in., in box 6)

e) Records received from the Department of Defense with reference to the capsizing and sinking of the United States Drill Ship "Glomar Java Sea" in the South China Sea, October 25, 1983. Arranged by investigative report. (box 7)

f) Additional documents tabbed by Mr. Tourison during review of the Special Office for POW/MIA Affairs. The documents include State Department press releases, reports and memos from the National League of Families of American Prisoners and Missing in Southeast Asia, newspaper and magazine clippings, and a variety of other lists, reports, excerpts, letters, etc. The first folder in box 8 is a list of 591 documents in this subseries. (box 8-9)

7. Dept. of Defense, Central Documentation Office:
declassified documents.

18 bx

Arranged in three subseries: 1) Tighe Task Force Report; 2) declassified CDO letter documents; and, 3) PW/MIA Weekly reports.

The records consist of declassified documents sent to the committee by the CDO in response to committee requests. The three subseries are as follows:

1) records of the Tighe Task Force to Review of DIA's PW/MIA Analysis Center, looking for coverups. The

records consist of six drafts and the final report, and related records. (box 1)

2) declassified document packages: these records consist of declassified documents arranged in packages identified by "CDO Letter Numbers." The numbered CDO Letter packages are unarranged, but are listed on the "Note to Enclosure Listing" in box 1 lists the documents in each package and has annotations to show the box in which it may be found. Each CDO Letter packet contains multiple documents which are shown on the box list. The documents in boxes 12-16 were sent to the committee on Dec. 28, 1992, while those in boxes 2-11 were received earlier. (box 2-16)

3) PW/MIA Weekly Reports, 1982-1991. These records consist of two chronological collections of reports which overlap somewhat. (box 17-18)

8. Dept. of Defense, Joint Chief of Staff: MIA/POW
Policy Documents

4 bx

Unarranged.

Records include memoranda, reports, and other documents which were sent to or received by the JCS, or prepared for internal use. The records cover the period 1965-1991.

9. Dept. of Defense, Joint Casualty Resolution Center 6 bx
Arranged in two subseries: JCRC live sightings; and,
JCRC live sightings by Province.

The records include documents relating to live and dead sightings of Americans, location of grave sites, crash sites, and Viet Cong prison camp sites, and a variety of reports and analyses to verify such sightings. The documents include copies of letters and documents received in English and Southeast Asian languages, memoranda, text of telegrams, and other materials. The analytic reports include DoD Intelligence Information Reports, JCRC Evaluation Reports, DIA Evaluation of Information Reports, and more.

10. Dept. of Defense, Dept. of the Army: POW/MIA Affairs 25 bx
Unarranged.

Memoranda, correspondence, reports, and other documents in folders labeled with "PC- " numbers and folder titles. There is no apparent arrangement by either numbers or titles.

11. Dept. of Defense, Dept. of the Navy: POW/MIA Affairs 1 bx
Arranged in two files: Dept. of the Navy and Marine Corps
The records consist of the response of the Department of the Navy and the Marine Corps to the request of the Select Committee for archival records relating to the POW/MIA issue. They include administrative memoranda relating to responsibility for records, and relevant documentation.
12. Dept. of Defense, Dept. of the Air Force: Joint Service SERE (Survival, Evasion, Resistance, Escape) Agency Policy Records 16 bx
Unarranged
The records of the Joint Service SERE Agency (JSSA) of the U.S. Air Force consist of copies of correspondence, memoranda, reports and other documents which were declassified at the request of the Select Committee. They are arranged in folders which have folder titles and PC-numbers which are part of the JSSA filing system. There is no index to the files, and they are not arranged according to the folder titles or the PC-numbers.
13. Dept. of Defense, Records Concerning Operation Homecoming 8 bx
Unarranged
The records include signed releases for Select Committee staff to review the portions of debriefings of returning POWs that relate to other POWs still held. They include Homecoming Egress Recap printouts, and reports of Army, Navy, Air Force, and Marine personnel, as well as other printouts, lists, statements, and reports.
14. Dept. of Defense: DIA Live Sighting Reports 95 bx
Arranged by DIA Live Sighting Source Numbers.
[also see Wick Tourison files, box 4 & 5 for list]
The records consist of the declassified documents of live sighting reports delivered to the Select Committee in partial compliance with the Senate's request to the President.
To protect the identity of sources their names were excised by DIA, and the cases were referred to by a Source Number. In many instances sources provided more than one account, and the DIA assigned other numbers to these subsidiary reports. The main body of DIA live sighting reports consists of reports numbered from 1 to 15,313 (bx 1-91) and bx 92-95 contain lists and indexes to the files.
Nine-hundred and twenty-eight of the reports were

removed from this series for use in the "Cluster Map" project, and filed in a separate series. These reports are filed in the series "Dept. of Defense: Defense Intelligence Agency: Declassified Live Sighting Reports used in Select Committee Cluster Analysis", and are arranged by geographical location according to a grid system imposed over the map of Vietnam.

Boxes 1-91 contain live sighting reports, box 92 contains various printouts of indexes and administrative documents, box 93 contains a three part report from DIA on Sightings of US Prisoners by Indochinese Refugees and boxes 94 and 95 contain live sighting files from the Joint Casualty Resolution Center (JCRC).

There are three indexes to the live sighting files. The indexes list the live sighting: 1) by Source Number, 2) by date of sighting, and, 3) by location of sighting.

The index entries contain data from the SI Report data base used by the Defense Intelligence Agency as one of its information management systems. The entries start with the Source Number or case number (CASENO), indicate whether the report was POW or MIA and FirstHand or Hearsay (SIGHT), provide a brief description of the contents of the report (REPORTED INFORMATION), list the date of sighting (DOS) if available, give latitude (LAT) and longitude (LONG), have an unidentified column (UTM), tell the country involved (CNTRY), indicate which agency originated the report (ORGIN - there is a symbol list attached), a status report column (POLY CAT), and the disposition of the case(IAC COMMENTS).

On the index to live sightings by location, the first line on the top of the pages show the coordinates for the sightings such as "FILE SEARCH WAS BASED ON CENTER POINT OF 205800N 1054600E FOR 25 KILOMETERS" and in most cases the location is hand-written alongside as "HA DONG." The locations indexed are Ben Nape, Ha Dong, Hai Phong, Hanoi, Hoa Bin, Hon Gai, Hon Gai (other coordinates), Hon Gai (other coordinates), Loa Cai, Mahaxai, Muong Khoua, Muong Ngoy, Muong Sai, Nho Quan, Noug Het, Pleiku, Sam Neua, Sonla, and Tehepohe.

The live sighting reports from the JCRC are arranged by geographical area. They were numbered by the Senate Security Office. Some of these sightings are also in the DIA system and may have DIA numbers, but others are not in that system.

15. Dept. of Defense: DIA Live Sighting Reports by Location 40 bx
Arranged by location according to the grid system used by the Select Committee in its Cluster Analysis. The records consist of live sighting reports which were removed from the original series of DIA live sighting reports, for use in the cluster map analysis project. Each box contains live sightings from one or more grid segments, and a map of Vietnam with the segments highlighted. A box list showing the grid segments in each box is in the NSC finding aids.
16. Central Intelligence Agency: POW/MIA Sightings 1 bx
Arranged by country and report number. The records consist of six groups of CIA POW/MIA intelligence reports: three each on Laos and Vietnam and numbered 315, 316, 317. An index showing report number and date of promulgation precedes each group.
17. Senate Foreign Relations Committee, Minority Staff, Tracy Usry Files. 29 bx
Arranged in ten numbered "file groups", and within each file group alphabetically. There is a document list and name index in box 1. The records are arranged in folders under the names of various individuals, organizations, reports, and subjects. The document list includes both the folder title and descriptions of many of the documents within the folders. The index to the documents list indexes the documents within the folders that appear on the list. The series contains a wide range of materials, including letters, interviews, memoranda, issue papers, speeches, news clippings, cables, telegrams, printouts, testimony and reports. Several of the reports in box 1 relate to the history of the POW/MIA issue: "POW/MIA Memoranda Listing Indexes to all Congressional Testimony on POW/MIA Since 1971"; "Significant Documents Relating to the POW/MIA Committee"; and, "Review of U.S. Policy Toward POW/MIAs by Republican Staff of Senate Foreign Relations."
18. The Papers of Henry Kissinger (now at the Library of Congress) 1 bx
Unarranged. The records include declassified memoranda for the President, memoranda of conversation, memoranda to file, texts of cable traffic and various types of reports relating to the Paris Peace Accords, negotiating strategies, and the release of prisoners of war.

19. Foreign Broadcast Information Service: Foreign Media Reports and other records on the POW/MIA issue. 1 bx
Arranged by record type.

The records are arranged in seven categories as follows: a) FBIS reports and analysis of POW/MIA issue according to foreign public media; b) foreign media reports on return of US MIA remains; c) foreign media reports on live sightings; d) official Vietnamese media statements on the POW/MIA issue, 1974-89; e) same 1990-92; f) Vietnamese media commentaries on POW/MIA issue, 1974-92; g) foreign media reports on meetings between US and Vietnamese delegations on the POW/MIA issue.

20. Printout of Combined DIA, DIOR, JCRC POW/MIA Lists 1 bx
Arranged alphabetically by last name of serviceman.

The printout was produced from a database created by combining the POW/MIA databases maintained by three Department of Defense agencies: the Defense Intelligence Agency, the Directorate of Information, Operations, and Reports, and the Joint Casualty Research Center.

The primary purpose of the printout appears to be the comparison of names on the three databases. The entry for each individual name contains three rows of information: one row each for data in the DIA, DIOR, and NCRC databases (if no entry the row remains blank). The data columns have the following titles: Name; Serv; DOB; Doc/Date; Status; SSN; State. The printout also contains a field for Remarks related to each name, which includes the following fields: Cas Place; Paygrade; Porc Date; BNR Status; Duty; Grade; Nation; Serv#; and, Unit.

21. Microfiche Copies of Military Master Personnel Records: Army, Navy, Air Force 13 BX

22. Transcripts of Depositions (Deposition Files on older drafts) 32 bx
Arranged alphabetically in two subseries.

Transcribed copies of testimony of persons deposed by the committee. There is a folder title list of individuals in this series. Much of the material in this series is duplicated in series 19.

23. Deposition and Witness Case Files (Records of the Chief Clerk: Depositions and Witness Case Files on older drafts) 28 bx
Arranged alphabetically. There is a box list.
These records include the testimony and related documentation for persons deposed to appear before the committee. The documentation includes authorizations for and notices of deposition, and exhibits submitted with testimony. Some of the files include abstracts of the testimony. Where transcripts are missing from these files the researcher should look to series 24. A file of notices and authorizations is in box 28.
24. Working Files of Staff Director Frances A. Zwenig 12 bx
Unarranged. There is a box list.
The records contain correspondence, memoranda, reports, lists, and clippings concerning U.S. policy toward POW/MIAs, committee procedures, hearings, meetings, evidence, declassification of documents and other matters related to the work of the committee. Boxes 6 and 7 contain files on individual witnesses, staff members, committee members and POWs.
25. Miscellaneous Files of Chief Clerk Nancy Cuddy 16 bx
Unarranged. There is a box list.
The records include correspondence, memoranda, reports, logs, lists, indexes, calendars, and other materials relating to committee rules, procedures, funding, powers, resolutions, hearings, voting and proxies, and staffing. They include various files on document security and declassification of documents, and a list documents from the Office of Senate Security. Boxes 5 and 6 contain a chronological correspondence file and log for 1992. Boxes 7 through 10 contain copies of briefing books and backup material for the 1992 hearings, Ross Perot's testimony, and the April trip to Southeast Asia. Box 11 contains samples of constituent correspondence, and box 13 contains a January 5, 1993 draft of the Select Committee's Final Report, backup material, and the Vice Chairman's comments on the final report.
Boxes 14-16 include: Staff Director Zwenig files on Task Force Russia, the trip to Russia, POW records in Records Centers, and other material. Files on the April Vietnam trip, the December hearings, the declassification and archiving projects, a file of working papers from John McCreary, and other subjects. Also included are transcripts of the depositions of four CIA officials: Vientiane Cos, the Chief for East Asia Division 1976-81, John Stein, John McMahon.

26. Files of Deputy Chief Clerk Rich Smith
Unarranged.

3 bx

The records include the case file on Michael John Kustigian who disappeared from the USS Longbeach at sea in 1968 (bx 1-2), and copies of reports and analyses of lists of POW/MIAs, including lists dated 27 Jan 1973, 11 Dec 1991, and several breakdowns from the Operation Homecoming period in 1973.

27. Working Files of Chief ^{Counsel} Codinha

19 bx

Arranged in two subseries, thereunder the first series is arranged by record type, and the second in alphabetical order.

The records in the first subseries consist of files on committee members, staff members, witnesses, and subjects (bx 1-5), and briefing books on hearings and several subjects (bx 6-10).

The second subseries (boxes 11-19) is an alphabetical subject file consisting of files on individuals, agencies, offices, and various other subjects.

28. Working Papers of Kim Baker: Committee Correspondence
Files

8 bx

Arranged in three subseries: 1) Committee requests to Agencies for documents, 2) Agency responses to requests for documents, and, 3) Outgoing signature correspondence files of chairmen and principal staff.

The first two subseries of correspondence between the Select Committee and the agencies they requested to provide copies of records relating to POW/MIA issues. Letters originating from the select committee and responses from the agencies are arranged in separate series. Both series are arranged chronologically, and the letters have been assigned file numbers which appear on the file folders, but the numbers do not appear on the documents themselves. There are separate document lists for the two series which provides brief descriptions for the 459 Agency Requests and 464 Agency Responses.

The third subseries consists of copies of outgoing letters from Senator Kerry, Senator Smith, Chief Counsel Codinha, Staff Director Zwenig, and Investigators Kravitz and Valentine.

29. Hearing Files: Transcripts and Printed Versions 7 bx
Arranged chronologically

Copies of the printed hearings and transcripts of hearings and other recorded meetings arranged chronologically. In addition to the open committee hearings, are statements from Tracy Usry, Mark Smith, and Royal Lao General Khan Hou Boussarath, and three transcripts of committee business meetings; an committee sensitive briefing on POW/MIA investigation policy and process; and committee briefings and hearings on the declassification and release of executive branch materials.

30. Briefing Books 3 bx
Arranged chronologically

Briefing books and backup documents prepared for the hearings and meetings held between April 16, 1991 and December 4, 1992.

31. Committee Final Report and Committee Print 2 bx
Arranged chronologically, reports first, followed by committee prints.

At this point we have a copy of the Dec. 30, 1992 draft of the Final Report, and a Committee Print on the Authority and Rules of the Select Committee.

C. SUBGROUP: RECORDS OF THE SELECT COMMITTEE: INVESTIGATORS CASE FILES

32. Working Papers of Hilton Foster 40 bx
Arranged by file number, but with no indication as to the meaning of the numbers.

The records consist primarily of files relating to the 1992 investigation of fraud in POW/MIA activist organizations, including Vietnam Veterans of America, Prisoner of War Committee, and National League of POW/MIA Families and many others. The files are numbered rather than subject-titled, however, no key to the meaning of the numbers has been located.

The files contain correspondence, memoranda, reports, clippings, annual reports, financial statements, income tax forms, and a variety of other investigative materials. Boxes 10-14 contain the responses of the Attorneys General of the States to committee requests for documentation on charitable organizations soliciting funds within their boundaries, and other state files on POW organizations. Other records include various intelligence reports and accompanying documentation, copies of selected POW/MIA newsletters and newspapers, and copies of selected depositions.

33. Working files of Hilton Foster and Alex Greenfield
Unarranged 3 bx
The records include memoranda, correspondence, reports, copies of magazine articles and other research materials.

34. Working Papers of Sedgwick Tourison 21 bx
Unarranged.
These records may contain the most complete set of databases and lists which were received by the committee, however, many of the lists are separated from any cover documentation, and are otherwise unidentified.

The files contain various lists and narrative descriptions of persons missing in SE Asia, analytic memoranda and database printouts prepared by Tourison, two copies of the printout sent to NSX (box 4 & 5), the committee's "Master List" of lists received by 3/12/92 and a collection of lists (box 6-9), paper files, printouts and disks of databases created by Tourison (box 11), and DOD directives pertaining to information management, deserters, and casualty reporting.

Boxes 20-21 contain documents related to the MACSOG Documentation Study and a declassified Defense Intelligence Agency printout "DIA PW/MIA Automated File (PMSEA)" dated September 1979.

35. Files of Neal E. Kravitz: Witness Files 14 bx
Arranged in five subseries: witness files; substantive/administrative files; deposition and hearing transcripts (box 10-12); and miscellaneous documents (box 13-14). There is a folder title list.
The witness files of the Investigative Counsel are arranged alphabetically (box 1-6). The subseries of substantive/administrative files (box 7-9) consists of files on various subjects such as committee memoranda files, committee rules, declassification, Paris Peace Accords, the Kissinger Papers at LC, staff meeting notes, returnee debriefings, various reports, a copy of the index to all Congressional POW/MIA hearings, and other subjects. The deposition and hearing transcripts (box 10-12) are duplicates of those found in elsewhere. The final subseries (box 13-14) contains miscellaneous files on PPA subjects, declassification, a GAO report on identification of human remains, and files on hearing and non-hearing witnesses.

The files contain correspondence, memoranda, reports, lists, DIA live sighting reports database printouts, and other materials related to analysis of the sightings. They contain a wide variety of packages of documentation submitted by private individuals and organizations. Much of the material consists of analyses and daily revisions of a database of live sighting reports which may have been associated with the Cluster Map Project.
39. Files of Harold H. Nicklas 2 bx

Memoranda, interviews, case files, requests for information or documents, and working papers related to the committee work of Harold Nicklas.
40. Files of William E. LeGro 8 bx
Unarranged.
Files on individuals, correspondence and requests with the DOD POW/MIA Central Documentation Office, lists and statistical analyses, memoranda, drafts of reports and statements, research materials, documents and reports received from private organizations or individuals and from other agencies. Some of the material relates to WW II and Korean War missing.
Box 8 contains four 1992 reports and translations published by the Joint Task Force Russia (POW/MIA) for use by the US/Russia Joint Commission on POW/MIAs.

41. Papers of John Erickson 5 bx

These records consist primarily of copies of reports of various committees, commissions and agencies on POW/MIA affairs, excerpts from or complete Congressional committee hearings missing persons in southeast Asia, and excerpts from other publications. The file also contains a small number of memoranda, including a list of actions taken by the House Committee on Foreign Affairs 1960-1991. Box 5 contains records relating to identification of remains, primarily information about and questions relating to the Army Central Identification Laboratory in Hawaii.

The records consist primarily of working papers, interoffice memoranda and other materials used in the preparation for hearings or planning and implementing investigatory procedures. They include copies of various reports, lists, and other documents, including the Department of the Army personnel file on Barry A. Toll.

45. Investigator's Case Files General, The Case of Paul B. Whipkey, missing in 1957. 3 bx

Arranged in binders as described below.

Paul B. Whipkey disappeared while in the Army in 1957 and it was believed that he had left his car, wandered into the desert and died, and that the shifting sands covered his body. His brother Carl Whipkey collected a file on the disappearance and asked to be deposed to testify before the committee and turn over a copy of his file [Holstine files box 1]. The records in these boxes include the files Carl Whipkey collected.

The records consist of materials presented to the Select Committee by Carl Whipkey: 1) a binder of exhibits identified in two parts as # A through # D5 and #1 through 53 (both parts are prefaced by a documents list); 2) a binder containing FBI file 42-141960-26 on the Paul Whipkey disappearance; 3) a binder labeled "Lt. Paul B. Whipkey: 1983 to 1992 problems with GI insurance, Death Gratuities, Senator Heinz, Spector, Kerry POW/MIA Committee & Synopsis"; 4) testimony before a 1982 Army Board for Correction of Military Records in the case of Paul Whipkey; and, 5) a folder of newspaper stories about Whipkey.

Records relating to the Whipkey case may be located among other records of the committee. Box 6 of the records of committee investigator Jon Holstine contains a file on this case.

46. Investigator's Case Files, General: Investigation of Robert R. Garwood.

Arranged chronologically 1965-1992, and thereafter miscellaneous papers.

The records are related to Marine Pfc. Robert Garwood, who in 1984 claimed that his travels in Vietnam gave him reason to believe that at least 70 U.S. servicemen were still being held prisoner in that country. The bulk of the records are the declassified records relating to Garwood's military career arranged in annual folders from 1965 through 1992. The records include Garwood's military records, newspaper and magazine clippings, and other related material (boxes 1-5). Additional records, including copies of press clippings, correspondence, statistical analyses, debriefing transcripts, and transcripts of Vietnamese communist propaganda radio are filed in boxes 5-7.
