
SUBJECT: Mobilization Designation Nomination

Reservist Concerned

1. A review of your Military Personnel Record reveals you possess qualifications which may be utilized effectively in a Mobilization Designation position. See attached Information Sheet. Vacancies currently exist in Department of the Army Staff Agencies, Major Commands, US Continental Army Command, CONUS Army Headquarters, Headquarters Military District of Washington, US Army Alaska and Southern Command.
2. The above proponent agencies have key positions which must be filled by Mobilization Designees who are readily available and specially qualified for augmentation. However, the program is based on the premise that the skills required by the position cannot be satisfied by branch, grade and MOS qualifications alone. Individuals selected must be given extensive premobilization orientation and qualification training in the position in which they have been assigned to serve during mobilization.
3. This notification of your eligibility for nomination does not assure that you will be selected for a mobilization designation assignment. Selections are made by the proponent agency and are based on available information from both military and civilian sources.
4. DA Form 2976, Application for Mobilization Designation Assignment, and return envelope are enclosed. Request you complete the application and return it to this Center prior to the suspense date shown above.

INFORMATION SHEET

1. A Mobilization Designee is an officer in a Ready Reserve status who is preselected, trained and available to fill a certain key military Table of Distribution position in the event of mobilization. You will complete, in a pay status, at least 12 days ACDUTRA annually with your Proponent Agency to enhance your potential and to receive on-the-job training. Tours of active duty are scheduled by the Proponent Agency. Every effort will be made for you to perform your active duty at a convenient time.
2. You may be assigned to a TD position two grades higher than your current rank. You will be selected on the basis of your awarded primary or secondary MOS or an allied MOS and will be assigned only to a TD position having requirements for such specialities. You may be potentially capable of qualifying for the allied MOS after a reasonable period of training.
3. You may be voluntarily attached to an appropriate Reserve unit to engage in non-pay drills for retirement points. You may also earn points by participating in the USAR School program and/or Army Extension courses.
4. If you have had experience in higher level staff duty or operations and training, or are engaged in a civilian occupation related to military planning and troop operations, we suggest that details be included in the remarks section of application.
5. Your Mobilization Designation Assignment will be terminated under the following conditions:
 - a. Request by your Proponent Agency.
 - b. Discharge or separation from the Army Reserve.
 - c. Transfer to the Standby Reserve (including the inactive status list thereof), or to the Retired Reserve.
 - d. Promotion to a grade higher than the grade authorized for your mobilization designation, unless redesignated to another TD vacancy or a grade waiver is requested by proponent agency.
 - e. Failure to maintain minimum retention point credits for retirement year.
 - f. Elimination of the position for which you are given a mobilization designation.
 - g. Departure from the continental United States whenever you intend to travel or reside outside thereof for a period of six months or more.
 - h. Dropped from Reserve strength to enter on extended active duty.
 - i. Voluntary assignment to a paid-drill unit.
