Subj: Permanent change of station

3. You are authorized to delay until not later than 6 June 1962 in reporting, such delay, less proceed and travel time, to be chargeable as annual leave.
4. You are hereby assigned the MOS indicated opposite your name.
5. You will report to the Disbursing Officer within three working days after completion of travel to settle travel expenses.

1. Subj: Permanent change of station

1.
