Who are *The Insiders*? According to the Independent Newspaper NEZAVISIMAYA GAZETA, (August 9, 1992 Issue), "The Insiders is a group of current and former intelligence officers who have been looking, since 1982, for evidence that shows that missing Americans fell into Soviet hands."

Others say "The Insiders" is a group of men and women who surround the President and can advise him that LIVE Americans are being held in Communist countries (Vietnam, Laos, Cambodia, North Korea, China and the former Soviet Union). If these advisors to the President were ready, willing and able to accept the idea - to grasp the concept - that U.S. citizens were kept, alive, after ALL wars (WWI through the Cold War), they could have aided in a prisoner release. But, alas, Bush appointees have failed to hear the calling of a monthly publication called THE INSIDER, which is mailed to their offices and homes FREE. THE INSIDER is a monthly publication that details evidence that Americans were captured alive but were not released, have never been accounted for, and need to be brought home.

The FBI, CIA and the DIA all maintain files on THE INSIDER. Should one have a high enough classification clearance, one could ask the FBI to reveal FILE #334,201 and BUFILE 190-51298. Parts of FILE #334-201 were created on August 1, 1989, by Oliver B. Revell, the FBI's Assistant Deputy Director for Investigations. FILE #334-201 lists the Bush administration appointees who have received THE INSIDER information service that was designed to help Presidential appointees understand that there are unresolved problems of Americans who were captured alive - POWs - but not released. The fact that a file exists on THE INSIDER indicates that it has reached the highest levels of government.

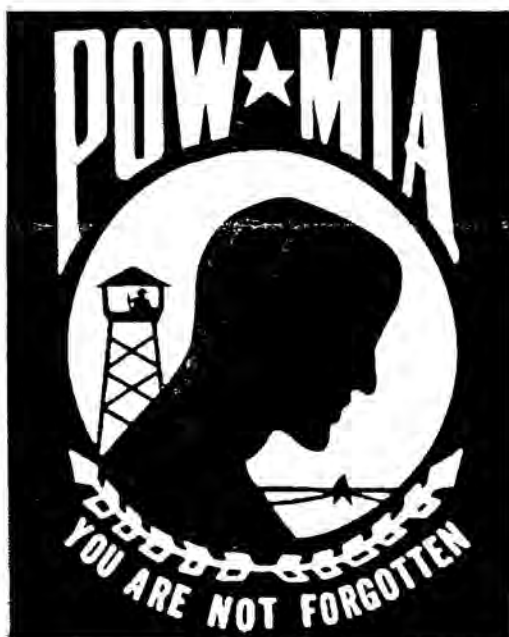
This information service is designed to help George Bush appointees understand that there are unresolved problems of Americans who were captured alive (POWs) but not released.

Many of the people on this list who HAVE received information showing that Americans were captured alive but not released, EITHER have failed to advise the President to TAKE ACTION to bring home these LIVE American prisoners, OR the President has been advised of the overwhelming evidence and HAS CHOSEN to ignore the evidence. It is clear that the Foreign Policy objectives of President Bush do not include a program designed to get the LIVE POWs home.

Twice I have met with Soviet Generals in Moscow, Communist officials in Cambodia, and Laotian, Vietnamese and Soviet officials in the United States, all of whom

have discussed the Live Prisoner problem and have offered solutions to this problem. In effect, this is a private, back-channel effort aimed at making it advantageous for all sides to admit knowledge of Live POWs and bring them home.
