Notes to Accompany the Financial Report

1. This is the second full year that we have had separate Scholarship Fund, Monument Fund, and Money Market accounts. Interest earned is apportioned directly to each fund. Total interest earned this year was \$1,474.73.

Treasurer

- 2. This is the second year in a row where dues income has been high. This reflects the consistently large number of Life Memberships (115 in the current reporting period), which is a non-renewable resource.
- 3. The Newsletter cost figure is significantly lower than last year and reflects publication of only three newsletters. Anticipated cost of the current (fourth) newsletter for the Society's fiscal year is \$5.500.

4. The total income from dues other than Life Membership was \$16.503. This is not enough to even publish the newsletter for a year.

- An increase in annual dues of \$5.00 of which \$3.00 would go to National and \$2.00 would go to Chapters would yield approximately \$2,261 for national.
- An increase in annual dues of \$10.00 of which \$6.00 would go to National and \$4.00 would go to Chapters would yield approximately \$4,522.00 for national.
- An increase in annual dues of \$5.00 where all \$5.00 would go to National would yield approximately \$3.150 for national.
- An increase in annual dues of \$10.00 where all \$10.00 would go to National would yield approximately \$6.300 for national.

The cost of Life Memberships should increase, as a minimum, to \$273.00. (with \$200.00 going to national and \$73.00 to chapters).

As of May 31, we have 555 life members and 629
people current in dues. If the Life membership trend
continues, we will have more life members than current
paid members by the end of 1994.

No other organization that I can think of has ever done that before ... not VVA, not even the Vietnam Womens Memorial Project. the 173rd did not relegate us as "second class veterans status"; segregate us and ask us to "enter the parade" (so to speak) after some other country's nurses, nor deny us honorary membership as others have done. I was speaking from the heart when I stated at your banquet that we civilian women felt truly honored! For me, your tribute was everything the Womens Memorial Dedication should have been but wasn't. In my opinion. it took the 173rd Airborne Brigade to do it right! And for that I. and I'm sure all the women who were honored, will be forever grateful. THANK YOU.

Friends asked me how the reunion went, and I said "Great. I got pinned by the 173rd ABN BDE!" But seriously, I will wear your beautiful, sterling silver, 173rd patch with great pride!

'Where is Sgt Rick'?

On Saturday 6 August, 1994, I went in to Sydney with my lady Krys to visit a quilting exhibition and generally relax and look around an area of Sydney known as "The Rocks'.

I chanced to enter a shop to look around, not for any particular reason I looked in a display cabinet and saw an array of cigarette lights with a sign over them stating: —

Genuine American Servicemens — Vietnam — Cigarette Lighters

Sure enough my eyes found what I was unconsciously looking for, the emblem of the 173rd Airborne Brigade.

The engravings on the lighter identify the lighter to have belonged to a member of the herd, who served in Vietnam with the Herd from 1966-1967 and 1970-1971.

Dear Fellow Sky Soldier:

I read with special interest Chapter IV's In Observance of Memorial Day reprinting of a beautiful letter and poem by Linda Philips Palo addressed to three classmates that she lost in Vietnam. Her grief and anguish was all the more borne home to me for one of her classmates, William Paul Mason. was under my command in the 2nd Platoon, Co. D. 16th Armor when he was KIA.

"Doc" Mason was the platoon medic on 4 Mar 68, when D/16 engaged a numerically superior enemy force of battalion strength at the Battle of Tuy Hoa North, the villages of Ninh Tin 1, 2, & 3, Co. D/16th Armor stood tall that day, credited with 137 enemy killed of a total of 200. For this action, and at BG Allen's behest, the company was nominated for the Valorous Unit Citation. This of course would not have been possible without the supreme sacrifices made

by Sp4 Mason and seven others of our company.

It was during the third assault. Ninh Tin 3. on the entrenched enemy command post in close quarters fighting that Sp4 Mason was killed. An APC from the 3rd platoon had taken a hit from a B-40 and the fighting crew were badly injured and killed. The two nearest tracks to the stricken vehicle, one of which was the 2nd platoon command track in which Doc Mason was riding, rushed to its aid. As soon as his vehicle was stopped and without a moment's hesitation, he leaped from his track and ran to the aid of his fallen comrades. While he was attempting to evacuate the wounded and dead from the burning fighting vehicle, he was hit again by another rocket at point blank range killing him and mortally wounding the already wounded. The second APC was also hit until the rocketeer was silenced by two bursts of six of caliber .50 from the 2nd platoon APC.

For his selfless act of courage and devotion to duty. SP4 William P. Mason was posthumously awarded the Bronze

Star with V and the Purple Heart.

At the end of the sun-up to sundown battle, D/16, whose complement of Officers and Men did not total more than fifty, suffered 50% casualties. KIA and WIA. But we never stood taller for ourselves and for The Herd. I remember monitoring the brigade push and listening to the 4th Batt. CO repeatedly requesting permission to commit one of his rifle companies, and the CO of "Dog" Company, I believe, practically screaming to join the fray and prepared to form an immediate PZ. This was in response to our asking for Infantry support of our own. Requests denied.

I remember our brother Armor unit, Troop E. 17th Cavalry screening our right flank along the highway, who would occasionally yell words of encouragement on our company and platoon nets. Years later at our 1990 reunion. Don Ashlock of E/17 Cav and the Texas Chapter told me of their giving us "unauthorized" supporting fire across the paddies and picking off those enemy too dumb to realize what they

were running into. They were there.

I remember when I called the 1Sqt in the rear for our resupply of ammo and asking him how he was making out manpowerwise in getting it done, since we already had our company and supply clerks and cook's helpers on the line. He replied that it was not a problem because NCO's and men from the 4th Batt, were helping hump ammo. D/16 was never alone.

Within a week of the next of kin being notified of the loss of their loved ones, as the Executive Officer of D/16, I had the honor of receiving two letters on behalf of the company. The first was from Sqt. Gary D. Hall's widow. She wrote to us, not of her loss of her husband that fateful March day, but to ask us, the survivors, if we were alright; could she do anything for us; that she was praying for and thinking of us. I will never ever forget her selflessness in what had to be her deepest moment of sorrow.

The second letter was from Sp4 Mason's uncle. CWO Mason explained he was a career military man and although he knew it was Army policy not to give details of battle deaths to anyone, he felt, as a soldier and as an uncle, he had a right to know the circumstances of his nephew's death. I

felt that way too. And I told him.

So Linda Philips Palo. I too think of your classmate. William P. Mason, and I would like to say just this, he will live forever because paratroopers never die for we are, and shall ever remain. Airborne. All the Way.



Dear Editor:

I am representing David Greenslade in his claim with the VA for service connection for PTSD. The Court of Veterans Appeals remanded the case to the Board of Veterans' Appeals. We are now seeking additional evidence, particularly regarding stressors.

Mr. Greenslade served two tours of duty in Vietnam with the U.S. Army. The first was from May 2, 1967 to April 28, 1968, with Headquarters and Headquarters Company of the 4th Battalion, 503rd Infantry, 173rd Airborne Brigade. He served as a cook at Dak To and elsewhere. He was rotated into the field when possible to serve the troops hot meals. We have one affidavit from a member of the 173rd stating that there was mortar fire in December 1967 at Dak To, that cooks were in forward support groups, and that such groups were subject to fire. He also stated that cooks were left in the field of battle overnight. This man, however, did not witness Mr. Greenslade in the field personally. That is what we are seeking — someone who witnessed his exposure to combat.

Would you please let me know if you or your publication can help. Thank you for your assistance.
