**OH-58 AIRCRAFT
MAINTENANCE WORKING GROUP
2 February 1971**

1. Meeting of the OH-58 Aircraft Maintenance Working Group was conducted in the USARV Aviation Section conference room at 021400 Feb 71. Persons in attendance were as follows:

2. CPT Ostovich began the meeting with a discussion of the problems involved in providing a direct support maintenance capability to AFV in conjunction with the lease of eight OH-58 aircraft. AFV was advised that USARV could not provide adequate maintenance training or sufficient quantities of repair parts, tools and ground support equipment to sustain an AFV direct support maintenance effort. It was further determined that organizational level maintenance training and associated parts/equipment could be provided. The conference continued on this basis.

3. AFV expected utilization is 100 hours per month for each aircraft. With a 300 hour periodic inspection schedule, this would result in three OH-58 aircraft in scheduled DS maintenance each month. AFV intends to keep six of the eight leased aircraft operational.

4. Once the 161 Recce Flt begins OH-58 operations, the direct support unit (DSU) would be initially required to conduct frequent assistance visits. These visits would serve to standardize AFV maintenance operations with those normally practiced at comparable US units.

5. The general concept of maintenance training is to provide a group of approximately five AFV mechanics with general subjects ground school instruction in conjunction with an OJT program at the IP/SIP school in Vung Tau. Those AFV personnel who will perform as unit technical inspectors will continue with OJT at the DSU in that particular field. The school at Vung Tau is capable of accommodating two transition pilots and five OJT mechanics.

6. Subjects requiring further investigation and resolution are as follows:

a. RAAF relief from airworthiness responsibility - Wg Cdr Felton/Wg Cdr Rundle.
