MEMORANDUM FOR: DEPUTY AVIATION OFFICER

SUBJECT: CAF Training Update

Basis for Action: Note from DAO.

Summary: a. Administrative arrangements. All administrative arrangements pertaining to billeting, mess, PX privileges, identification/privilege cards, ration cards, medical care, transportation and money exchange have been made.

b. Instructor pilots. Four French speaking UH-1H instructor pilots have completed IP training and will be officially validated as USARV UH-1H IP's prior to 6 Dec 70. One French speaking student IP, 179 Cav, was returned to his unit on 30 Nov due to lack of flying proficiency. Another French speaking student IP, CW2 Gregory, 57 Med Det, will complete IP training on 4 Dec and will be used in training the CAF.

c. Flying equipment. Twenty four each SPH4 flying helmets have been received. These helmets will be issued to the pilots and crew chiefs.

d. Translation of the Technical Manuals. The UH-1H pilots check list, emergency procedures and standardization of procedures guide have been translated. Applicable portions of instructions pertaining to performance of preflight, postflight and intermediate inspections are being translated and will be completed by 6 Dec 70.

e. PIO release. Information is still classified secret. MACV PIO reports that DOD is not going to release this information to the public until certain hearings are completed (Assume these are Senate hearings).

f. Entry formalities. MACV has not yet informed USARV of the entry formalities for CAF.

g. Governmental sanction. MACV has not notified USARV if the GOSVN has approved this project.

h. Classroom instruction. POI's and lesson plans have been completed. Rehearsals of instruction are underway. Major problems are not expected.

i. Letter of Agreement. MACV will send USARV a msg directing that individual waivers of liability be executed in lieu of an agreement.
