SUBJECT: Aviation Training/Logistic Support for AVNK (C)

PURPOSE: (C) To provide information on aviation training and aviation logistic support provided by USARV to AVNK to date.

## FACTS:

1. (C) Aviation training conducted for AVNK is listed below:

2. (C) To date six UH-1H helicopters have been provided to AVNK and paid for by MAP funds. So that a daily OR of six flyable may be maintained USARV has two float UH-1H's which may be provided AVNK on a daily basis. When float aircraft are used a daily rental fee is charged; however, if at a later time FANK desires to purchase additional UH-1H's the total rental fee may be deducted from the purchase price. Spare parts and required maintenance support is provided by 34th GS Group and paid for by FANK. Any maintenance support (normally PMP's) beyond the capability of AVNK is performed by a unit of 34th GS Group.

3. (C) Twenty-eight O-1D aircraft have been given AVNK on a NIMEX (no cost) basis; however only 11 have been flown to the KIMERE Republic. MEDTC has requested thru CINCPAC that all O-1D peculiar parts be declared excess and given to AVNK but approval for this transaction has not been received.

4. (C) Eighteen U-1 aircraft have been offered AVNK on a NIMEX basis, however, none have been delivered to the KIMERE Republic. Pilots and mechanics are in training at Vung Tau to be qualified on subject aircraft.
