The letter from John Frank was waiting for me at my office when I got back to work Monday. I'd been on the road for a week and had not seen my mail for that period.

Since John will be entering individual Callsigns in the Members/Friend database I will be able to update the Callsign database from it starting in the near future. However, for the period from the July Reunion until he gets the new database structure operational, I will need the hard copies of the new applications to update the Callsign database. Also, any hard copies containing information pertinent to Gary's KIA/MIA database should be forwarded to him. Does the new contract with AAM continue to provide for this? To keep it simple, John can send me a copy of every new application and renewal and I will forward them to Gary as I finish my review.

John has been sending me Orders, Class Rosters, and Information Requests\Letters from the members but I have not been receiving new applications or the renewals since we returned from the July Reunion. The most recent updates I have are from July. Since I do not have the hard copies to send you, I would like to suggest an alternate plan for updating the unit fields. When you get a copy of the new database, create a label which includes the following fields:

MEMBER  
DIRSORT  
FIRST  
SECOND  
THIRD  
FOURTH

You can then print them out as labels on paper stock, make corrections and send the hard copy to AAM. Don't use an index on the database when you do this; the labels will then print out in record order (the order in which the girls entered them). This should make it easier for them to enter the corrections. You might try printing them out in blocks of 100 or 200 records in order to keep the work organized and manageable.

I will devote my time to developing a usable Master List of Aviation Units for AAM's use. Target date for completion will be the end of January. Thereafter, I will budget part of my time to reviewing the Members/Friends database in conjunction with your efforts.

When these two get up to speed with Dbase I will detail Murray to work with Gary on the KIA/MIA/Dead database, Roger will work on the Class Roster Database with Peter Barber under my direction and I will update the Callsign database and keep the soon-to-be-created Units database up to date as new info comes available.

I'm returning your book under separate cover since it might slow down this letter. Many thanks for letting me borrow it.

Drop me a letter if you have questions or suggestions about updating the Units fields as discussed above.

It was good to talk to you and I'm glad to have your time and experience available to the committee. Can I welcome you back to the Records\Database Committee officially? How about Member Emeritus or Past Chairman?
