DEAR MIKE,

SURE HOPE THE '95 REUNION IN KANSAS CITY WAS A BIG SUCCESS!

HAVEN'T HAD ANY SUCCESS GETTING MORE NEWSLETTER ARTICLES LATELY BUT I HAVE MADE SOME CONTACTS IN MY TRAVELS & HAVE HEARD ABOUT

SEVERAL FORMER VIETNAM ERA HELICOPTER PILOTS IN THE 3 STATE AREA. AS SOON AS I LEARN of THEIR NAMES, I CHECK THE VHPA DIRECTORY TO SEE IF THEY ARE MEMBERS. IF NOT, I TRY TO GET INFORMATION ABOUT VHPA to THEM — OR AT LEAST to SOME ONE WHO CAN GET THE MATERIAL to THEM.
