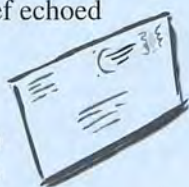
Years make difference in pilot's homecoming

I lay wide awake with my wife; the jet lag had a strong hold on me. The day's events would not let me sleep, thoughts of a different time and place raced through my mind.

The freedom bird descended from altitude, there was dead silence as the pilot reduced power and the aircraft settled for landing. As the wheels touched the runway, a tremendous cheer arose from the silent passengers.

After a year in Vietnam, a lot of relief echoed throughout the cabin.

From reading and watching the news, we were apprehensive of our reception at home. As I left the plane, no one said "welcome home" or "thank you for your service."



In the airport, I was met with stares and gruff remarks, something like the plague had arrived. No one smiled or said "hello," it was as if I didn't exist.

I could not wait to get out of my uniform and try to blend in. After about a week, all I wanted to do was to go back to RVN to my friends and home. Well, that did not happen, life went on and we all adjusted and tried to forget.

The freedom bird descended from altitude, there was dead silence as the pilot reduced power and the aircraft settled for landing.

As the wheels touched the runway, a tremendous cheer arose from the silent passengers.

The R&R flight from Kuwait/Iraq had landed and the entire crew welcomed us home and thanked us for our service.

The USO was at the gate with my family, waving flags. At the sight of a soldier in uniform, everyone in the crowd cheered.

I could not walk 10 feet in the airport without a stranger stopping to shake my hand and to say "thank you."

As my family and I crossed the road to the parking lot, people honked horns and gave a thumbs up and yelled well wishes from their cars.

I was proud to be in uniform after 34 years, I did not want to go home and take it off. I had a great R&R with my wife and four college students/kids.

On the way back to the airport, we stopped for gas. A man stopped his car, got out and gave my wife and me a hug, and thanked us both for our service and sacrifice to our country.

To the people of the United States, I thank you for your support; it sure feels good to be home after 34 years.

Chopper crew saves Special Forces team

A former Special Forces commander is looking for the helicopter crew that extracted him and his B-36 LRRP team from a B-52 bomb crater on a dark, rainy night some 37 years ago.

The commander would like to contact the captain and warrant officer who flew the helicopter and thank them for "saving his team's collective asses"!

The action took place in rainy weather the night of Sept. 16, 1967, in the area of the "Parrot's Beak" near Katum in northwest III Corps.

The B-36 LRRP team belonged to Company A, 5th Special Forces, and was in deep trouble after being surrounded by the enemy. The team had been pushed into a B-52 bomb crater and was thankful the Huey crew was able to hover in heavy rain down through the jungle canopy to the crater and pull team members up onto the skids during a hover.

The unit and call sign of the aircraft are not known, only the date and location of the incident.

Writer conducts survey of pilots at 2004 reunion

In the last issue, my article was published, "Connecting the dots." It was a request for information from fellow VHPA members regarding their hearing loss and tinnitus as a result of their military flying.

As a result of the response, I went the logical next step and surveyed the attendees of the 2004 Reunion and promised to publish the results of that survey in order to benefit anyone who may be filing a claim or going through an appeal with the VA.

VHPA currently has 11,900 members out of the 40,000 helicopter pilots who served in Vietnam. Of the 11,900 membership, 1,060 were present for the Reunion in Dallas and 202 (or 19 percent of all the attendees) filled out a four-page questionnaire, which made a statistically significant survey.

This 19 percent sample is large enough to significantly reduce the variability of result or it means that these results would have a very small probability of happening just by chance.

Besides an adequate number of respondents to ensure accuracy, I also avoided bias by taking a random sample, meaning everyone at the reunion had an equal chance of being chosen.

Executive Overview

This is not a comprehensive summary of the survey, so the total numbers for each question don't tally up because some participants filled out only portions of the questionnaire, i.e., some only filled out hearing and others only complete tinnitus. The original questions have been removed for brevity considerations.

- Of the 202 surveys, over 75 percent suffered up to 50 percent hearing loss and 70 percent have hearing loss in both ears.

- 70 percent realized hearing loss only AFTER active duty.

- 59 percent had hearing loss reported on exams while on active duty.

- 97 percent shows a hearing loss as a result of active duty.

- 56 percent of the separation physicals indicated a hearing loss. 30 percent of the separation physicals showed inaccurate results relative to hearing, 14 percent had no hearing test performed on separation.

- The largest other cause of hearing loss was due to explosions (17 percent) and trauma (7 percent).

- 91 percent of the respondents attributed their hearing loss to engine noise, 44 percent of these men had between 1,000 and 3,000 hours, 75 percent had turbine aircraft time.

- 79 percent of surveyed members had tinnitus, and of those with tinnitus 81 percent had it in both ears, 64 percent had it at a severe level — more than 50 percent of the time.

- 72 percent felt the tinnitus was increasing in severity.

- 59 percent noticed/evaluated tinnitus only AFTER active duty.

- 80 percent of flight physicals on active did NOT test for tinnitus.

- 81 percent of the physical examinations did not show tinnitus BEFORE active duty.

- 34 percent indicated that their separation physical showed more hearing than was actually present. 26 percent later discovered tinnitus at a severe level of over 50 percent.

- The most frequent cause of tinnitus besides engine noise was explosions in 16 percent of the cases.

- Of the respondents with tinnitus, 47 percent had 500-3,000 hours of flight time, and over 75 percent of their time was in turbine helicopters.

- 58 percent indicated that they were not required to wear ear protection.

- Only 48 percent have made a claim for hearing loss and 29 percent for tinnitus.

- 37 percent plan to file a claim.

- Breakdown of respondents: Warrants, 48 percent; Commissioned, 40 percent.

Years in service:

- 22 percent — 1-5 years.
- 14 percent — 6-10 years.
- 19 percent — 11-20 years
- 43 percent — 21+ years

Conclusions

There is definitely a link between flying helicopters and hearing loss and tinnitus. These afflictions were not accurately reflected on the pilots' separation physicals and many times only were only accurately diagnosed many years after active duty.

Epilog

The current issue, July-August 2004, of *DAV Magazine*, Page 36, has an article entitled, "Radiation Study Clicks for Some Atomic Veterans" that you will find interesting. In essence it stated that:

The disability claims of more than 1,300 veterans exposed to ionized radiation during nuclear weapons tests in the 1950s are being reconsidered by the VA as a result of a study that found the levels of exposure estimated by the government was inaccurate.

The 1,300 claims were a small percentage of the over 11,000 disability claims made to the VA by veterans exposed to nuclear testing.

The DAV supports the presumptive service-connection for all veterans with recognized radiogenic diseases versus the estimates used by the government.

What is the connection?

The message to all helicopter pilots of the Vietnam era is clear: The VA should also recognize the presumptive service-connection for hearing loss and tinnitus veterans with flight time during that time period.

Thank you, all of you, for adding more to my life. Don't ever change, I love you all for it.

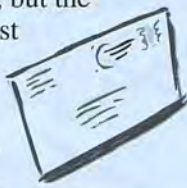
As my husband told me, all you helicopter pilots are truly "cats of a different breed" — fun-loving, hell-raising party people, but still honorable and compassionate.

The day our gunships almost killed Steamer

Three teams were the most you could have operating across the fence at one time so, after inserting a third recon team in southern Laos, it had been a slow day at CCC, the forward operations base in Kontum for SOG.

Nothing but sitting around, reading, playing cards, playing Battleship, pitching horse shoes and waiting for something to happen and hoping it wouldn't.

The team we had just inserted, operating south near the Tri-border area, heard noise, figured they were being tracked and moved to avoid contact. The other two teams reported no activity at all. Everything seemed OK.

Every day the 361st ACE "Pink Panthers" and the 57th "Gladiators" were tasked with providing four AH-1G's and six UH-1D's, respectively, to support the mission of CCC. This particular day, one of the Snakes had a mechanical problem and returned to Holloway early after the team insert.

As quiet as things were, there seemed no need to request a replacement. Anyway, a heavy fire team always worked well if needed.

Gary Meyer was the AMC for the day. A relatively new AC, this was his first mission as Panther lead. Mike Harsh and Vince Sullivan were his wingmen.

Stan Stenbock, a Gladiator legend, was flight lead for the 57th. It was shaping up to be an easy day — 30-minute flight to CCC for the briefing, 2-hour insert southwest of Ben Het, 30-minute flight to Dak To II to "stand by," 30-

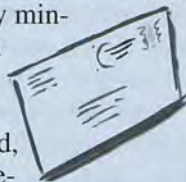
minute flight to Kontum and a 30-minute flight home to Holloway.

Around 5 p.m. the teams gave Covey the all-clear and he, in turn, released the air assets. Nine birds cranked, called clearance, pulled pitch and headed south toward Holloway.

An easy, fairly uneventful day. Just the kind of day you loved and hated at the same time. Twenty minutes later, as the two flights called Pleiku Air Force Base for overflight clearance, Covey called saying the team, inserted earlier in the day, had in fact been tracked, was in contact with a force of vastly superior size, was running for their lives and had declared a "Prairie Fire" AKA "come get me NOW or there won't be anything to get later on."

Covey had located a "door," a usable PZ, directed the team toward it and called for the extraction assets to get there ASAP. To add to the excitement, the weather was starting to get dicey.

Gary landed and headed to Panther Operations for a briefing, while Mike and Sully headed for refueling. Steamer and his flight were right behind. The slicks refueled first and took off west-northwest. The two snakes



were 5 minutes behind.

Forty-five minutes later Covey bingoed the PZ and the snakes set up a low-level gun pattern, 60 knots inbound, 120 knots outbound, and called Steamer down.

CW2 Stanley "Steamer" Stenbock was an outstanding slick driver. About 5-foot-6 and 160 pounds, big mustache and brass testicles, he could get in hover holes most pilots couldn't and make aircraft perform like no other pilot I've ever seen. He didn't know the word NO.

My first or second day on missions, I was flying with Mike, a college classmate and great friend. He suggested (told me) I was flying back to Holloway with Steamer so we could "get to know each other."

Steamer headed to Holloway, straight and level. All of a sudden, he starts a tight spiral to the left, pulls out at tree-top level and puts us in the tightest hover hole I'd ever been in; you know, the ones instructors wouldn't go into at Fort Wolters.

He then says to me: "New Guy, you got it." I took the controls, scared, sweating like a stuck pig.

He sits back, takes out a cigarette, lights up and says: "New Guy, while you're up there flying around in your air-conditioned Cobra, I'm down here risking my ass and the guys on my bird to insert or extract teams out of deep kimshe. You make damn sure you put your rockets and mini-gun where I tell you to or I'll have your ass. Do we understand each other, New Guy?"

"Yes, Sir," I replied.

After what seemed like the first seven months of my tour, Steamer took the controls and headed home. To this day, I still get nervous just thinking about it.

Back to the "Prairie Fire." It was getting on toward dusk. The weather was going south.

Steamer entered the pattern and headed inbound. "Taking fire 9 o'clock, taking hits. Taking fire 12 o'clock. I've got the team in sight. Taking fire 2 and 3 o'clock. Panther lead, bring it in close, bad guys all around the LZ."



Mike rolled in and fired two pair.

"No, no, too far to the left. Bring it in closer."

Sully fired two pair.

"Damn it, Panther lead, they're all around me in the LZ. Bring it in close."

As the Cobras broke left, tracers "rooster tailed" after them. Both snakes were taking hits.

Visibility was getting poor due to the weather and the onset of darkness.

Mike fired two pair on his next inbound. He could see Steamer's exhaust glowing bright orange. The rockets seemed to head right for the orange glow. In fact, the two pair obscured the exhaust completely.

Mike thought to himself, "My, God, I've killed Steamer."

At the last instant, the four rockets ducked under the slick, exploded in front of the aircraft, blowing holes in the chin bubble, putting several pieces of shrapnel in Steamer's legs and causing the aircraft to bounce upward.

"That's it, that's it. That's where the bastards are. Keep it coming, keep it coming." Steamer picked up all seven guys on his bird, turned and headed outbound. Tracers followed his path of flight.

Once away from the PZ, battle damage started to con-

cern Steamer and Mike. After flying toward Dak To II for several minutes, they decided to set down in an open field and check their aircraft.

By this time, Gary had arrived on station and set up a gun pattern with Sully, while Mike and Steamer quickly ran around their birds with flashlights, checking the damage. Convinced the ships were flyable, they headed to Kon-tum.

A couple of the team members had minor wounds, the three aircraft had multiple bullet and shrapnel holes, and the team had been saved from being overrun.

All in all, a successful mission. And Mike ONLY almost killed Steamer.

That's what makes the VHPA and its reunions so great, why I am a life member of VHPA, and why I intend to come to every reunion I can as long as I'm able.

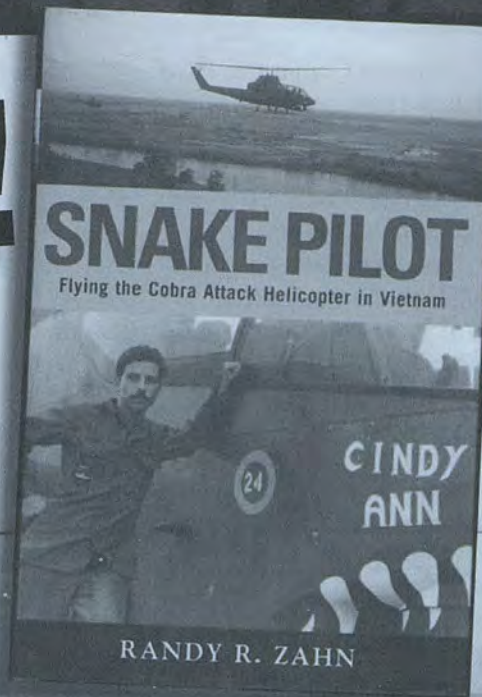

Association details election policy

VIETNAM HELICOPTER PILOTS ASSOCIATION®

National Election Policy

This document sets forth the policy and procedures of the Vietnam Helicopter Pilots Association (VHPA™) regarding candidates for office, campaigning and campaign materials and election procedures. Much of this policy has always been in effect and the purpose of this document is to express the policy and procedure in writing in a singular source.

CANDIDATES FOR OFFICE

The candidate must inform the Executive Council (EC) Coordinator in writing of his intention to seek a specific office NLT 12 midnight, June 15 in the year the candidate is seeking elected office. The candidate will receive a "Candidate Packet" with a copy of the VHPA Election Policy and a Candidate Information Sheet to be filled out and returned to the EC Election Coordinator. Any and all questions the candidate may have will be directed to the EC Election Coordinator.

The candidate must be an active member of the VHPA for a minimum of one (1) year prior to the first day of the VHPA National Reunion in which he is seeking elected office.

The names of candidates for each office will be posted to the VHPA website NLT June 20 in the year they are seeking elected office. All names will be posted at the same time and listed alphabetically by office sought.

CAMPAIGNING AND CAMPAIGN MATERIALS

The following rules will apply:

Candidates and/or their supporters may campaign and provide campaign literature and materials at the Annual Reunion.

Candidates and/or their supporters must obtain the permission of hotel management prior to posting campaign materials on the hotel property.

The VHPA or its HQ will not provide member information, of any kind, to candidates and/or their supporters to be used in the campaign.

Candidates and/or their supporters may not use any National VHPA website to post campaign information.

Candidates and/or their supporters may not use the VHPA Newsletter© to campaign for office.

Candidates and/or their supporters may not place campaign materials of any kind in the Reunion registration Packets.

ELECTION PROCEDURES

The following procedures will apply:

The EC Election Coordinator will conduct the actual elections in conjunction with the VHPA President's agen-

da for the Annual Business Meeting.

The EC Election Coordinator will assemble a group of election volunteers to assist with the actual elections. All volunteers must be active members of the VHPA. No volunteer can be a member of the Executive Council, a Committee Chairman, or a candidate of any office being decided at the Annual Business Meeting. The room will be "sealed" during the entire election process.

Ballots will have the names of each candidate, in order of declaration for office, listed on them. Ballots will be passed out by the election volunteers after all candidates for that office have spoken, marked by circling the name of the candidate to receive the member's vote and collected by the election volunteers.

The election for Junior Member at Large will be conducted first. The election for Vice President will follow the completion of the first election.

All candidates must be present at the Annual Business Meeting.

The order of candidate speaking will be determined by random draw prior to the start of the Annual Business Meeting.

Each candidate for office will be allotted two (2) minutes to speak to the member present and voting.

If there are three (3) or more candidates seeking the same office, a candidate must receive more than fifty (50) percent of the votes to win. If no candidate receives more than fifty (50) percent of the votes, a runoff between the two (2) candidates with the most votes will be held. The only exception to this rule will be if two or more candidates tie with the same number of votes for second place and the candidate with the most votes does not receive more than fifty (50) percent of the votes cast, all three (3) candidates will be in the runoff. If there is only one candidate for an office, the election of that candidate shall be done by voice vote.

Ballots will be taken from the Annual Business Meeting by the election volunteers under the supervision of the EC Election Coordinator, sorted by the election volunteers, counted by the election volunteers and the counts give to the EC Election Coordinator. The EC Election Coordinator will verify the count totals and add the vote totals of each election.

The EC Election Coordinator will announce the results.

All ballots and result sheets will be kept at VHPA for one (1) year.

An active member is not required to register for or attend the VHPA Annual Reunion to attend the Annual Business Meeting and vote in the elections of VHPA officers. However, active members not registered at the Reunion must check in at the Registration desk and pick up an admittance ticket for the Annual Meeting prior to the start of the action election process.

Policy spells out investment rules

Vietnam Helicopter Pilots Association Investment Policy

It is the policy of the Association that excess funds shall be invested in a manner which will provide the highest investment return commensurate with a reasonable level of risk while meeting the cash flow needs of the Association.

Scope

This investment policy shall apply to all financial assets identified as excess, that is, all funds not needed for the day to day operation of the Association.

Generally, these are funds that the Association will not need for at least one year. Income from the investment of these funds may be used to fund current operating expenses at the discretion of the Executive Council (EC) or it's delegate.

It is the intent of the Executive Council that the principal be reserved for investment purposes and not used to pay current expenses.

Investment Objectives

Safety

While safety is a consideration in making investment decisions, it is not to be interpreted as meaning that no risk is acceptable in managing these funds, but that risk should be commensurate with a reasonable expectation of reward.

The Council is willing to accept the risk of negative returns on it's equity investments for periods of time up to one year in exchange for the potential of superior performance over time as measured against appropriate market indices.

Assets should be allocated between moderate and low risk investments in a manner best designed to achieve this purpose.

Liquidity

While it is not anticipated that these funds will be required to meet current operating expenses, sufficient liquidity should be maintained to meet those requirements that might be reasonably anticipated.

Return on Investment

Subject to the foregoing constraints, the Council will strive to maximize the return on the portfolio while assuming a moderate level of investment risk.

To obtain this objective, diversification is required in order to insure that potential losses on individual securities do not expose the entire portfolio to excessive risk of loss.

Prudence

In managing it's portfolio, investments shall be made with the judgment and care, under circumstances then pre-

vailing, that persons of prudence, discretion and intelligence exercise in the management of their own affairs.

Delegation of Authority

Authority to manage the Council's investments is delegated to the Investment Advisor, with the advice and consent of one other person appointed by the EC.

In the absence of the person so appointed, the advice and consent of the President or Secretary-Treasurer of the VHPA shall be obtained prior to implementing any investment recommendation.

Ethics and Conflicts of Interest

Investment Committee members shall refrain from personal business activity that could conflict with the proper execution of the investment program or impair their ability to make impartial investment decisions. Members should disclose any material financial interest they have in a matter before the council.

Authorized and Suitable Investments

1. Bonds, securities and other obligations of the United States or an agency or instrumentality of the United States; as well as corporate debt securities of U.S. corporations rated BBB or higher by at least two rating agencies;

2. Certificates of Deposit, savings accounts, checking accounts and other deposit accounts of financial institutions insured by the FDIC, FSLIC, NCUIC or SIPIC;

3. Commercial Paper, Repurchase Agreements and Bankers Acceptances of United States Banks;

4. Equity securities traded on the NYSE, AMEX and NASDAQ exchanges;

5. Mutual Funds and Investment Trusts with the authority to invest only in those vehicles which are otherwise authorized for direct investment by the Association;

6. Such other investments as may, from time to time, be deemed appropriate by the EC;

7. At no time shall more than 50 percent of the portfolio be invested in any single asset class with the exception of cash or near cash investments.

Investment Performance

The investment advisor shall provide performance information quarterly and at such other times as requested by the EC.

The performance analysis will include information regarding year-to-date returns and time weighted returns adjusted for deposits to and withdrawals from the account. Information regarding the performance of appropriate indices most nearly representative of the funds investment posture shall also be provided, to the extent possible.

Registration enforcement policy under review

VIETNAM HELICOPTER PILOTS ASSOCIATION National Annual Reunion Registration and Enforcement Policy

This document sets forth the policy of the Vietnam Helicopter Pilots Association (VHPA) regarding registration for the VHPA National Annual Reunion and our enforcement of reunion registration.

Much of this policy has always been in effect and the purpose of this document is to express that policy in writing in a singular source, along with establishing some procedural matters related thereto.

REUNION REGISTRATION

The following procedures are hereby adopted for reunion registration for those who wish to register and attend a VHPA National Reunion. The foundation for these rules resides in (1) a portion of the membership dues being used to pay for much of the reunion overhead and (2) the registration fee being used to pay for specific reunion overhead and to underwrite some reunion events. All registered individuals and vendors shall receive a registration badge, appropriate to their registration classification.

Member and Guest Registration

Payment of membership dues includes the RIGHT to register for and attend a reunion. Therefore, only VHPA members-in-good-standing shall be allowed to register for a reunion; they shall also be allowed to register eligible guests.

If a member's guests are over the age of 18, the registration fee for them shall be paid, regardless of the number of events they will be attending. (The remainder of this section is currently under review)

Non-member pilots who are eligible for membership in VHPA shall not be allowed to attend as the guest of a VHPA member. They must become members and register themselves. Likewise, a member shall not be allowed to

attend as the registered guest of another member.

Terminated members are not eligible to register for or attend a reunion and shall not be allowed to attend as the guest of another member.

REUNION REGISTRATION ENFORCEMENT

Have controlled access, with the exception of the registration area(s), vendor area, mini-reunions, and any other areas designated as non-access controlled. A registration badge, whether standard or restricted All areas — as defined in Paragraph 3, above — under VHPA control shall access, shall be required for access to these areas.

Members and eligible members of the Vietnam Helicopter Crewmembers Association (VHCMA), who are not registered guests of a VHPA member, shall be provided access to some controlled-access areas — such as bars and lounges — under the following conditions.

Such individual shall be referred to Registration prior to granting access. Upon presentation of a current VHCMA Membership Card, Registration shall issue a restricted access badge to the individual.

In the case where an individual does not have his VHCMA Membership Card and indicates that he is eligible for VHCMA membership or is a member of VHCMA, Registration shall have him complete the VHCMA Application Form and collect the VHCMA dues.

The individual shall then be issued a restricted access badge and provided with a copy of his completed VHCMA application to serve as his VHCMA receipt. VHPA Headquarters shall forward all collected dues and applications to the VHCMA after the reunion.

In the case of military veterans who are not eligible for membership in either VHPA or VHCMA, and are not registered guests of a VHPA member, they shall be provided access to some controlled-access areas, such as bars and lounges under the following conditions.

Such individual shall be referred to the Chairman, NRC (or his designated representative), prior to granting access. The Chairman will attempt to screen out "wannabe's."

If the Chairman is satisfied that the individual is authentic, he shall instruct Registration to issue the restricted access badge described in Paragraph 5.a, above. The Chairman may, optionally, suggest that the individual register for the reunion as his guest.

Amending

Bylaw, articles changes require rules

POLICY AND PROCEDURE FOR AMENDING THE VHPA BYLAWS AND ARTICLES OF INCORPORATION

The VHPA EC hereby establishes the following policy and procedure for amending the VHPA bylaws and articles of incorporation. This is intended as a supplement to the provisions in the bylaws pertaining to bylaw amendments, and to the provisions in the articles pertaining to article amendments.

Nothing herein shall be construed in a manner that would contradict the provisions of the bylaws or the articles.

Any current member of the VHPA may propose an amendment to the VHPA bylaws. The VHPA is incorporated in Kansas, the laws of which require that all amendments to the articles be proposed by the EC.

In accordance with the articles and the bylaws, all proposed amendments to the articles and the bylaws must be submitted to the membership for approval.

Proposed bylaw amendments should be mailed or delivered to HQ VHPA as soon as possible, but must be postmarked or hand-delivered to HQ VHPA or any VHPA Officer by the deadline set forth in the bylaws.

A motion to amend the articles must be approved and adopted by the EC no later than the deadline set forth in the bylaws for bylaw amendments. As of the date of adoption of this policy by the EC, the deadline is currently 90 days prior to the date of the annual business meeting or special meeting at which the proposal is to be considered.

Proposed amendments received or adopted after the deadline will be deemed to have been submitted for approval at the annual business meeting for the following year.

For clarity, submitted bylaw amendments should state the existing bylaw provision followed by the proposed amended bylaw provision. However, no proposed amendment will be rejected for failure to state the current bylaw provisions.

Notice of the proposed articles or bylaw amendment and its availability for review on the VHPA website will appear in the next newsletter, or the following newsletter if the deadline for the next newsletter has passed on the date of receipt of the proposed amendment at HQ VHPA.

To avoid misunderstanding regarding the agenda of the pending annual or special meeting, a proposed amendment received or adopted after the deadline will appear in the first newsletter following the pending meeting, and will not appear on the website until publication of the notice.

If, for some unforeseen reason, the submitted proposed bylaw change is received in accordance with this policy but can't be noticed to the membership in a timely manner using the next scheduled newsletter, the EC reserves the right to notice the members through an alternate means of the EC's choosing.

Upon publication of the notice, a link to the secure portion of the website where the complete text of the proposed amendment is posted will appear on the home page of the VHPA website.

The secure site will include an area for discussion, both pro and con, of the proposal.

Only comments that are pertinent to the merits of the proposed amendment will be posted. Derogatory personal comments or comments that are offensive in nature or language will not be posted.

In the interest of focusing relevant commentary on proposed amendments to the designated site on the VHPA website and to avoid the potential appearance of any VHPA association with or support for unrelated websites, links to non-VHPA websites or comments referring to links to other such websites will not be posted.

Members, for or against the proposed bylaw change, shall not be allowed to place information in the registration packets.

The proposed amendment will be placed on the agenda of the annual business meeting as "new business." The time allocated for each agenda item of old and new business will be determined by the EC prior to the meeting.

The proponent of a bylaw amendment may withdraw the amendment at any time before notice is published in the newsletter.

After notice has been published, the proponent may request withdrawal of the proposal. Notice of intent to withdraw the proposal will be posted in the next newsletter and on the website. If no objection to the withdrawal is received from a current member by HQ VHPA within 30 days of the mailing of the newsletter containing the notice of withdrawal, the proposal will be dropped from the meeting agenda.

A request to revise a proposed bylaw amendment already submitted will be treated as a new proposal together with a request to withdraw the prior proposal, and the above procedures will apply.

The EC may withdraw a proposed amendment to the articles at any time, but may not propose a new amendment or make new modifications to a proposed amendment after the deadline set forth in the bylaws for bylaw amendments.

Policy establishes access to records

Policy for Disclosure of Financial Records

Requests have been received from a few members seeking the financial records of the VHPA.

In response, the following Policy has been adopted by your Executive Council to provide a reasonable balance between the interests of the VHPA and of its members who request an opportunity to review those records.

The goal of this Policy is to provide reasonable access to the financial records of the VHPA to members on request, subject to the VHPA's right to recover the costs of such requests, to protect any information in VHPA records that was obtained from third-party vendors or other providers in exchange for a promise of confidentiality, and to protect the VHPA staff and resources from being unnecessarily overtaxed by excessively overbroad or burdensome requests for information that are more in the nature of fishing expeditions than reasonable requests for information relevant to particular issues or matters of interest.

In accordance with IRS requirements, the VHPA makes its Form 990 (Annual Information Return) available for inspection at its Headquarters offices in Citrus Heights, California.

This form and supporting documents, kept on file with the IRS for three years, may be viewed during normal business hours. While no federal or State of Kansas obligation requires nonprofit veterans' organizations to provide access to their financial records or information, the VHPA voluntarily provides the membership access to its financial records in accordance with this Policy.

The VHPA voluntarily posts the current year's Auditor's Report and Statement of Financial Position. Please avail yourselves of the opportunity to examine the records

on our VHPA website (www.vhpa.info). They are open and available to any current member in good standing.

Requests for information beyond that which is provided at VHPA headquarters and the website will be considered on a case-by-case basis.

Blanket requests for all financial records for past years, including check registers, contracts, all submittals to accountants, etc., will not be honored.

Unlimited requests for financial records without regard to time or scope and without reference to particular issues or points in question are overbroad, unduly burdensome, and could result in unintentional release of confidential information.

Requests for information concerning particular issues, points of interest, or particular documents will be considered when the question arises. In all such cases, the requesting party will be required to pay a reasonable charge for assembling, providing, and copying the records.

The requested information or an explanation of why it is not produced will be provided to such persons.

Every effort will be made by the administrative staff to accommodate requests in compliance with this policy. Any member in good standing may also pose questions following the financial report during the annual business meeting.

Each of us could recruit new member or pay dues

Our Association is growing every year. As of the mailing of this *Newsletter*, VHPA has more than 7,500 dues current regular and life members.

During the past 20 years, more than 12,500 of our fellow pilots have been active members at one time or another.

Unfortunately, some 500 plus of this number have passed away since joining. Others have come in to the Association and then dropped out for some reason.

If you subtract the more than 2,100 of our number who were killed in action, the over 4,000 we know of that have died since their service in Vietnam and the 12,500 who have been members of VHPA at one time or another, Gary Roush estimates there are approximately an additional 22,000 individuals eligible to become members of VHPA.

And Gary is never wrong.

This means somewhere around 50 and 55 percent of those who could be eligible are not and never have been members of our Association.

We — you and I — need to change this.
I have an idea.

Here is my suggestion. Each one of us needs to either get one NEW GUY to join VHPA or pay for one NEW GUY to become a member during the next year.

The \$36 membership fee is not that much money. Pick out a guy you care about, someone you served with, went to flight school with, saved your ass when it needed saving. Don't tell him you're doing it. Just do it. Go crazy, sign him up or three years.

If we add one NEW GUY each, VHPA active membership doubles.

Now, wouldn't that be something? Some 15,000 active members.

Also, if there is a former member you would like to see back in the Association, contact him about getting involved again or sign him up yourself. HOWEVER, this shouldn't take the place of your NEW GUY.

RESTATED ARTICLES OF INCORPORATION

OF

VIETNAM HELICOPTER PILOTS ASSOCIATION

I, the undersigned incorporator, hereby form and establish a corporation NOT FOR PROFIT under the laws of the State of Kansas.

ARTICLE FIRST

The name of this corporation is Vietnam Helicopter Pilots Association.

ARTICLE SECOND

The location of its registered office in this state is 302 Broadway, in the City of Cottonwood Falls, County of Chase, Kansas 66845-0000. The resident agent at this address is Charles R. Rayl.

ARTICLE THIRD

This corporation is organized NOT FOR PROFIT and the objects and purposes to be transacted and carried on are:

1. The general purposes of the corporation are to operate solely and exclusively as a charitable, scientific, literary, educational, or veterans organization and to specifically engage in all associated activities, including one or more of the following:

EXHIBIT Z

Policy establishes access to records

- a. To enhance and accredit the cohesiveness, esprit de corps, and traditions of valor of rotary wing aircrews that flew in Southeast Asia during the Vietnam Era.
- b. To seek out, using whatever means available, individuals who piloted rotary wing aircraft in Southeast Asia during the Vietnam Era and inform them of the existence of the VHPA and encourage all eligible individuals to become members.
- c. To promote and perpetuate the bonds of brotherhood that bind a group of men who have shared and survived an experience fraught with danger yet filled with the essence of pride and satisfaction – an experience unshared except by these unique men.
- d. Assisting needy and disabled veterans, widows and orphans of deceased veterans.
- e. Providing entertainment, care and assistance to current members of the Armed Forces and veterans of the Armed Forces.
- f. Promoting social welfare in the community.
- g. Perpetuating the memory of veterans and comforting their survivors.
- h. Conducting programs for charitable, literary and education purposes.

- I. Sponsoring and participating in patriotic activities.
- j. Providing social and recreational activities for members.
- k. Any and all other allowed general purposes authorized for not-for-profit corporations under Kansas statutes.

2. To further such objects and purposes, the corporation shall have and may exercise all the powers conferred by the laws of the State of Kansas upon corporations formed under the laws pursuant to and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended. Specifically, this corporation shall have power to acquire, purchase, hold, lease, convey, mortgage and pledge such real and personal property in Kansas, other states of the United States and elsewhere, as shall be necessary or convenient to the transaction of its business and the realization of its objects and purposes.

PROVIDED, HOWEVER, that in all events and under all circumstances, and notwithstanding merger, consolidation, reorganization, termination, dissolution, or winding up of this corporation, voluntary or involuntary or by operation of law, the following provisions shall apply:

- a. This corporation shall not have or exercise any power or authority either expressly, by interpretation, or by operation of law, nor shall it directly or indirectly engage in

any activity that would prevent this corporation from qualifying (and continuing to qualify) as an organization described in 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue statute) or as an organization of war veterans described in 501(c)(19) of the Internal Revenue Code.

b. This corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.

c. No compensation or payment shall ever be paid or made to any member, officer, director, trustee, creator, or organizer of this corporation, or substantial contributor to it, except as an allowance for actual expenditures or services actually made or rendered to or for this corporation; and neither the whole nor any portion of the assets or net earnings, current or accumulated, of this corporation shall ever be distributed to or divided among any such persons; provided, further that neither shall ever be used for, accrue to, or inure to the benefit of any member or private individual within the meaning of §501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law).

3. Upon the dissolution of this corporation the governing body shall obtain or make a provision for the payment of all liabilities of the corporation, and dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organization

or organizations organized and operated exclusively for charitable, education, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under 501(c)(3) of the Internal Revenue Code of 1986 or qualify under 501(c)(19) of the Internal Revenue Code, to the extent such distribution is allowed by law and to the extent that allowing such distribution will not prevent the receipt of donations by this corporation of contributions that are deductible by the donor as charitable contributions under the Internal Revenue Code, as the governing board shall determine. Any assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation is located, exclusively for the purposes or to such organizations, as said court shall determine, which are organized and operated exclusively for the aforesaid purposes.

ARTICLE FOURTH

The corporation will NOT have authority to issue capital stock, and the conditions of membership shall be fixed by the bylaws. Members may vote only in person and no Member shall be entitled to vote by proxy.

ARTICLE FIFTH

The Board of Directors shall have all powers granted by Kansas law and statutes. The Board of Directors may, from time to time, conduct their business and operate under the name "Executive Council of the Vietnam Helicopter Pilots Association" and in all matters the corporation's Board of Directors and its Executive Council shall be considered one and the same.

ARTICLE SIXTH

No director shall be personally liable to the Corporation or its members for monetary damages for any breach of fiduciary duty by such director as a director. Notwithstanding the foregoing sentence, a director shall be liable to the extent provided by applicable law (i) for breach of the director's duty of loyalty to the Corporation or its stockholders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under the provisions of K.S.A. 17-6424 and any amendments thereto, or (iv) for any transaction from which the director derived an improper personal benefit. No amendment to or repeal of this Article shall apply to or have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior to the date when such provision becomes effective.

In addition and not in derogation of the foregoing paragraph of this Article Sixth, the Corporation shall indemnify any past, present or future director or officer made a party, or threatened to be made a party, to any threatened, pending or completed action or proceeding, whether civil, criminal, administrative, or investigative, which is brought to impose a liability on such person for an act alleged to have been committed by such person in his or her capacity as director or officer of the Corporation, or as director, officer, employee or agent of any other entity which he or she served at the request of the Corporation against judgments, amounts paid in settlement and reasonable expenses, including attorneys' fees, actually and necessarily incurred as a result of such action or proceeding or any appeal (but not for taxes, penalties or fines), if such person is either successful in his or her defense or if the proceeding is terminated by settlement (or

nolo contendere if a criminal matter) or if such person acted in good faith in the reasonable belief that such action was in the best interests of the Corporation, or if in criminal actions or proceedings, such person acted without reasonable ground for belief that such action was unlawful. Fees and expenses may be paid in advance of final disposition of such actions, proceedings or suits upon an undertaking by or on behalf of the directors and officers, that if it is ultimately determined that he is not entitled to such indemnification as authorized by this resolution then all fees and costs advanced shall be refunded. The indemnity shall not be extended to include any and all acts by parties acting in the capacity as directors, members, officers or agent of Chapters of the Corporation as "Chapters" are permitted, provided and allowed under the Corporation's Bylaws, as such Bylaws are from time to time amended.

ARTICLE SEVENTH

The term for which this corporation is to exist is perpetual.

ARTICLE EIGHTH

No member of this corporation shall benefit financially from the dissolution thereof. In the event of dissolution of this corporation, the assets of this corporation shall be distributed as set forth in ARTICLE THIRD hereof.

ARTICLE NINTH

The name and resident of the incorporator is:

ARTICLE TENTH

The Corporation shall have seven directors. The Board of Directors shall sometimes be referred to as the "Executive Council" and the directors shall sometimes be referred to as "members of the Executive Council." The Executive Council shall be comprised of the Corporation's President, Vice President, three members at large and the immediate Past President all of which being elected and, if appropriate, appointed according to the Corporation's Bylaws. The seventh member of the Executive Council shall be selected by the other six members and shall serve at the Executive Council's pleasure.

Bylaws of the VHPA

CHAPTER 1 — NAME

This Association shall be known as the "Vietnam Helicopter Pilots Association," hereinafter referred to as the "VHPA." It is an organization for all helicopter pilots who flew helicopters in Southeast Asia during the Vietnam Era, (1961-1975).

CHAPTER 2 — OBJECTIVES

The VHPA is dedicated to the fulfillment of the following purposes:

1. To enhance and accredit the cohesiveness, esprit de corps, and traditions of the valor of rotary wing pilots who flew helicopters in Southeast Asia during the Vietnam Era.
2. To seek out, using whatever means available, individuals who piloted rotary wing aircraft in Southeast Asia during the Vietnam Era and inform them of the existence of the VHPA and encourage all eligible individuals to become members.

CHAPTER 3 — OPERATION

1. The VHPA will operate on a calendar year basis.
2. The VHPA shall operate as a not for profit organization.
3. An annual audit will be conducted by a recognized financial agency selected by the Executive Council.
4. The VHPA shall not engage in partisan politics or endorse political parties, candidates, or public officials. Nothing herein shall restrict individual members from being individually engaged in political activities, political parties, or political office. However, members may not mention their membership in the VHPA when involved in such political activities, political parties, or political office in a manner so as to imply endorsement by the VHPA.

CHAPTER 4 — MEMBERSHIP

1. Pilots who flew helicopters in Southeast Asia during the Vietnam Era are eligible for membership.
2. Members shall be classified as Life, General, and Honorary.
3. Membership classifications are as follows:
 - a. Life membership will be conferred upon an individual eligible for membership, who pays a specified amount of dues as directed by the Executive Council and approved by the general membership.
 - b. General membership will be conferred upon an individual eligible for membership, who annually pays a specified amount of dues as directed by the Executive Council and approved by the general membership.
 - c. Honorary membership is open to distinguished persons, such as aviation pioneers, guest speakers at annual reunions, and aviation dignitaries. Honorary memberships must be voted upon by the Executive Council. Honorary memberships shall be conferred for life by the Executive Council. Honorary members shall not be required to pay dues nor shall they be permitted to vote at membership meetings.
4. In order to vote or participate in any VHPA election or petition, or to be elected or serve as a VHPA officer or on its Executive Council or to participate in VHPA offices, functions and/or meetings, or to be included within a quorum of membership, a member must be current in his VHPA dues.

CHAPTER 5 — EXPULSION FROM MEMBERSHIP

1. Members of any classification, including elected and appointed officials of the VHPA, may be expelled for cause or conduct which the Executive Council deems contrary to the best interest of the VHPA or interferes with the fulfillment of the pur-

pose of the VHPA.

2. General members shall be suspended for nonpayment of annual dues and shall be dropped from the active membership roster until dues are brought current.

CHAPTER 6 — ORGANIZATION OF THE ASSOCIATION

1. The officers of the VHPA shall be as follows:
 - a. President
 - b. Vice President (who shall be President-Elect and who shall succeed the President).
 - c. Three Members at Large.
 - d. The Immediate Past President.
2. The Executive Council shall consist of seven members as follows:
 - a. President.
 - b. Vice President.
 - c. Three Members at Large.
 - d. The Immediate Past President.
 - e. Secretary/Treasurer.
3. Holding office, or other positions of influence and trust, shall be limited to members who are current in their dues.
4. Committees
 - a. The VHPA may have standing committees whose duties and responsibilities are outlined in the job descriptions and policy statements recommended by the current President and approved by the Executive Council.
 - b. Vacancies for the chairmanship of all committees will be filled by appointment by the President.
 - c. All appointments to the chairmanship of committees are subject to ratification by the Executive Council.

CHAPTER 7 — ELECTION OF OFFICERS

1. A Vice President and a Junior Member at Large shall be elected by a majority vote of those members present and voting at the annual reunion business meeting.
2. A Vice President shall be elected to a consecutive three year term on the Executive Council. The first year he will be Vice President. The second year he will be the President. The third year he will be the Immediate Past President.
3. Members at Large shall be elected to a consecutive three year term on the Executive Council. The first year he will be the Junior Member at Large. The second year he will be the Midterm Member at Large. The third year he will be the Senior Member at Large.
4. Individuals newly elected to office shall assume duties of that office at the close of the annual reunion.
5. Individuals already holding office shall advance to the next position of their term at the close of the annual reunion.
6. Officers shall be elected by members using written ballots.

CHAPTER 8 — VOTING

1. All members who are current in their dues (with the exception of the honorary members) are eligible to vote.
2. Members, in attendance at a meeting or special meeting, are eligible to vote. Proxy voting of members shall not be permitted.
3. Only life members and general members who are current in their dues shall be eligible to vote in VHPA matters. A list of members entitled to vote shall be reasonably made available on premises at the time and place at which a vote of the VHPA is

conducted.

CHAPTER 9 — MEMBERSHIP MEETINGS

1. There shall be an annual reunion of the VHPA. This annual reunion shall also serve as the annual meeting of the VHPA membership.

2. The annual reunion shall be conducted at a place and time determined by the Executive Council.

3. The Executive Council shall announce the date and place for the next year's annual reunion at each annual reunion.

4. In the event of a national or natural emergency, the Executive Council shall have the authority to cancel or postpone annual reunions.

5. Special meetings of the membership may be called by either a two-thirds vote of the Executive Council or by the Executive Council upon it being presented a petition signed by one-third of the VHPA's members. Notice of a special meeting shall state the time and date of the meeting (which shall be no less than 45 days after the date such notice is posted) and shall further specify, in reasonable detail, all matters to be considered at the meeting. For purposes of the travel convenience of the members, all special meetings will be held in Kansas City, Missouri.

6. The presence of three percent (3%) of the membership at an annual meeting shall constitute a quorum. The presence of six percent (6%) of the membership at a special meeting shall constitute a quorum.

CHAPTER 10 — RESPONSIBILITY AND AUTHORITY OF THE EXECUTIVE COUNCIL

1. The board of directors shall have all powers granted by Kansas law and statutes. The board of directors may, from time to time, conduct their business and operate under the name "Executive Council of the Vietnam Helicopter Pilots Association" and in all matters the corporation's board of directors and its Executive Council shall be considered one and the same. It shall be responsible for the management of the affairs of the VHPA, including funds, programs, and regulations. It shall have the authority to approve budgets, authorize expenditures, seek and accept contributions, and approve annual meeting sites and program arrangements.

2. Unless otherwise specifically provided herein a majority opinion of the Executive Council shall prevail in all matters pertaining to the VHPA.

3. The Secretary/Treasurer shall have a vote only as a tiebreaker.

4. In addition to business conducted at the annual reunion, there shall be a minimum of three quarterly conference calls made by the Executive Council between annual reunions for the purpose of conducting VHPA business. Said calls are to be conducted at a time that is convenient for the majority of the Executive Council and may be called by any officer. The presence of four members of the Executive Council shall constitute a quorum. The President or Secretary/Treasurer shall have the authority to initiate additional conference calls as deemed necessary.

5. The Executive Council may delegate authority and functions to the Secretary/Treasurer or specific members of the VHPA.

6. The Executive Council shall perform such other duties as are prescribed by these Bylaws.

7. The Executive Council may upon motion go into executive session for purposes of discussion, voting and taking action on the following matters:

a. Legal actions or litigation (except that votes, minutes and settlement agreements must be open to the public on final disposition unless ordered closed by a court of competent jurisdiction).

b. Leasing, purchase or sale of real estate and/or negotiations of bids or contracts where general knowledge might adversely affect the amount paid in the transaction.

c. Hiring, firing, disciplining or promoting a particular employee.

d. Disciplinary and/or expulsion of any member.

The motion calling for the session must state the reason for going into executive session. The Executive Council may exclude the membership from such session and the minutes and records of such session need not be disclosed to members who are not members of the Executive Council until the applicable matter is disposed, no longer an issue, finally decided or concluded. Executive session may only be called during a properly convened meeting of the Executive Council and a record shall be made of all motions and votes calling for an executive session.

CHAPTER 11 — DUTIES OF OFFICERS

1. The President shall preside at all meetings of the VHPA and all Executive Council meetings.

2. The President shall appoint or remove a committee chairman subject to ratification by the Executive Council.

3. The duties of the officers shall be those which are customary for such office and such other functions as may be prescribed by the Bylaws of the VHPA, the Executive Council, and written job descriptions.

CHAPTER 12 — SECRETARY/TREASURER

1. The Secretary/Treasurer shall be a member and shall be appointed or removed at the pleasure of the Executive Council.

2. The Secretary/Treasurer will be responsible for signing all checks for debts incurred by the VHPA along with the President of the VHPA (and in the President's absence, the Vice President or the Immediate Past President).

CHAPTER 13 — EARLY SUCCESSION TO OFFICE

1. Should the President resign, become incapacitated, or otherwise be unable to fulfill the duties of the Presidency, then the Vice President (President-Elect) shall succeed him as President for the remainder of the resigning or incapacitated President's term. At the completion of the resigning or incapacitated President's term, the President shall begin serving the term of the Presidency for which he was initially elected. The position of Vice President shall remain vacant until the annual reunion.

2. Should the Vice President resign, become incapacitated, or otherwise be unable to fulfill the duties of the Vice Presidency, the position of Vice President shall remain vacant for the duration of the term of the resigning or incapacitated Vice President. A President and a Vice President shall be elected at the next annual reunion.

3. Should both the President and the Vice President resign or become incapacitated, then the Senior Member at Large shall assume the duties of the Presidency (become the Acting President) for the remainder of the term of the President who has just resigned or become incapacitated, but shall not automatically succeed to the position of President after his term of Acting President has expired. A President and Vice President shall be elected at the next annual reunion with the new President's one year term

beginning at the close of the annual reunion. The Immediate Past President shall serve one additional year on the Executive Council.

4. Should the Senior Member at Large resign, become incapacitated, or become the Acting President, then the following shall automatically take place:

a. The Midterm Member at Large shall immediately become the Acting Senior Member at Large. He shall remain the Acting Senior Member at Large until he succeeds to the position of Senior Member at Large under the terms to which he was initially elected.

b. The Junior Member at Large shall immediately become the Acting Midterm Member at Large. He shall remain the Acting Member at Large until he succeeds to the position of the Midterm Member at Large under the terms to which he was initially elected.

5. Should the Midterm Member at Large resign, become incapacitated, or become the Acting Senior Member at Large, the Junior Member at Large shall immediately become the Acting Midterm Member at Large. He shall remain the Acting Midterm Member at Large until he succeeds to the position of Midterm Member at Large under the terms to which he was initially elected.

6. Should the Junior Member at Large resign, become incapacitated, or become the Acting Midterm Member at Large, the President or Acting President shall offer the position of Acting Junior Member at Large to any qualified previous Executive Council member to be ratified by the Executive Council.

7. Should the Immediate Past President resign, become inca-

pacitated, or otherwise be unable to fulfill the duties of the Immediate Past President, the President or Acting President shall offer the position of Immediate Past President to any qualified previous Executive Council member to be ratified by the Executive Council.

CHAPTER 14 — CHAPTERS

1. Chapters may be recognized by the Executive Council. The Executive Council may revoke recognition of any Chapter for conduct of the Chapter or its officers or directors which the Executive Council deems contrary to the best interest of the VHPA or conduct which interferes with the fulfillment of the purposes of the VHPA.

2. Chapters are independent entities and are not and shall not be agents or partners of VHPA. Neither VHPA nor any Chapter shall have the right to contract for the other or bind the other to any contract without express prior written authorization.

3. VHPA shall not be liable for the actions or inactions of the local VHPA Chapters and the local VHPA Chapters shall not be liable for the actions or inactions of or by the VHPA.

CHAPTER 15 — BYLAW AMENDMENTS

1. Proposed amendments will be submitted to the VHPA or any VHPA officer 90 days prior to the annual meeting or special meeting at which they will be considered.

2. The adoption of the amendment(s) at a meeting of the VHPA shall be by two-thirds majority of the members present and voting. Unless otherwise stated in the amendment(s), all amendments to these Bylaws shall be effective the day following the conclusion of the meeting at which they were adopted.

Rules determine refunds on reunion events

No refund will be given for any reunion fee or event unless the member cancels the registration by faxing [REDACTED] e-mailing (hq@vhpa.org), calling VHPA Headquarters (1-800-505-VHPA), or by U.S. mail.

Headquarters must receive notification by any of the above means no later than (insert date approximately 7 days prior to the first day of the reunion; to be determined for each reunion). After this date we have given firm commitments and guarantees to the hotel and others in your name that generate non-refundable expenses to our Association.

Donations, T-shirt orders and Reunion events identified as "Non Refundable Events" are not refundable.

There will be a \$10 cancellation fee charged for each refund request, regardless of the number of items (dinners, golf tournament, registration fee, etc.) included in the request.

T-shirts ordered and not picked up will be mailed and shipping charges deducted from the refund.

Each refund request received prior to the above time and date will be assigned a refund request confirmation number on the day the request is received by VHPA Headquarters, and a credit will be issued to your credit card by the third week of July (two weeks after the end of the reunion).

Members eligible for a refund who originally paid by check will be reimbursed by check timed to arrive by the end of July (three weeks after the end of the reunion).

Host hotel room charges

Notice of hotel reservation cancellations must be made directly to the (Insert Host Hotel Name) reservations system at (Insert phone number) by (Insert date x days prior to the first reunion date). Cancellations after this date will result in hotel charges to you equivalent to one night's room charge, plus applicable taxes. Should you need to cancel your reservation, please ensure you get and keep a cancellation number for your records.

Also, as a courtesy and to avoid any potential, non-reimbursed reunion fees (see above), please also let our Headquarters staff (1-800-505-VHPA) know that you have canceled. Please note that members who check out earlier than scheduled, without notifying the hotel at time of check in, will incur a \$50 administrative fee penalty plus one night's room charge and tax payable to the hotel.

The hotel policy is that you may shorten the length of your stay by requesting so at the time of check in without penalty, however an early check out after that time will result in being charged the \$50 fee plus a penalty of one night's room and tax.
