(These instructions are an integral part of the basic order.)

- FR-1. Enlisted man attached for rations, quarters, administration and administration of Uniform Code of Military Justice.
- FR-2. Upon completion of training, individual will return to permanent station.
- FR-3. Class II flight physical to be accomplished 75 days prior to arrival in overseas command.
- FR-4. One year service obligation incurred under provisions of AR 350-100 and DA Pam 350-10.
- FR-5. Two years service obligation incurred under provisions of AR 350-100 and DA Pam 350-10. In addition, para 4-18a(2), AR 635-100, applies with reference to retirement.
- FR-6. Under provisions of AR 600-105, this is a category A aviation assignment.
- FR-7. Under provisions of AR 600-105, this is a category B career development assignment.
- FR-8. Assignment is for the purpose of release from active duty.
- FR-9. If an emergency occurs while you are on leave that will make it necessary to readjust port call date, report to the nearest military installation and arrange to call Fort Rucker over Automatic Voice Network (AUTOVON). Fort Rucker AUTOVON number is 899-1450, extension 5215 or 3907. If AUTOVON facilities are not available, collect commercial calls are authorized to: Area Code 205, phone numbers 255-5215 or 255-3907. Have a copy of your orders available for reference during the conversation.
- FR-10. Individual clothing and equipment requirements contained in Appendix C, USAAVNC Reg 612-3, will be complied with prior to departing Fort Rucker for RVN.
