

a. Exclusive right in the English language, in the United States of America, its territories and possessions (including United States military installations throughout the world), the Philippine Republic, and Canada and (referred to as Publisher's "exclusive area"), and non exclusive right in all other countries except the British Commonwealth (other than Canada), the Republic of South Africa and the Irish Republic (referred to as Publisher's "non-exclusive area") to:

- i. print, publish and sell the Work in book form;
- ii. print, publish and sell the Work in adapted, condensed and abridged versions and selections from the Work in anthologies and other publications of Publisher;
- iii. license publication of the Work (in complete, condensed and abridged versions) by book clubs, including affiliates of Publisher;
- iv. license publication of hardcover editions (herein "hardcover license") and hardcover and softcover reprint editions by other publishers (herein "reprint editions") with the approval of Author for each such license granted, such approval not to be unreasonably withheld or delayed. Author shall be deemed to have given approval if within ten (10) days after written notice Author fails to notify Publisher of disapproval;
- v. license publication of the Work (in complete, condensed, adapted or abridged versions) or selections from the Work in anthologies and other publications, in mail order and schoolbook editions, and in other special editions (herein "special editions");
- vi. license publication in each country prior to book publication in each such country, in periodicals, including magazines, newspapers and digest (herein "first serial");
- vii. license publication in each country after book publication in each such country, in periodicals, including magazines, newspapers and digest (herein "second serial") to the extent second serial rights are available;
- viii. publish and, subject to Author's approval in each case, license publication of the Work (in complete, and, subject to Author's approval, in adapted, condensed and abridged versions) (a) in microfilm, microfiche, photocopying (herein "special reproductions"), and (b) in information storage and retrieval systems, and all other non-book forms of copying, distribution or transmission, whether now or hereafter known or developed, intended to make the text of, and any illustrations or photographs contained in, the Work available in visual form for reading (including, but not limited to, electronic or machine-readable media, or on-line electronic or satellite-based data transmission) (herein "Electronic Books");
- ix. publish and, subject to Author's approval in each case, license publication of adaptations of the Work, in whole or in part, for filmstrips, cartoon versions, calendars and for sight-sound devices and in sound reproductions (in complete, condensed, dramatic and non-dramatic versions) (all herein "special adaptations"). Author will have the right of reasonable approval over the contents of Publisher's special adaptations, including any artwork used therein;
- x. to prepare, reproduce, publish and sell, to distribute, transmit, download or otherwise transfer copies of, and, with Author's consent, which consent shall not unreasonably be withheld or delayed, to license the foregoing rights in, electronic versions of the Work (herein "Electronic Versions"). As used herein, Electronic Versions shall mean versions that include the text of the Work and any illustrations contained in the Work (in complete, condensed, adapted or abridged versions, and in compilations) for performance and display (i) in any manner intended to make such Electronic Versions of the Work available in visual form for reading (whether sequentially or non-sequentially, and together with accompanying sounds and images, if any) and (ii) by any electronic means, method, device, process or medium (herein "Electronic Device or Medium"). For the purposes of this subparagraph, Electronic Device or Medium shall include, but not be limited to, all forms of electronic, magnetic, digital, optical and laser-based information storage and retrieval systems, floppy diskette-based software, CD-ROM, interactive software and compact discs, floptical disks, ROM Card, silicon chip and other such systems, on-line electronic or satellite-based data transmission and other such systems, and any other device or medium for electronic reproduction, publication, distribution or transmission, whether now or hereafter known or developed. Notwithstanding the foregoing, the rights to publish or license Electronic Versions pursuant to this subparagraph shall be revocable by Author upon giving written notice to Publisher with respect to any particular Electronic Device or Medium

for which Publisher has not published or licensed or optioned publication, transmission or distribution of any Electronic Versions within five (5) years after first publication of the Work in book form in the United States or after first development of such Electronic Device or Medium in commercially viable form, whichever is later, provided Publisher has received written notice of such revocation before such publication occurs or such license or option is granted.

b. Exclusive right to license, in the English language outside the United States, its territories and possessions, the Philippine Republic and Canada, the rights granted in Paragraph 4.a. above, revocable by Author with respect to each country for which no license or option has been given within two (2) years after first publication in the United States, provided Publisher has received written notice of such revocation before such license or option has been granted.

c. Exclusive right to license, in all foreign languages and all countries the rights granted in Paragraph 4.a. above, revocable by Author with respect to each language or country for which no license or option has been given within three (3) years after first publication in the United States, provided Publisher has received written notice of such revocation before such license or option has been granted.

d. Exclusive right to use or license others to use, subject to the approval of Author for each such use or license, the name and likeness of Author, the Work, the title of the Work and materials and elements from the Work, including characters and illustrations therefrom, in whole or in part, and adaptations of any thereof, as the basis for trademark or trade name for other products and services and any other commercial or merchandising uses in connection with other products or services (herein "merchandising rights").

e. Exclusive right to license performance rights in the Work, including dramatic, musical, radio, television, motion picture and allied rights, subject to Author's consent. In the event of the disposition of performance rights, Publisher may grant to the purchaser the privilege to publish excerpts and summaries of the Work in the aggregate not to exceed 7,500 words, for advertising and exploiting such rights, provided, however, that such grant shall require the purchaser to take all steps which may be necessary to protect the copyright of the Work.

f. All rights not expressly granted to Publisher are reserved to Author.

#### *Style and Price of Publication*

5. Publication of the Work will be at Publisher's option and expense at such time and in such style and manner, under such imprint, and at such price or prices as Publisher deems suitable, whether in a hardcover or paperbound edition or both simultaneously. Final decision as to cover and title of the Work shall be Publisher's. In the event Author is more than one person, Publisher shall determine the order of authorship credits.

#### *Proofreading and Author's Corrections*

6. Author shall read, correct and return any proofs of the Work and Publisher shall charge to Author the cost of alterations in type, plates or film requested by Author and made by Publisher, other than those due to printer's errors, in excess of ten percent (10%) of the charge for composition. If Author fails to return corrected proofs within three (3) weeks after submission, Publisher may elect to treat them as correct, and they shall be deemed approved by Author, with such changes as Publisher elects to make, in accordance with the provisions of Paragraph 2 hereof.

#### *Termination for Lack of Publication*

7. a. If the Work is not published within eighteen (18) months after acceptance of the manuscript, unless delayed by circumstances beyond Publisher's reasonable control, then Author may terminate this agreement at any time thereafter prior to commencement of manufacture of copies of the Work, by ninety (90) days written notice, and unless the Work shall have been published within ninety (90) days after receipt by Publisher of such notice, this agreement shall terminate without further liability on the part of Publisher effective ninety (90) days after such receipt. Publisher's time to publish shall be extended by the period of time publication was prevented by circumstances beyond Publisher's reasonable control.

b. In the event of termination of this agreement by Author in accordance with this Paragraph 7, Author shall be entitled to retain all advances previously paid and to contract with others concerning the Work free of liability to Publisher, except Publisher will be entitled to repayment of its advances from the first proceeds of such contracts with others concerning the Work. All rights granted to Publisher herein shall revert to Author upon the effective date of termination in accordance herewith.

#### *Copyright*

8. After publication of the Work hereunder, Publisher shall copyright the Work in the name of Author in accordance with the United States Copyright Law and in compliance with the Universal Copyright Convention and apply for renewal of copyright if this agreement is still in effect. If any material in the Work by Author shall have been previously published, Author shall notify Publisher promptly and shall deliver a legally recordable assignment to Publisher of the copyright in such material together with the same rights in such material as are granted to Publisher with respect to the Work.

#### *Advance Payments*

9. Publisher shall pay to Author, as an advance against and on account of all sums payable to Author hereunder, the sum of **Seven Thousand Dollars (\$7,000.00)** payable as follows:

- a. \$3,000.00 on signing hereof;
- b. \$2,000.00 on acceptance of the complete and satisfactory manuscript of the Work in conformity with Paragraph 1; and
- c. \$2,000.00 on the official publication date of Publisher's initial edition of the Work.

Author shall not be required to repay such advances except as specifically required by the provisions of this agreement or if Author is in default of Author's obligations under this agreement.

#### *Royalties*

10. a. Publisher agrees to pay to Author a royalty on the retail price or, for any hardcover copies, on the invoice price (see Paragraph 28), of each copy of the Work sold by Publisher, less returns (subject, however, to the provisions and exceptions in this agreement set forth below):

- i. With respect to copies sold by Publisher in a mass-market softcover edition: Six percent (6%) up to and including 150,000 copies; and eight percent (8%) in excess of 150,000 copies.
- ii. With respect to copies sold by Publisher in a trade softcover edition: Seven percent (7%).
- iii. With respect to copies sold by Publisher in a hardcover edition: Ten percent (10%) up to and including 5,000 copies; twelve and one-half percent (12½%) in excess of 5,000 copies up to and including 10,000 copies; and fifteen percent (15%) in excess of 10,000 copies.

b. If the Work is published in more than one of the formats described in Paragraph 10.a. above, the applicable royalty set forth in this agreement shall apply separately to each such publication, and in determining increases in royalty rates based upon whether particular sales levels have been reached, only sales in such format of such publication for which a royalty is payable under the provisions of said Paragraph 10.a. shall be included.

c. One-half (½) of the prevailing royalty rate, based on the amount received by Publisher, with respect to hardcover copies and softcover copies ~~percent (%) with respect to hardcover copies and percent (%) with respect to softcover copies of the amount received by Publisher for copies sold directly to the consumer through the medium of mail order, coupon, radio, television or space advertising, or through Publisher's own book clubs.~~
