1. (C) Operational Summary

A. General

(1) The 2nd Sqdn continued operations under OPCON to 3rd BDE, 1st ACD within it's AO. Primary emphasis was placed on providing a screen south-east of FSB Mace to interdict enemy movement across QL-1 to the South. Special emphasis was placed on the use of radar to cover movement on QL-1. Squadron elements continued to secure the composite Engineers on the Tanh Linh Rd. (Hwy 336)

(5) H Co continued security operations on Hwy 336 until 14 Jan when it conducted maintenance. On 15 Jan H Co commenced its Tactical Road March back to Dian.
