1. (C) SITUATION:

- a. Enemy Forces: See Annex A.
- b. Friendly Forces:

(1) 1st Cavalry Division (AM):

- (a) On 240630H Nov 69, 1st Bde, 1st Cav Div (AM), places two infantry companies (AM) with a command and control group OPCON with 3/11 ACR.
- (b) O/O 8th Engr Bn, 1st Cav Div (AM), provides on order support for 11th ACR operations in War Zone C. (See Annex C- Engineer)
- (c) O/O Div Arty, 1st Cav Div (AM), provides 11th ACR a liaison team to support operations in War Zone C.

(2) Joint Operational Units: Operating jointly with 3/11 ACR, Special Forces CIDG companies will support 11th ACR operations in AO DALLAS with two companies and assist in security of airfield at TONG LE CHON.

c. Attachments & Detachments: Task Org.

2. (C) MISSION: At 240630H Nov 69, 11th ACR will commence area reconnaissance of the Eastern Sector of War Zone C (see Annex D) with one squadron.

3. (C) EXECUTION:

a. Concept of Operations: 3/11 ACR, reinforced, conducts a multiple route, cross country penetration through AO DALLAS along axis of Route 246 executes CAs along Route 246 to clear it of obstacles. On order 1/11 ACR moves to 3/11 ACR AO and prepares for operations in War Zone C. 2/11 ACR continues operations in LOC NINH District and prepares for operations along QL 14A in the direction of BO DUC.

b. 1/11 ACR:

- (1) On order, move to vicinity XT7189 and assume responsibility for 3/11 AO.
- (2) Maintain responsibility for current AO and missions.
- (3) Coordinate with BINH LONG Sector and CO 15th ACR (ARVN) for assistance in AO's.
- (4) Assume responsibility for security of AN LOC-TONG LE CHON Road.
- (5) Be prepared to assist in security of TONG LE CHON Airfield with 1 platoon.
- (6) Be prepared to move into War Zone C to commence operations as required.

c. 2/11 ACR: Continue current missions.

d. 3/11 ACR:

- (1) At 240630H Nov 69 commence combat assaults and ground movement into Eastern War Zone C.
- (2) Following commitment in Eastern War Zone C conduct joint operations with CIDG as required.
- (3) At 240630H Nov 69, accept OPCON of two infantry companies (AM) with a control group, one engineer platoon (AM), 3/919 Engr, and four 6-man mine sweep teams drawn from platoons of 919th Engineer Co.

e. Air Cav Troop:

- (1) Priority of effort to 3/11 ACR.
- (2) Retain ARPS in readiness for commitment into War Zone C.

f. 919 Engr Co: See Annex C - Engineer.

g. Coordinating Instructions:

- (1) At H Hour, D Day 3/11 ACR assumes responsibility for AO DALLAS (see Annex D) and OPCON of any US/ARVN forces located therein. Additional AO's will be assigned to 3/11 ACR as required.
- (2) The artillery LNO assigned to 3/11 ACR will clear artillery fires within that unit's AO.
- (3) Fires within 1st Bde/2d Airborne Bde (ARVN) AO's will be cleared through 2/19 Artillery Battalion, 1st Cav Div (AM), call sign: TRAIL SPIKE 8 Freq: 61.00.
- (4) Fires will not be placed within 3 kms of the Cambodian border without approval of the Regimental Commander, closer than 2 kms without permission of Commanding General, 1st Cav Div (AM).
- (5) All air warning data for Eastern War Zone C will be posted through the 2/19 Artillery Battalion, 1st Cav Div (AM), Call Sign TRAIL SPIKE 8, Freq: 61.00.
- (6) As 11th ACR's AO in Eastern War Zone C is extended, fire support coordination will be accomplished in accordance with sub-paragraphs (2) through (6) above.
- (7) Supplemental check points in Annex B are in effect for Operation TEXAS TRAVELER.
- (8) This OPORD executes OPLAN 13-69.
- (9) OPORD effective upon receipt for execution at 240630H Nov 69.

1. SUMMARY OF ENEMY SITUATION:

a. Eastern War Zone C has traditionally provided the enemy with an inviolable area from which he could provide manpower and material to the battlefield. High level headquarters, rear service installations, training centers, and hospitals are also located in this area. Additionally, there are two base areas straddling the Cambodian Border into War Zone C: Base Areas 352 and 353. These base areas not only contain the headquarters of COSVN, but are also used by main force enemy units to rest, regroup, evade friendly forces, and initiate preparatory phases for offensive operations.

b. There are two primary supply/infiltration routes traversing War Zone C: The Saigon Michelin Corridor which follows the Saigon River basin; and a system of trails and supply caches generally running diagonally from the Dog's Neck in a southeasterly direction to the Saigon River (vicinity of XM4553). Although allied operations have hampered enemy activity along these routes in past, the enemy continues to use War Zone C as a route of resupply and infiltration.

c. From mid-September until early November, enemy initiated activity in War Zone C was characterized by scattered attacks by fire, light ground probes, ground to air firings, and logistical operations. However, during the early morning hours of 4 November, FSB IKE and FSB JAMIE received ground probes while FSB ST. BARBARA and FSB VICKIE received attacks by fire. Although the K2 Battalion, 271st VC Regiment was identified as participating in the attack on IKE, no other unit identifications were obtained. At present, the future intentions of the 9th VC Division are unknown; however, it is believed that these attacks as well as others throughout III CTZ signalled the beginning of the first phase of the Winter-Spring Offensive. According to documents captured in II CTZ, the initial phase of the campaign will be from 3 November to 25 November.

- (2) What is the location and exact content of supply caches?
- (3) Is 95C NVA Regiment OPCON to the 9th VC Division?
- (4) During the period since mid-September, what have the units been doing?
- (5) How many replacements have the enemy units received since August?
- (6) When will the Winter-Spring Offensive begin? Has it already begun?
- (7) Are Saigon and LONG BINH targets of this offensive?

1. (C) SITUATION:

- (2) On order, five sweep teams from the 919th Engineer Co (-) & 3/11 ACR will be airlifted to points along routes 246/244 with airmobile engineer work parties as required, and infantry/CIDG security to clear the roads & improve trafficability. See appendix 1 (Engineer operations Overlay)

- (1) Place 3/919 OPCON 3/11 ACR: 4/919 OPCON 2/11 ACR: 2/919 OPCON 1/11 ACR.
- (2) Place two (2) AVLB OPCON to 3/11 ACR.

- (5) Place 1500 PG4 Water Purification Set in operation vic TON LE CHON airfield.

1. GENERAL: This annex provides for the combat service support of the 11th ACR and attached and supporting units during Operation TEXAS TRAVELER. Regt is supported by 29th General Support Group and Discom, 1st ACD.

2. (C) MATERIAL AND SERVICES:

(2) Resupply of Class V, other than Howitzer ammunition, will be on a as needed basis from QUAN LOI.

(3) Howitzer ammunition will be continued to be resupplied by fixed wing to TONG LE CHON at a rate of 288 rds per day.

(4) The helicopter rearm point at TONG LE CHON will be established on D-Day and replenished to maintain stockage level as follows:

ANNEX G (PSYWAR) to OPORD 7-69 (Operation TEXAS TRAVELER) (U)

1. MISSION: 11th Armored Cavalry Regiment conducts intensified PSYOPS Campaign utilizing Chieu "oi theme, to entice NVA/VC to rally or surrender.

2. SITUATION: Enemy units in area of operation may have little or no knowledge of the Chieu "oi progra . Additionally, individuals may desire to rally or surrender who have not had the opportunity to do so because allied units have not operated in AO for over six months.

3. EXECUTION:

a. Initially the PSYOPS effort will be directed at informing the enemy of the current Chieu Hoi program. The initial confrontation will provide the NVA with the proper procedures for rallying. Special tapes prepared locally will be utilized.

b. The second phase of the operation will utilize the subtle approach. Leaflets and tapes will shown the rallier that they can expect when they Chieu Hoi, the type of treatment they will receive, what happens to their personal property, and the benefits of a Hoi Chanh.

c. The third phase will utilize the "hard-sell" PSYOPs effort with leaflets and broadcasts designed to show what the allied firepower can do.

d. The 3d Squadron will be provided a 250 watt speaker system and a cartridge tape recorder with complete accessory kit and an operator, also (4) four cartridge tapes will be available, two of which will be pre-recorded for the purpose of playing each night for approximately one (1) hour.

e. The recognition signal for an enemy desiring to rally will be arms raised with hands crossed. This means of identification will be described in aerial loudspeaker missions and will be known by all participating units.

4. REPORTS: All incidents of ralliers and voluntary POWS will be reported to the Regimental S-5 expeditously. Every attempt will be made to exploit HOI Chanks on day of rallying. Report of broadcast time and the number of the tape utilized over the 250 watt speaker system will be made daily to the Regimental S-5.
