It is believed to have been capable of supporting a Regt (NVA) sized unit and to have been staffed by 4-5 doctors and 2-3 female nurses. A 15 to 20 man permanent party is believed to have served an administrative role (ie guard duty, carrying supplies, laisson, etc.) Indication are that liasson was maintained with VC especially regarding food resupply. THE OCCUPYING THE HOSPITAL WAS THE B 5 MEDICAL UNIT, 82nd REAR SERVICE GROUP. THE 82nd RSG IS IN DIRECT SUPPORT OF THE 95th C REGIMENT.</p> <p>Additional notes of interest: 1. The medical supplies were from Great Britian, Holland, France, China, and the US. Their est worth is \$2000. 2.
