2. Further request that we receive a copy of MR dtd 4 Apr 69 MR Control # 2(3Apr69). On looking at MR's for 3 Apr and 5 Apr it is apparent that you have merged the strengths of the OLD and NEW B Trp and that you have also reassigned 47 EM from the OLD Trp to some other unit.

3. Also with respect to MR of 4 Apr 69. Who is the one (1) Officer and who are the two (2) EM. I assume that the Officer is CPT Cook. Orders will be accompanying this feeder report of 17 Apr 69 to reassign Cpt Cook. I just found them buried in the OLD B Trp files.

4. I have noticed that you have an aversion to picking up personnel on the MR as ATTACHED. This is an important entry since it indicates the date that a man was present for duty in your unit even if he had no orders or if he had arrived prior to EDCSA, or if he arrives pending amendment of his orders.

MR Feeders of 1, 2, 5, 7, 10, and 11 April had attach entries.
