AS YOU MAY OR MAY NOT REMEMBER, WE TALKED A FEW WEEKS BACK OVER THE PHONE ABOUT THE WORK YOU ARE DOING AND ~~WHAT~~ I AM DOING ON CHEMICAL HERBICIDES.

I AM SENDING YOU THE PACKAGE I HAVE PUT TOGETHER. I WAS HOPING AT THAT TIME TO HAVE SOME HELP WITH MY CONGRESSWOMAN KAY BRANGER. BUT AS YOU KNOW THEY WILL PROMISE YOU ANYTHING AND GIVE YOU NOTHING. I REALLY THOUGHT SHE WOULD WORK WITH BOTH OF US AND HELP US DO THE RIGHT THING IN TRYING TO HELP VETS. I WAS WRONG AND I HOPE YOU CAN UNDERSTAND HOW SORRY I AM FOR THAT.

IN THE MEAN TIME THE COMBAT VETS OF TEXAS OF WHOM I AM DIRECTOR OF OPP. HAVE FILED 15 CASES OF CHEMICAL TOXIC POSIONING. THIS IS NOT AN A BERT ORANGE CASE. THE CASES WE FILED COVER ALL 15 HERBICIDES USED IN VIETNAM. AS FAR AS I KNOW THESE ARE THE ONLY CASES EVER FILED IN THIS MANNER.

When we filed the cases everyone's complete medical files, the color of his package, and your package that was sent to me, we included in every case filed. At this time I have 46 more cases to be filed and a waiting list of around 300. It just takes a while to get everything printed and everyone's medical files together and filed. I hope you approve of what I am doing and have your support.

SIR to let you know what is going to happen next month, Nov 11, 1999 and you know what day that is. There will be a newspaper story (cover story) that will hit the streets that day in Ft. Worth, TX. The color of his will be public information. It will go on the AP and up wire service for every newspaper in the country to read. With your information and my information the truth is going before the American public. The lies and cover ups must will be brought to light. The Vietnam vet needs to have his day in court. He is my brother and I am sick and tired of my brother being push around. I was told at one time by VA doctors that in 2 years I would be in a wheelchair. I am not there yet, as long as I can take care of myself and my mind works I will do what every is necessary to fight and fight for my brother. I want to thank you for all the information you gave me and if there is anything I can do to help you or for you please let me know. SIR THE MISSION CAN BE CARRIED OUT AND WE CAN WIN.
