- 10/25/45 Anchored in Quarantine anchorage, Yangtze River, China. Underway to Shanghai. Moored alongside USS DIXIE in Whangpoo River, Shanghai. "ZUMWALT, E.R. Jr., Lieut., USN., reported on board this vessel for duty."
- 11/5/45 Underway. Transferred Ensign Probst to USS ROBINSON. Anchored in South Channel of Yangtze River.
- 11/11/45 Underway to Shanghai. Moored.
- 11/12/45 Underway standing down Yangtze River. Left formation to take mine under fire. Mine destroyed.

- 12/3/45 Underway to Buckner Bay, Okinawa in company with USS OSAGE.
- 12/5/45 Anchored in Buckner Bay, Okinawa.
- 12/6/45 Completed stowing 253 cases of whiskey. Underway to Shanghai.
- 12/8/45 Summary Court Martial, Lieutenant ZUMWALT, senior member, convened to try the case of Sessions, Jake Calvert, StM2c. Moored in Whangpoo River, Shanghai. Delivered whiskey to COM, Shanghai.
- 12/12/45 Underway with USS ROBINSON and CHARRETTE with DesDiv 43. Enroute to CONUS via Eniwetok and Pearl Harbor.
