SUBJECT: Commander's Situation Report

1. (C) Opn Summary

a. HHC: Bn Forward CP remained at Q. Provided logistical support for operation in Northern AG.

b. Troop A, B, D: Troop D FHM to Q for possible insertion via ID 832362. Troop A, B continued extensive VP's in area of yesterday's activity. CH6A observed 1 NVA via ID 832362, engaged with gun results 1 NVA/KEL. CH6A observed 12.7mm machine gun via 833362, engaged with gun, results 1 CW destroyed, 1 NVA/WA even to 18th Surg., later died. CH6A observed 7 NVA/KEL (previously), wrapped in poncho, 10 NVA/KEL last 24 hrs. Chayenne Phanton observed 1 NVA via ID 834360, NVA was extracted, to Q where he was classified a Noi Chook. Conducted HMA of Q 14101. CH6A observed poncho and signal equipment via ID 836359. CH6A observed 20 NVA/KEL last 24 hrs, 2 AK-47's, 1 RPG, w/3rds and 20 rucksacks, engaged area, results 5 rucksacks destroyed.

c. Troop C: Conducted first and last light for 1st and 2d Bde. Provided 1 pink tn to 3d Bde. Conducted HMA of 11 14091 & 11 14092. Conducted VP of Gumbado Vault locations for 3d Bde. Conducted HMA of A/E for 1st Bde. Conducted sniffer mission for 3/187. Conducted 2 V for downed CH6A via AHP remained at Phu Bai in response to downed A/C.

d. Co L, 75th Inf: Extracted to Hanoi via ID 710467, 12 green. Requested to Javelin via ID 835456, 12 green. Insertion planned for today were not completed due to weather and finding AG changes in Northern LZ's.

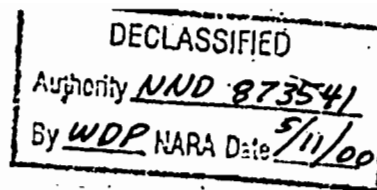
