a. Air Activity

(1) 070940H vic YD475000, B Trp AH1G on AAR msn recd 4 rds SAF at 100 knts 400'. Neg hits or cas. Area was eng w/Gunships w/unk res.

(2) 071015H vic YD142093, C Trp obs where road (Rte 9222) had been interdicted by bombs. Road had been rebuilt around the area that had been interdicted w/in the last 3 days.

(3) 071035H vic YD179108, C Trp obs a truck that had been prev dest. Truck was old and rusted w/neg rec act.

(4) 071300H vic YC645760, B Trp OH6A on AAR msn recd 150 rds of SAF at 60 knts 100'. A/C sust 1 hit in the main rotor blade and 1 hit in the tail rotor. Neg cas. A/C returned to CEE (non-flyable) Area was eng w/gunships w/unk res.

(5) 071304H vic YC645760, B Trp obs 20-30 4x4 bunkers w/act in the last 1-5 hrs.

(6) 071310H vic YC654755, B Trp OH6A on AAR msn recd 40 rds SAF at 60 knts 90'. Neg hits or cas. Eng w/gunships w/unk res.

(14) 071500H vic YC645761, B Trp obs 5 4x5' bunkers, 30 piles of cut crop 5' long, 1 10x10' hut, trail 2' wide oriented E-W and 1 UO AA/AV psn w/act 12-24 hrs. Also obs 1 NVA/VC in a 5x8' bunker. Area was eng w/gun ships w/unlk res.

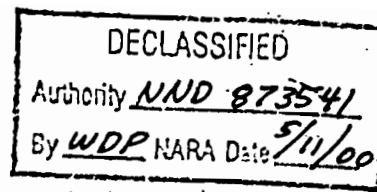
