(1) 172108H vic YD293258, C Trp FLIR obs 20-25 NVA in two separate groups. Also obs several other small groups of personnel in the area. Area was eng w/gunships w/unk res.

(2) 172115H vic YD284358-296360, A Trp FLIR obs 2 groups of 8-10 personnel and numerous fires in the area. Area was eng w/gunships w/unk res. After re-fueling rtd to area and had neg findings.

(3) 180430H vic YD283256, A Trp FLIR obs 2 NVA moving to the W. Area was eng w/gunships w/unk res.

(4) 180705H vic YD317223, B Trp OH6A AAR msn recd 50 rds 7.62mm fire at 150' and 60 kn. Neg hits or cas. Area was eng w/gunships w/unk res. OH6A on second pass recd another 50 rds 7.62mm fire at 100' and 60 kn. Neg hits or cas. Area was re-eng w/gunships w/unk res.

(7) 180752H vic YD24220, B Trp OH6A AAR msn recd 40 rds SAF at 150' and 60 kn from approx 5 vpsns. Neg hits or cas. Area was eng w/gunships w/unk res.

(9) 180650H vic YD302367, A Trp obs trail 2' wide oriented E-W w/act in the last 12 hrs.


