 8. ENEMY: 050945 tm inserted and acted as radio relay. 061000H vic YD443018 tm obs 2 NVA/VC wearing dark green uniforms vic YD444019. The en moved to the SE and were lost from view. 070930H vic YD442022 tm disc trail 4' wide oriented NE-SW and another trail 3' wide oriented N-S. Also disc another trail 3' wide oriented N-S vic YD447024. Both smaller trails show signs of light activity in the last 48 hrs. Throughout the day and night of 08 Oct tm heard voices of more than 3 personnel from vic YD458030. 090700H tm heard the same voices as on the previous day. 091930H vic YD463027 tm heard voices of 15-20 personnel moving to the SW. The personnel congregated vic YD465025. 091945H 3-4 NVA/VC moved by the tm's psn but did not spot the tm. 092000H tm employed arty w/ unk res. 100200H tm heard 2 steel wheeled carts moving NE. The carts moved to vic YD465025 where they were taken over by the first group of personnel. Both groups then returned in the directions they came from. Tm employed arty again unk res. No further sightings or contacts.
 9. NATURAL WATER SOURCES: Conform to map
 10. COMMUNICATIONS: Good except for interference on the night of 07 Oct
 11. HIZ'S: Poss 12 in bomb crater vic YD453028
 12. CONCLUSIONS: Team leader feels that the en sighted on the last night of the patrol were pre-occupied with picking up the carts. Team leader feels that the en were aware of the presence of the tm but were too busy to worry about them. There appears to be a lot of traffic at night in the river junction area.
