B. B TRPs: Provided one OH6A to FB Tomahawk for convoy cover. Aircraft took fire at AT931909. Provided one Allick and one Cobra for Ranger overflight. Inserted two Ranger teams utilising 1 cobra, 2 slicks, and 1 C & C. Team BALTIMORE (13-V) was inserted at YD317144 at 1422H. Team OTTAWA (13-W) was inserted at YD312117 at 1430H. Both LZ's were green. Conducted VR in vicinity from Bradley to FB Ripcord to locate 803rd NVA Regt. Received fire at YD283184, YD365198 and YD223153. Took negative hits. Ranger team BALTIMORE was in contact at 1740H. Link team went to AO but was unable to work due to weather. Provided first and last light missions of Eagle perimeter and Eagle—Phu Bai Rocket Belt.

C. Co L: maintained radio relay on FB Rakasan. Maintained 3 teams in AO. Inserted teams BALTIMORE AND OTTAWA, at locations and times listed above. Team BALTIMORE engaged 3 NVA, wounding one at YD313145.
