

Allotment options clarified

FORT BENJAMIN HARRISON. Voluntary allotments from retired pay can be a convenient way of handling some of your recurring financial obligations, but there seems to be some confusion among Army retirees as to the purposes for which allotments can be made.

Basically, there are 10 purposes for which you can make an allotment from your active duty pay, and almost all of those allotments can be continued from your retired pay if you make the necessary arrangements before you retire. The only two that cannot be carried over are Combined Federal Campaign pledges and deposits in the Veteran's Educational Assistance Program (VEAP).

Any continued allotment will go on until you change or stop it. However, there are only six categories for which you can start an allotment after you retire, and there are some restrictions on making changes to the others.

The following chart may help you to understand all of this. While the chart can serve as a ready guide, it is always best to check with Retired Pay Operations before you request action on any of your allotments. For information about allotments, call toll-free 1-800-428-2290; Indiana residents may call collect, (317) 542-2900.

Requests to start, stop, or change an allotment require only a simple letter over the retiree's signature, addressed to: Retired Pay Operations, U.S. Army Finance and Accounting Center, Indianapolis, IN 46249-1568.
