B Troop 7/1 ACS
The Rescue Of an American
January 1969
Hawk-talk

It was the 31st of December on a typical day in the Delta of South Vietnam. Before the day would end it would have proved to be a very special day for Major James N. Rowe and the men of B Troop 7 th Armored Squadron 1 st Air Cavalry. The mission was not uncommon. Today the Dutchmasters would support the 21 St. ARVN Division. A visual Armed reconnaissance in the U-Minh Forest, Was in order.

Warrant Officer Louis E. Schantz was piloting, Major David E. Thompson in the command helicopter. At approximately 1315 hours an enemy sampan loaded with military equipment and explosives was sighted and destroyed by B Troops aerial rocket and machine-gun fire. Three Viet Cong were killed and a prisoner was taken along with several automatic weapons. Upon return to CAMUA and interrogation of the prisoner, it was learned that the man was actually an ARVN Lieutenant that had been captured by the VC the previous year. He indicated that there were more VC in the area where he was picked up. Major Thompson directed Bravo Troop to return to the area of operation. Upon arrival at the site, another sampan with four occupants was sighted by Maj. Thompson and Mr. Schantz. Major Thompson directed Mr. Schantz to execute an evasive maneuver so he could be more effectively control the strike of his gun ships.

It was during this low altitude turn that both Maj. Thompson and Warrant Officer Schantz spotted what appeared to be a VC several hundred meters away from the sampan. He was in tall reeds and waiving a white cloth. It was surmised that this man was probably bait for a trap, however the possibility of a general defector or surrender could not be entirely discounted. Major Thompson decided to go in. He directed two scout helicopters to cover his insertion and told Mr. Schantz to begin a tactical approach. As their helicopter came closer the propwash blew the reeds away from the suspect. The man was of fair complexion and had a long beard. It was apparent this man was not Vietnamese.

The landing was difficult due to dense foliage and underlying swamp. After cutting several small limbs with the rotor blades in an almost vertical descent, the crew was able to pick up the man and depart without damage to the aircraft or personnel. The added risk of enemy fire was more evident as suppressive fire from the ascending helicopter was not deemed advisable due to the possibility of more friendly personnel in the area.

The man they picked up was 1Lt. (Now Major) James N. Rowe. He had been a prisoner of the VC since October of 1963.

Major Thompson remarked "After we got him into the ship SP4 Mike Thompson and SP4 Stevens gave him some C rations and water, we realized he had not eaten for several days. Major

Thompson continued "he looked surprisingly healthy for the ordeal he had gone through."

Upon their return, Major Rowe was able to make a call to his parents who live in McCaland Texas....They said they had never given up hope for their son.

For the Rowe family and the Dutchmasters, New Years Eve of 1968 will be hard to beat. Welcome back Major Rowe and to the Dutchmasters, another job well done.

Editors Note:

Major James N. Rowe was killed in the Philippines in May 1989 he was a Colonel at the time. There is a very good book out Written By James N. Rowe entitled Five Years to Freedom. It is published by Ballantine Books.

What was in those Malaria Pills

I am contacting you in hopes that you may assist my efforts in gathering information about the effect of the malaria pills we took while in Southeast Asia. My previous articles in the VHPA Newsletter and 1st Cavalry Division "SABER" Newsletter netted over forty responses from Vets who have minor or major medical problems.

Veterans have never been told by any competent medical authority that their problems may have been caused by massive/long term ingestion of the anti-malarial drugs.

I remember the Big orange pill we took being called "CHLOROQUINE/PRIMAQUINE" and the little white pill as "DAPSONE". What is now so unique, is to read about the mild and serious adverse side effects of these drugs.

Many of the responses indicate:

Heart Problems, Kidney Disorders, Liver Malfunction, Anemia, Low Blood Platelets, Cornea and Retina Damage, Excessive Bruising and Bleeding through the skin. "Heart Attack "symptoms, hearing disorders, Tinnitus, Permanent blindness, Psychotic Disorders, etc. Responses are still coming in and I would like more.

One Medic's response was that there were "allegedly" 1000 deaths and 10,000 casualties due to the ingestion of the anti-malarial pills during the Vietnam era. He was told in medical classes that any problems to humans ingesting the drug was an "Acceptable Risk". Apparently, there were none or more major studies conducted by the Veterans Administration and or the Department of Defense in the early 1970's to determine the effects (Long Term). Those results were never made available to the veterans who took the pills for a few months to several years.

The Veterans Administration advised one pilot that they can not even discuss the anti-malarial drug after-effects unless a "Claim" is filed.

In Touch

"I have memories that belong to his family." You came back from Vietnam; he didn't. You wish you could do one last thing for your buddy. You often have thought about contacting his family, but you have been afraid doing so may only stir up more pain or sad memories.

"I have memories that belong to his family," was written by the first GI to complete an In Touch application that resulted in a "match." The In Touch program of the Friends of the Vietnam Veterans Memorial has made more than 1,000 such matches between buddies and families.

The program maintains a database with a file for each name of our brothers and sisters on The Wall.

You no longer need to wonder how the family will feel when you call---family members who have registered with in Touch definitely WANT to hear from you! Even if you only have one small piece of information, it belongs to his family.

A note about what to say when you do make contact: The family may say "Tell us everything." That does not mean they want to hear he died a slow, painful death, his body was all torn up, he was a jerk, or he liked to visit prostitutes.

They want to hear you remember him, he was respected and liked, he did his job well, he was part of a team. Did he have peculiar likes or dislikes? Some favorite phrases? Do you have any pictures? What did he do in that war so long ago?

If you can't wait for an application, you may write to In Touch, with the following information: Last, first and middle name of KIA?MIA, your relationship or reason for your request (Buddy in Nam) Additional info about the KIA: Rank, birthdate, KIA date, nickname, branch, unit, hoemtown, etc. Then your last, first, and middle names, your mailing address, and phone numbers. State if you do or do not give permission to release your name to other participants in the In Touch program.

In some cases, your entry will wait in the database until a family member submits a request; in other cases, your application may result in an immediate match!


