SUBJECT : Security Report for the Month of September, 1958

Tuesday
September 2, 1958: Mr. Jerome Franklin reports that while driving in a southerly direction on Cong Le at about 10:05 this date, he was struck by a taxi license number NBC 497, driven by Nguyen Van Vat, 126 Pavie, Cholon, driver's license number 98621. Mr. Franklin's car was damaged slightly, and the taxi suffered the loss of a left rear mudguard.

Tuesday
September 2, 1958: Mr. Charles F. Sloane reports scaring away a burglar who was in the process of entering through a screen door at his home at 232 Duong Hien Vuong. He reports nothing missing at this time.

Saturday
September 20, 1958: Mr. Carl Rumpf reports that while moving from #9
Le Ngo Cat to Apartment 13, 137 Pasteur, 500 piasters
and some jewelry was stolen. One of the coolies
employed by MSUG and engaged in the process of moving
Mr. Rumpf later confessed to the theft of the money
and jewelry. He was arrested and is at the present
time awaiting trial.

SUBJECT : Accident Report

On Monday, September 1, 1958, while proceeding on Cong Ly (one-way street) in a southerly direction, my car was struck by a taxi driving in the same direction at about 10:05 A. M. At the time I was in the outer lane driving at a moderate speed, whereas the taxi was in the inner lane. The collision occurred about 3 feet in my lane.

The damage to my car was not significant other than a few scratches near the bumper of the front right side of the car, whereas the taxi suffered the loss of a left rear mud guard which was torn from the body. None of the passengers in the taxi nor the driver were injured.

The taxi number was NBC 497; drivers name was Nguyen Van Vat; address was 126 Pavie. Cholon; license number was 98621.

I believe that the accident was caused by another vehicle pulling away from the right-hand curb (in a south bound direction) which made the taxi swerve into my car.

Unfortunately I could not communicate with the investigating officer because he only spoke Vietnamese, and in addition, the investigation itself was not made for approximately one hour after the accident and in that time two rain storms had completely washed away the actual evidence of the point of contact.


