Since the contract between Michigan State University and the International Cooperation Administration, together with the Corollary Agreement between Michigan State University and the Government of Vietnam, for technical assistance services in Vietnam is now in its twelfth month or slightly past the halfway mark this raises the question concerning the authorization of travel and transportation for personnel assigned to this project on and after April 20, 1956. This will become of increasing significance since the new amendment to the contract provides for additional staffing.

In order to permit proper planning on your part, you are hereby notified that it is ICA's present intention to extend your contract and that, within the dollar limitations already provided, you may for a period of twelve months recruit contract staff members in accordance with the existing contract provisions, as amended. If the present contract is not extended, ICA will, within the limits of available funds, reimburse you for returning these personnel to the United States including salary payments to the end of the present ICA contract or for re-employment, whichever is earlier.
