Dear Dr. Fishel:

As you know, South Viet-Nam has fallen to Communism. I suppose that you have followed closely these events, having known Viet-Nam so intimately, and having played an important role in the first years of the Republic.

The fall of the Republic of Viet-Nam occurred when I was Ambassador to Belgium. Since I can no longer return to my country, I have now to start a new life. My wish and hope is to be able to teach and do researches in International Relations, especially on Southeast Asia. To that effect, I shall be grateful for any help, advice or information you would give me.


In the academic field, I have a Doctorate of Juridical Science from Harvard University (LL.M. 1954, S.J.D. 1956), and a Doctorat en Droit from the University of Hanoi (1953). I taught International Relations at the University of Dalat in 1966-1968, and at the Faculty of Law, University of Saigon, in 1968-69.

In other activities, I held Cabinet posts in the Government of the Republic of Viet-Nam (Special Assistant to the President of the Republic for Foreign Affairs from 1968 to 1974, Acting Foreign Minister in 1973), and various diplomatic appointments (Ambassador, Permanent Observer to the United Nations in 1964-65, ad hoc Ambassador to the Republic of China in 1969, Ambassador to Belgium, Luxembourg, and the European Economic Community from May 1974 to April 1975).

Please find enclosed a copy of my curriculum vitae, which provides some further details.
