Dear Friends,

The Association of NIA Alumni established by Arrêté No.30 BNV/NA/P5 of May 14, 1957, has reached the following two objectives:

1. To tie closer the bond of friendship and mutual help;
2. To exchange views and experiences on the discharge of administrative responsibilities.

Since the past three years the Association's activities have been concentrated on the first objective only; and the former Boards of Administration, though blessed with good will and having made enormous efforts, had no means and no opportunities to extent their activities in order to reach the second objective; so the Association deems it necessary to have a press organ, or at least a news letter review to exchange news among NIA alumni or experiences acquired in administration.

"The administrative career", let us use the term, requires from us who are staff members of various levels the necessary duty to improve ourselves as do other people pursuing other careers; and perhaps we have to train ourselves in a more scientific way for we have to shoulder heavy, complex responsibilities, and are made more responsible before our fellow countrymen than other people in other branches.

With the NIA students of the fourth session, who will soon graduate from NIA, the number of alumni will reach 300, we think that with this total or at least two third of them as

member of the Association, we will hopefully publish a deserving administrative review which in the near future will team up with the "Administrative Research Review" (of NIA) or the "Administrative Treatise "(of the Interior Department) in order to supply worthy documents concerning administrative study.

On the occasion of the lunar New Year, the Rector of the N.I.A. sent to the Association an open letter to address the Alumni his best wishes and to express his hope that this newsletter will serve as an understanding link between the Alumni and the Institute.

Dear Alumni,

Once more, Spring comes round with our Republic of Vietnam. At the time when every people welcome enthusiastically the New Year after a year of toilsome work, when everyone reserves his most sincere feelings to the living as well as the dead, to his relatives, close friends and casual acquaintances, I cannot help thinking to you who have led a common life under the NIA roof during a stretch of time worth mentioning in your youth.

Up to now, five springs have past since the day when the National School of Administration of Dalat moved to Saigon and became the National Institute of Administration with a more improved organization and more important and complicated responsibilities at the same time. In the past five years, the students who have got their graduation number approximately 300.

You are among these fortunate people and have received from the Government assignments to serve right in the capital or in the provinces at agencies pertaining to administrative, economic or financial branches. Although you have left the Institute, my collaborators and I in the Board of Direction and the Academic Section of the Institute, keep on following up your steps on your way of serving. We shared your joy, anxiety and discouragement every time we noticed that you have secured some advantage in your career or your unexpected failure when you met with some drawback or difficulty.

Through my own enquiry as well as my asking your supervisors' opinion or that of the public in the places you are assigned, I am glad to find that almost all of you deserved the positions you are entrusted with and have indeed raised the good name of the National Institute of Administration, which has had the honour of training you.

I am also glad to notice another fact: although you are scattered far and near on the national territory, the ties of friendship which linked you on the bench of school did not fade away. An obvious proof lies in the fact that a number of you have taken in hand the organization of an association named the Association of NIA Alumni and immediately after its setting up, a great number of you have joined it enthusiastically. This meaningful attitude expressed clearly the sacred fraternity feelings existing between the Institute alumni.

I believe that with this review, The Alumni Association will not only give you the most efficient means of exchanging news pertaining to your family and your work but also offer many favorable occasions to better your knowledge and experience on your career. But I cherish another aspiration: I hope that your Association, with this review, can at least be a link of mutual understanding between you and the National Institute of Administration, as well as between you and other students who are learning in the school or about to join our family, The Institute.

As the first step of news exchanges between you and the Institute, I send to you this open letter with my sincere new-year wish of Canh Tý. I do not hope otherwise than to wish you and your dear ones a merry Canh-Tý year full of happiness, and in the discharge of your responsibilities, you will continue to behave as the most deserving public servants of our regime of personalism-respect Republic led by President Ngô.

ANNUAL MEETING

of the National Institute of Administration Alumni
(October 3, 1959)

On October 3, 1959 at 3p.m. the N.I.A. Alumni held its 1959 yearly meeting at the auditorium of the National Institute.

More than every year, a large number of members came from distant provinces to attend it enthusiastically, in spite of their numerous and busy duties. Were present at the meeting 48 members comprising all the 4 classes including the one that has just got graduated in early 1959.

Opening the meeting, the Alumni President Tô-vân-Quế gave all the members informations as to the activities of the Administrative Committee for the 1958-1959 annual session, during which 30 new members have joined the association and thus bringing the members to a total of 80 by the date of the meeting.

Besides, the Association's financial situation was shown in the following balance:

Foregoing receipts and expenditures have been carefully checked and certified liquidated by the controller for finances Nguyễn-hữu-Phước.

After the report had been done, the President in behalf of the old Administrative Committee proclaimed the resignation

of the latter so as to let the present Assembly vote a new Administrative Committee for the 1959-1960 annual session.

The vote was taken under the chairmanship of Huynh-trung-Nghia in a rather effervescent and enthusiastic atmosphere. Upon the introduction of the present members, the Meeting proceeded to the vote of the Administrative Committee members according to the relative majority at the second ballot for the chairman, the deputy-chairman and the General secretary and a single ballot for the other members.

Results of the vote have been recorded in the list of Administrative Committees for 1959-1960.

After the new Administrative Committee had been presented to the attendance, all the present members went on discussing the problems put on the agenda. After a lively discussion, the meeting gave its approval to the new Administrative Committee for the carrying out of the following during the 1959-1960 session:

- Issuing of a monthly news bulletin to exchange news between the members and to give informations concerning everything that is considered of being of some interest and deserving to be carried out in behalf of the members.

- The collection of monthly contributions will be performed every semester to simplify the cashier's duty.

- The Association quarters will be transferred to the National Institute of Administration if this is approved by the Rector of the Institute. The Administrative Committee will

contact the Rector and if no satisfactory results will be attained, the quarters will move temporarily to the private residence of the Association President 54 Nguyễn-tri-Phường Boulevard Saigon.

- The Administrative Committee will plan the public official presentation of the Association to secure it more credit and to introduce itself to groups, to other friendly associations and to those of the students who have not yet joined the association.

The Meeting broke up at 6:30 p.m. Then, to give the members an opportunity of chatting between themselves in this annual gathering, a party has been organized at Ngọc-Lan-Dinh Restaurant with the attendance of all the alumni who had come to Saigon for the meeting.

The Meeting has been successful in strengthening the friendship ties between the members with its bright promises of further developments.

A R R E T E S

Article I. NIA Alumni Association whose headquarter located in No.149/2B Ngô-tùng-Châu street Saigon is permitted to be established and to operate in Viet-Nam in conformity with the Association's by-law which has been approved and attached to this Arrêté and within the scope of Ordinance No.10 of August 6, 1950 fixing the regulation for associations.

Article II. The Director General of Political Affairs and the Director General of Police and Security are in charge of enforcing this Arrêté.

B Y - L A W

of the "NIA Alumni Association"

Chapter I

Purpose of the Association

Article 1.- It is established an Association for the boy and girl alumni of NIA with the purpose of:

- promoting mutual affection and aid
- exchanging learning and experiences in connection with the performance of administrative duties.

Article 2.- The Association does not have political and religious character.

Chapter II

Name of the Association

Article 3.- The Association is called "NIA Alumni Association".

Chapter III

Headquarter

Article 4.- The Association's headquarter is temporarily located in 149/2B Ngô Tùng Châu Street Saigon and can be moved to another location upon the Management Committee's decision.

Chapter IV

Term

Article 5.- The Association is established for an indefinite term and operates throughout Viet-Nam.

Chapter V

A. Admission

Article 6.- The NIA alumni of both sexes are eligible for admission but they must have the following requirements to become regular member:

1. 21 years of age and over
2. request for admission stating curriculum vitae, entrance and final year at NIA
3. introduced by two regular members
4. request for admission must be approved by the Management Committee
5. paying admission fee and monthly contribution.

B. Quitting the Association

Article 7.- Member may quit the Association but has to notify the Chairman one month ahead. If still involved in material and financial matters, that member should clear up before quitting the Association.

C. Loss of Membership

Article 8.- Those members who fail to pay contribution of three consecutive months and after being reminded twice

by the cashier, are considered as losing their regular membership.

Article 9.-- Those members who commit one of these two following mistakes:

1. causing material or moral damage to the Association
2. transgressing the Association's by-law will be expelled upon a 2/3 vote of the Association congress.

Article 10.-- The expelled members or those who quit willingly are not entitled to ask for reimbursement of admission fee, monthly contributions or any other properties contributed or donated to the Association.

Article 11.-- Those members whose name being deleted in the register (except the members expelled) are eligible for re-admission if approved by the Management Committee. But this member must pay admission fee as new member.

Chapter VI

Member's obligations and Rights

Article 12.--

- Members must observe the Association's by-law
- Members are unentitled to use the Association's property
- Members enjoy equal mutual aid

Chapter VII

Association's Finances

Article 13.-- The Association's finances includes: admission fee, monthly contribution and other revenues. Admission fee is two hundred piasters (200\$) Monthly contribution is twenty piasters (20\$)

Chapter VIII

Regulations on personal estates and real estates of the Association

Article 14.-- The Association has the right to possess, to purchase, to manage, and to own personal and real estates necessary for the attainment of the purpose of the Association.

Article 15.-- The Association has the legal personality: this personality is different from the interests of each member.

The Association may start lawsuits at Courts.

Chapter IX

Family name, name and age of the founders

Article 16.-- A Board of Directors is formed, the list of which is as follows. This list will be brought to the authorities' knowledge in accordance with the Decree

number 10, August 8, 1950, about the regulations of the foundation of Associations.

Chapter X

Rules on election and dismissal of
managers and their powers.

Article 17.- The Association is managed by the 10 men Board of Direction elected by secret vote to the Annual Assembly by absolute majority on the first time and by relative majority on the second time.

Article 18.- The number who is either far away or busy may cast his ballot by credentials.

Article 19.- If the contestants poll a tie score of votes, the elder is elected.

Article 20.- The Board of Directors includes:

- One Chairman
- One Vice Chairman
- One General Secretary
- One Secretary
- One Cashier
- One Assistant Cashier
- One Financial Controller
- One Controller of Affairs
- Two Advisors

Responsibility of the Board of Directors

Article 21.-- Chairman and Vice Chairman as the highest representative of the Association, the Chairman:

- is responsible of the members' conduct within the line of the Association
- convokes the Board of Directors and the General Assembly
- directs the discussions
- receives the correspondence sent to the Association
- signs payers and accounting documents

The Vice Chairman replaces the Chairman when the later is absent or busy. In order to handle problems relating to finances, he should have legal credentials of the Chairman or of the Directing Board if by any reason the Chairman could not give him credentials.

Article 22.-- General Secretary and Secretary.

The General Secretary:

- is responsible for all documents
- organizes the permanent bureau
- organizes meetings and drafts the agendas
- Sets up evidences of meetings of the Directing Board or Great Assembly or affairs assigned by the Chairman.

Besides, the Secretary General must record and keep the following books:

- one dealing with evidences of meetings of the Great Assembly

- one dealing with in going mail
- one dealing with out going mail
- one dealing with the list of members with full details of their going in and of the Association
- one dealing with properties of the Association: chattels and real estates...

The Secretary assists the General Secretary in the above functions and replaces him when the later is absent or busy.

Article 23.- The cashier and his assistant.

The cashier has the right:

- to collect entrance fees, monthly dues and all other incomes of the Association
- to sign on receipts
- to disburse expenditures by the determination of the Directing Board and with the Chairman's approval.
- to keep the accounting books and to be responsible on the funds.

The cashier should keep the following books:

- one containing the list of members
- one of receipts and expenditures, closed each month and approved by the Chairman
- one counterfoil book

The assistant cashier assumes the cashier's function and is supervised by the latter.

Article 24.- The cashier may keep 5,000\$00 in cash (five thousand piasters). The excess should be sent to the Savings Department or the Treasury or any Bank designated by the Directing Board.

The Chairman and the cashier should both be responsible for trusting money.

Any withdrawal of money should be signed by both of them.

Article 25.- Financial controller.

The Financial controller is responsible:

- to care for the Finances of the Association
- to control the Accounting Books of the Association
- to bring urgently to the knowledge of the Chairman all possible misuses of the fund of the Association.

Article 26.- Controller of affairs.

The Controller of affairs is responsible:

- to transmit the members' requests to the Directing Board.
- to report to the Chairman all members' funerals and marriages

Article 27.- Advisors.

The two advisors give advices to the Directing Board and transmit the members' ideas to it.

Article 28.- The term of the Directing Board is one year and may be renewable.

Article 29.-- The function of members of the Directing Board brings no salaries.

However, their expenses on transport, food and housing for doing missions of the Association are repaid at the rate determined by the Annual Great Assembly.

Article 30.-- Members of the Directing Board may resign ahead of their term; but they are responsible of their acts during the time they are in the Board.

Article 31.-- If from one to four members of the Directing Board are dead, have resigned or are absent for three consecutive meetings without proper reason, the Directing Board may temporarily determine their replacement in order to continue the activities till the end of their term. If the Directing Board has no more than 5 members, the Special Great Assembly will be held for the election of a new Directing Board.

Article 32.-- At least once every three month, the Directing Board is summoned by the Chairman, and only the presence of at least six members can legalise the meeting. If any problem need to be solved urgently, the Chairman may summon a special meeting.

Article 33.-- If the discussion should end in a secret vote, and if there is a tie score, the Chairman's vote gives privilege.

Article 34.-- The Directing Board may create or dissolve many committees to run the Board according to the needs of the Association.

Article 35.-- The Great Assembly has the right:

1. to repair the by-laws
2. to draft and to repair the regulations
3. to fix the rules on the execution of by-laws and regulations.
4. to nominate or dissolve the Directing Board
5. to disqualify members according to conditions fixed in the Article 9 of these by-laws
6. to approve the budget, to fix the monthly dues and other fixed expenditures
7. to approve the closed balanced of the past year and to liberate the financial responsibility of the previous Directing Board.
8. to solve any problem relating to the common property of the Association
9. to determine the common policy of the Association within the limit of the application of these by-laws

Annual Great Assembly

Article 36.-- The Annual Great Assembly is held on the day and hour fixed by the choice of the Directing Board.

Article 37.-- The Great Assembly may vote only when the present or delegated members attending it represent $\frac{2}{3}$ of the total of the members.

Article 38.-- If the above said quorum can not be met, the Great Assembly must be postponed for two days. During

the later, any vote is valid in spite of the number of present members.

Special Great Assembly

Article 39.-- The Great Assembly may be specially hold when the Directing Board or 1/4 of the members request it.

Article 40.-- The Special Great Assembly applies the by-laws of the Annual Great Assembly.

Article 41.-- Any subject suggested by any member to be discussed at the Great Assembly should be brought to the Chairman's knowledge 8 days ahead of the opening of the Great Assembly in order to be recorded previously into the agenda.

Chapter XI

Dissolution of the Association

Article 42.-- If requested by more than 2/3 of the members, the Great Assembly may be met for dissolving the Association.

Chapter XII

By-laws on liquidating and using property of the Association

Article 43.-- After the dissolution of the Association, its property is liquidated according to law in force and must not be divided to members.

The excess, if there remains any, will be donated to benevolent organizations of the Republic of Viet-Nam, as assigned by the Great Assembly.

(Summary of the activities during the fourth term 59)

I. General program:

1) By decision No. 961-TTP/TTK dated August 12, 59, the term "Evening classes" at the N.I.A. is replaced by that of "Administrative Capacity Course".

In order that living far-off students may attend the above-mentioned course and be exempted of assiduity, the Section in charge of book publication has got a number of lectures printed which are put for sale at the Institute.

2) Regarding students of the Đốc-sự and Giám-sự sections, the Institute has asked high ranking officials, well experienced technicians to lecture about administrative, economic, financial or social problems presenting an actual character as regards Viet-Nam for 2nd and 3rd years students. Lectures take place every Thursday starting from October 15, 59.

3) As a succession of the seminar on "Study and preparation of official documents" which closed within the last fortnight January 1960, the In-Service Training Division is preparing the organization of another seminar on "Organization and Methods" which will be held in mid-February 1960.

II. Panel-discussion:

Every month, the professors of M.S.U.G lead a panel-discussion

so that students might get an opportunity to practice English and exchange topics of common interest. The first panel-discussion was held on November 12, 1959.
