CONFERENCE ON VIETNAM FINANCIAL ADMINISTRATION

June 24 to July 31, 1958

In an attempt to make more meaningful the experience of the several Vietnamese governmental officials who have been in the United States for study and observation in various areas of governmental finance administration, the Vietnam Project this summer is conducting a conference in which that experience will be reviewed and analyzed in light of the responsibilities to which they will return and of the kinds of problems to which these experiences may or may not afford greater insight. Working alongside the Vietnamese will be a number of professionally qualified Americans interested in Vietnam. We hope that by working together the Vietnamese and American members of the conference can isolate those parts of American practices and approaches which might be applicable to relevant problems in the administration of Vietnam. There should be the additional by-product of giving each of the participating members, both Vietnamese and Americans, understanding of the operations and problems of other financial areas other than their own, for instance, budget vis-a-vis tax administration, etc.

The conference will last from June 24 through July 31st. Except for the first week, when there will be three 2 hour meetings on Tuesday, Wednesday, and Thursday, June 24th, 25th and 26th starting at 3:15 p.m., there will be two weekly 2 hour sessions starting at 3:15 p.m. on Tuesday and Thursday. During the first week, each of the Vietnamese will be called on to present, in a very informal manner, their reflections on their experience of study, observation and training in the U.S., in light of their future roles in Vietnam. In his remarks it is hoped that the discussant also will briefly detail and evaluate what he would hope to continue to do for the remainder of his time in this country. In thinking about his remarks constant emphasis should be given to the realities of the situation that he, as an administrator, will face in Vietnam. In the second week a general picture of the overall financial and economic situation in Vietnam will be presented. For these discussions we hope to have Mr. Tran Kim Phuong, First Secretary for Economic Affairs of the Vietnamese Embassy present a paper on the economic problems of Vietnam; Mr. David C. Cole, former staff member of the Michigan State Group in Saigon, will consider the governmental financial area.

The remainder and heart of the meetings will be devoted to a series of reports planned and drafted by each of the Vietnamese who will be working with one of the American members of the group. On Thursday, June 26th these working relationships and the reports themselves will be discussed and established on the basis of the remarks of each of the Vietnamese in the previous two sessions. Generally speaking the reports will involve an intensive consideration of some problem or problems that the Vietnamese member will have to deal with upon his return. The report, for example, could not only result in proposals for solution, but might further consider the various obstacles that would stand in the way of implementation. These reports should take about an hour to deliver and will be followed by free and open discussion. This, it is hoped, will give, for instance, the governmental accountant an opportunity to present his problems to the other administrators in the finance areas so that they can understand what problems their procedures and practices create for him, and, of course, vice versa.

The last week of the conference will be devoted to a general discussion of what has been covered. This should also provide an opportunity for the Vietnamese to again discuss their tour in the United States in order that the Project can obtain some understanding for planning for future Vietnamese having, at any one time, together on campus or in the United States as large a group of Vietnamese from as high a level within their government. The Project hopes that this group will be able to indicate what gaps there have been in their respective programs while in the United States and what they would suggest to remedy such omissions. Further, to help for future planning the Project wants to learn, and it can only do so from the Vietnamese participants themselves, what portions of their programs have been of least value. The Vietnamese should also give some thought to whom of their own staff in Vietnam would benefit, from their bureau's point of view, from a well-planned tour in the United States.

During the period of the conference the Vietnamese members will be able to undertake regular university courses if they so desire; however, we hope to provide an opportunity for intensive interning within the relevant State of Michigan offices. In addition, there will be brief field trips so that the entire group can visit each of the state offices involved in governmental finances.
